Qualified applicants could receive up to \$9,500 to replace their existing cars with newer, cleaner vehicles or other clean modes of transportation (such as transit passes, car-sharing, or an e-bike).



## Are You Eligible?

If you answer "Yes" to all of the questions below, you may be eligible for funding.

- Is your vehicle model year 2007 or older? Is your annual household income within the ranges listed?
- Do you own your vehicle?
- Do you reside within the South Coast Air Basin or Coachella Valley?
- Has your vehicle been operating California for the past two years?

<sup>2</sup> Zero-emission vehicles include battery electric vehicles (BEVs) and fuel cell vehicles.

<sup>3</sup> Plug-in hybrid and zero-emission vehicles are eligible for an additional incentive up to \$2,000 for the installation of electric vehicle charging equipment.

<sup>5</sup> ReplacementOptions You may only qualify for the higher incentive amount if your permanent residence is in a DAC zip code.

## Required Documents:

- Copy of California issued driver license
- Proof of residence
- Income documentation
- Copy of vehicle title (free of lien holders)
- Documentation showing vehicle operation in California over the past two years (must own the vehicle for at least a year prior to application date)
- Smog Check test result within 3 months of application submittal
