# TWO GOVERNING BOARD MEMBERS APPOINTED

## Supervisor Andrew Do

Orange County's District 1 Supervisor Andrew Do has been selected by the Board of Supervisors to represent the County of Orange on South Coast AQMD's Governing Board. He will fill the unexpired term of Supervisor Lisa Bartlett, who is vacating her term to run for Congress. The term expires on January 15, 2023. Supervisor Do was elected to the Orange County Board of Supervisors in 2015. Supervisor Do will also serve on South Coast AQMD's Marine Port, Refinery and Technology Committees.

## Councilmember Nithya Raman

Councilmember Nithya Raman has been appointed by Mayor Eric Garcetti as the City of Los Angeles' representative on South Coast AQMD's Governing Board. She will serve a 4-year term that will end January 15, 2026. She joined the Los Angeles City Council in 2019 as the representative for District 4 and is the first Asian-American woman and first South Asian ever to serve in this role. She is replacing Councilmember Joe Buscaino, who's term on the Governing Board has expired. Councilmember Raman will also serve on South Coast AQMD's Legislative, Marine Port and Mobile Source Committees.

During his 31 years at South Coast AQMD, he has been Planning & Rules Manager overseeing a number of rule projects, including regulation of refinery equipment, continuous emissions monitoring systems, flares, fence-line monitoring, combustion equipment, toxics, coatings, and adhesives, and upgrades to the Flare Event Notification System. Mike began his career as an Assistant Air Quality Engineer then progressively promoted to his current position. He will fill the vacancy created by Susan Nakamura's promotion.

## Kathryn Higgins

Kathryn Higgins has been selected as the Director of Community Air Programs; a new position assigned to the Executive Office. She began her South Coast AQMD career in 1987 as an Air Quality Inspector in the Enforcement and Compliance division and spent 24 years in PRDI where she was responsible for overseeing the AB 2766 Subvention Fund Program and Rule 2202 Programs. Kathryn worked most recently in the office of Legislative and Public Affairs as a Senior Public Affairs Manager, leading the Geographic Outreach Team and the AB 617 Team. In her new role, Kathryn will be responsible for directing the agency's AB 617 program development, implementation, and stakeholder collaboration.

# NEW INSPECTORS JOIN THE COMPLIANCE & ENFORCEMENT TEAM

This past November, 11 new inspectors joined South Coast AQMD's Office of Compliance & Enforcement after completing a newly designed training program. The 10-week course comprised of both virtual classes and field training operations and focused on enforcement of air quality rules and regulations.

All of the new inspectors have degrees in science or engineering, and some have prior experience in air quality compliance. These new inspectors have now joined their inspection teams and are ready to carry out the agency's mission to clean the air and to protect the health of the residents in the South Coast Air Basin.

# SOUTH COAST AQMD BEGINS RULE DEVELOPMENT TO REDUCE EMISSIONS FROM PORTS

South Coast AQMD is beginning a public process to develop an Indirect Source Rule (Proposed Rule 2304) to reduce air pollution from local commercial marine ports. The Ports of Los Angeles and Long Beach are the two busiest marine container ports in the nation and the largest emissions source in the South Coast region.

The South Coast AQMD Governing Board had directed staff to work with the Ports on a Memorandum of Understanding (MOU) until February 4, 2022, and then shift efforts to develop a rule if no agreement was reached. Although the Port of Long Beach's MOU proposal did include a number of clean air investments, the Ports' overall proposals did not provide sufficient measures to reduce emissions. The Ports' proposal also did not allow for enforceability should the agreed upon actions not be implemented.

Air pollution associated with goods movement affects public health throughout the region and disproportionately impacts neighboring communities. Many of the sources causing this pollution are primarily regulated by the federal government, and additional actions at the national level are



still urgently needed to provide healthy air for the South Coast region. To start the rulemaking process, South Coast AQMD will conduct working group meetings, community meetings and stakeholder outreach to seek input for potential rule concepts.

Rule development is expected to take 12 to 18 months before it is presented to the Governing Board for their consideration.

# UPDATE ON DIVERSITY, EQUITY AND INCLUSION EFFORTS



Over the past year, South Coast AQMD's Diversity, Equity and Inclusion (DEI) Office has been working hard to listen, learn and establish relationships both internally and externally. This year, South Coast AQMD's DEI office has addressed local, state and national social injustice events, providing programs and training to increase employee knowledge of DEI issues.

In 2021, the DEI office conducted seven all-agency events that included:

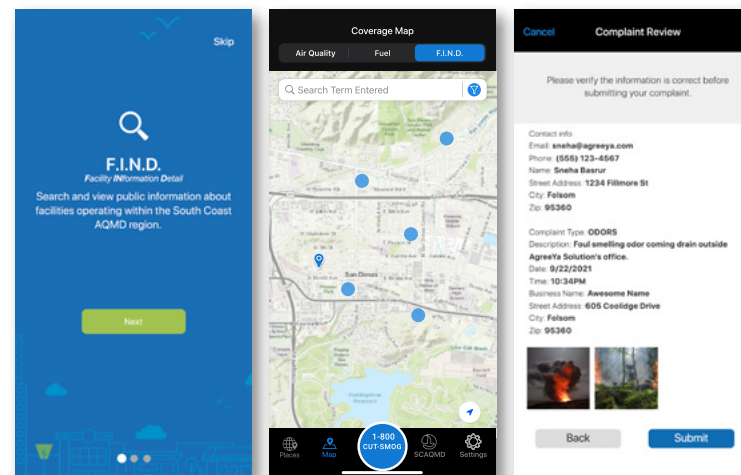
- Lunar New Year

# PUBLIC CAN NOW SUBMIT ONLINE COMPLAINTS, VIEW LOCAL FACILITY COMPLIANCE AND EMISSIONS INFORMATION VIA APP

South Coast AQMD is excited to announce two updates to its smartphone app that will allow users to conveniently access facility information, and submit online complaints directly from the free iOS or Android App.

With direct access through the App to the agency's FIND (Facility Information Detail) tool, users can search for public information on regulated facilities, including permit status, history of Notices of Violations, and annual emissions information.



There is also a more robust reporting feature, allowing users to submit online complaints directly from their phones, including the new option of submitting pictures. Once the air quality complaint is submitted and received, a complaint number will be issued. Users can then track the status of the complaint from their phone.

South Coast AQMD anticipates these updates will be released in April 2022. Download the current smartphone App to gain immediate access to our upcoming release and utilize these exciting, enhanced capabilities.

# 178 CLEAN SCHOOL BUSES TO BE PROVIDED ACROSS SOUTHERN CALIFORNIA



In December 2021 the South Coast AQMD Governing Board approved approximately \$47 million to 46 school districts located across South Coast AQMD's jurisdiction. These funds will be used to replace 178 high-emitting school buses with zero and near-zero emission school buses along with helping install supporting infrastructure.

Replacing older, high-polluting buses helps reduce smog forming emissions while also helping to reduce school children's exposure to toxic diesel exhaust. Since the School Bus program started in 2001 the South Coast AQMD has spent over \$325 million to replace over 1,800 school buses and retrofit 3,400 buses with filters to trap particulate matter pollution.

# \$140 MILLION APPROVED TO REPLACE DIRTY EQUIPMENT



On January 7, 2022, the South Coast AQMD Governing Board approved \$140.7 million in incentive projects that will replace older, higher polluting diesel vehicles and equipment with cleaner technologies that will reduce emissions such as Nitrogen Oxides (NOx) and Particulate Matter (PM).

Upgraded equipment will include heavy-duty trucks, off-road agricultural and construction equipment as well as locomotives and cargo handling equipment. Additionally, funds were awarded to support charging infrastructure projects.

These projects will provide estimated reductions benefits of 434 tons/year of NOx and 10.5 ton/year of PM. More than 80 percent of the awarded projects will benefit disadvantaged and low-income communities.

The projects will be funded under South Coast AQMD's Carl Moyer, Funding Agricultural Replacement Measures for Emission Reductions (FARMER), Surplus Off-Road Opt-in for NOx (SOON), State Reserve and Community Air Protection Programs.

# AB 617 PROGRAM & TRUCK INCENTIVES WORKSHOP UPDATES

After four years, the AB 617 Program continues to work to improve air quality and public health in environmental justice communities. The AB 617 Program is a community-based program where local stakeholders, known as Community Steering Committees, help develop and implement Community Emission Reduction Plans and Community Air Monitoring Plans. Currently, six communities have been designated as AB 617 Communities:

1. Eastern Coachella Valley;
2. East Los Angeles/Boyle Heights/West Commerce;
3. San Bernardino/Muscoy;
4. Wilmington/Carson West Long Beach;
5. South Los Angeles; and,
6. Southeast Los Angeles.

Except for South Los Angeles, all communities in the program are in the implementation phase of the program and meet quarterly. The South Los Angeles Community is currently developing their air monitoring and emissions reduction plans which are expected to be considered for adoption by the South Coast AQMD Governing Board in June 2022.

Additionally, South Coast AQMD hosted two of three Truck Incentives Workshops on December 1, 2021, and January 26, 2022. These virtual workshops are opportunities for community stakeholders to provide input and guide project plans for heavy-duty truck incentive funds within AB 617 communities. Small business owners and independent owners/operators of Class 4-8 trucks are encouraged to attend and provide feedback at the next workshop on March 30, 2022.

Spanish interpretation is available during each virtual AB 617 meeting and workshop, including teleconference capability for both English and Spanish lines. Meeting materials are available in both English and Spanish. Meetings are expected to continue in a virtual format for the time being. ## CHECK BEFORE YOU BURN SEASON CLOSES WITH 35 NO-BURN DAYS THIS WINTER

South Coast AQMD issued 35 No-Burn day alerts across the South Coast Air Basin during the tenth Check Before You Burn season. This is an increase from last year's 25 No-Burn days, and above the 5-year seasonal average of 21 days. Unfavorable meteorology in November and early December along with increased emissions from the ports may have contributed to the increase.

Every winter from November 1 to the last day in February, when levels of fine particulate matter (PM2.5) are forecast to be high, South Coast AQMD meteorologists issue a 24-hour ban on burning wood or manufactured fire logs for residential fireplaces and outdoor fire pits.

Smoke caused by burning wood in fireplaces can emit approximately five tons of harmful PM2.5 emissions per day in the South Coast Air Basin. That is equal to PM2.5 emissions from all passenger vehicles in the Basin. However, during the Check Before You Burn season when wood burning activities are more common, the PM2.5 emissions from this source can be twice as high compared to an average day in the year. Exposure to PM2.5 is associated with premature death, respiratory and cardiovascular disease, and other health issues. Reducing wood burning on No-Burn days is critical to protect public health and is an important tool to help the region meet federal health-based clean air standards for PM2.5.

## 10 THINGS YOU CAN DO TO CELEBRATE EARTH DAY ON APRIL 22



1. Combine a daily walk or bike ride with running a few errands and consider riding a bike or walking to work. It cuts down on extra car trips and adds exercise into your daily routine!



6. Save on your electricity bill by installing solar panels, request green power from your utility, or join a community choice aggregator.



2. When you must drive, drive smart! Don't overfill/top off at gas stations, make sure your tires are properly inflated, and keep your car's engine tuned up. When it's time to buy a new vehicle, consider an electric, hybrid-electric, or hydrogen fuel-cell vehicle. Find incentives at [www.driveclean.ca.gov](http://www.driveclean.ca.gov).



7. Cut down your household energy usage by setting your water heater temperature to 120° F (48°C), and using major appliances off-hours, such as before 4:30 p.m. and after 9:00 p.m.



3. If you have the option, consider teleworking. The average employee who teleworks rather than commuting saves 156 gallons of gas and 2,923 pounds of Carbon Dioxide per year!



8. Buy locally grown produce and products whenever possible. When ordering items to be delivered, consolidate packages to reduce shipping materials and fuel used for transport.



4. Get rid of your gas-burning lawnmower, leaf blower, trimmer, or other lawn care equipment for cleaner, quieter electric versions. Find incentives at [www.aqmd.gov/lawnandgarden](http://www.aqmd.gov/lawnandgarden)



9. Be mindful of household waste and help keep unnecessary excess out of landfills. Recycling and reusing materials improve air quality by reducing greenhouse gases produced by landfills, and sanitation vehicles.



5. Invest in energy saver and renewable energy appliances such as efficient space and water heaters, induction cooktops, washers, dryers, dishwashers, and refrigerators when it's time to upgrade.

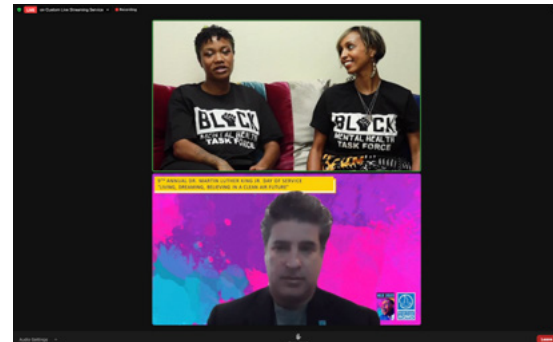

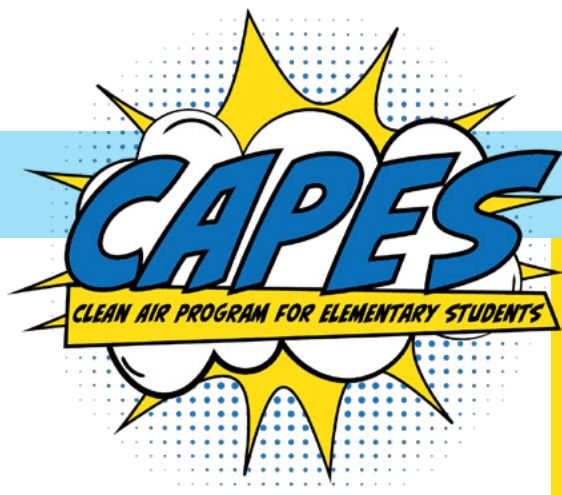

### 1147: NOx Reductions from Miscellaneous Sources

PAR 1147 will revise NOx emission limits to reflect BARCT for miscellaneous combustion sources and will apply to RECLAIM, former RECLAIM facilities, and non-RECLAIM facilities.

### Reg III: Fees

### 1480: Ambient Monitoring and Sampling of Metal Toxic Air Contaminants

Proposed amendments to Regulation III will incorporate the Consumer Price Index adjustment to reflect inflation pursuant to Rule 320.

Other amendments will include new or increased fees to recover costs incurred by South Coast AQMD for community air monitoring programs, certain permit processing and notification activities, large-scale incident responses. Additional but minor administrative changes will include, for example, moving existing fee provisions from Rule 1480 to Rule 301 and 306.

### 403.2: Fugitive Dust from Large Roadway Projects

### 218.2: Enhanced Requirements for Continuous Emission Monitoring System

### 218: 3: Enhanced Requirements for Continuous Emission Monitoring System Performance Specifications

PARs 218.2 and 218.3 are needed to modify provisions when monitoring mass emission limits using a Continuous Emissions Monitoring System for non-RECLAIM and former RECLAIM facilities.

### 429: Start-Up and Shutdown Exemption Provisions for Oxides of Nitrogen

### 1178: Further Reductions of VOC Emissions from Storage Tanks at Petroleum Facilities

PAR 1178 will incorporate the use of more advanced early leak detection methods and improve leak detection and repair programs for storage tanks to further reduce VOC emissions.

### 1426.1: Control of Hexavalent Chromium Emissions from Metal Finishing Operations

### 1159.1: Control of NOx Emissions from Nitric Acid Tanks

PR 1159.1 will establish requirements to reduce NOx emissions from nitric acid units that will apply to RECLAIM, former RECLAIM, and non-RECLAIM facilities.
