Agenda Item #1: Call to Order/Opening Remarks

Fabian Wesson called the meeting to order at 12:05 PM.

Agenda Item #2: Approval of Minutes

Nicole Starks-Murray moved to approve the September 19, 2018 Advisory Council meeting minutes. Ada Briceňo seconded. The minutes were approved.

Agenda Item #3: Review of Follow-Up/Action Items

There were no follow up or action items to be reviewed.

Agenda Item #4: EJCP Advisory Council Welcome & EJCP Updates

Alicia Rodriguez informed the council of the 2018 Environmental Justice Community Partnership (EJCP) accomplishments and summary of work completed. Ms. Rodriguez highlighted that South Coast AQMD partnered with City of Buena Park, the Office of Assembly Member Sabrina Cervantes and the San Bernardino Fleet Management and San Bernardino County Transit Authority to educate community members on the South Coast AQMD's environmental justice mission, electric vehicles, and program incentives. Staff presented information on how electric vehicles can help clean our air and incentive programs available to the community.

Ms. Rodriguez presented on the 2019 EJCP program goals. She stated the EJCP team planned to recruit new members to the Advisory Council, host quarterly meetings, implement the Student Clean Air Ranger Education (CARE) program in five elementary schools in the South Coast AQMD region, form the Inter-Agency Task Force and host quarterly meetings, host the fifth annual Environmental Justice Conference, and complete a community learning tour.

Ms. Rodriguez provided the Council with the Inter-Agency Task Force meeting dates and invited the members to attend. She also asked for community recommendations to join the Task Force and suggestions on topics, speakers, and locations for the Environmental Conference.

Ms. Rodriguez opened the discussion to questions on the EJCP program. Rebecca Zaragoza asked how schools can participate in the CARE program. Alisha James invited the Council to recommend elementary schools in San Bernardino and Orange Counties for the 2019 year, which have not yet been solidified. Nicole Starks-Murray offered to provide the recommendations for schools in the San Bernardino County.

Ms. Wesson expressed the importance of building relationships to expand the CARE program to multiple schools within South Coast AQMD's jurisdiction. Vallerie Gonzalez asked if the program was only available in public schools. Ms. Rodriguez stated that the team would be happy to introduce the program in all public and private schools, especially if there is recommendation by the Council. Alisha James stated that the goal of the program is to reach students in environmental justice communities. Ms. Gonzalez asked if the program is only for elementary level students. Ms. Wesson clarified that the CARE program was designed for elementary students; Ms. Wesson added that the district is launching a high school education program-

Nicole Starks-Murray expressed the importance of gathering data on the pilot program and informing the community of the tangible outcomes. She stated that most communities and schools in San Bernardino County would classify as disadvantaged communities, and the school district is always looking for innovative ways to heighten awareness and educate their communities on air quality and pollution.

Action Item: South Coast AQMD will present on data and impacts of the CARE program at the next Advisory Council meeting.

Ms. Wesson thanked Ms. Rodriguez for presenting and introduced Ada Briceno to present on Unite Here Local 11's environmental justice work.

Agenda Item #5: Presentation regarding Environmental Justice

Ada Briceno introduced herself to the Council and provided of Unite Here Local 11. Ms. Briceno explained that Unite Here Local 11, whose membership is 70% immigrant, represents over 32,000 workers employed in hotels, restaurants, airports, sports arenas, and convention centers throughout Southern California and Arizona.

Ms. Briceno shared that unfortunately the environmental needs in the most impacted areas in California are not being met. Low-waged immigrants and African-Americans in Southern California's hospitality industry are among those most impacted by air pollution. She added that many of the Unite Here members live, work, and go to school in these areas because they cannot afford to live in communities with better air quality.

Ms. Briceno showed the Council examples of vertical forests in Milan and explained that this technology should be accessible to communities with high concentration of pollution and hotel development. She expressed that hotels should have a plan for transit workers and customers by integrating affordable housing options, being sensitive to nearby communities, using water saving machinery, and providing waivers for zoning changes and height limits to affordable housing projects rather than luxury hotels. Unite Here Local 11 empowers their members to insert their voices in the planning stages to assist in making these developments better for the residents and the environment, and ultimately, shape a model that puts the community first.

Ms. Wesson thanked Ms. Briceno and asked what concerned citizens can do to assist Unite Here with their efforts. Ms. Briceno offered to provide the council with information and letters to educate them on ways to support Unite Here politically and civically.

Ms. Wesson thanked Ms. Briceno for her presentation and introduced member updates.

Agenda Item #6: Member Updates

Ms. Rebecca Zaragoza is currently working with communities in the Coachella Valley to submit nominations to be selected as an AB 617 year-two community. She added that she has been engaged in SB 1000 in Riverside County and is working with partners in the Inland Empire to submit comments to ensure jurisdiction and policies meet the community's needs.

Ms. Lisa Hart is working with the Stand LA Effort to end drilling in neighborhoods and establish clean and renewable energy with the Los Angeles Department of Water and Power by 2030. She added that she is also working to get a Climate Emergency Mobilization Department launched in the City of Los Angeles.

Ms. Vallerie Gonzalez is working with the Clean Vehicle Rebate Project to educate communities about clean vehicle incentives. She informed the council that her organization, the Center for Sustainable Energy, partners with various organizations to offer clean vehicle test drives and funding to community-based organizations to provide information about electric vehicle incentive programs available in the area.

Mr. Jan Victor Andasan is also working with the Clean Vehicle Rebate Program in Long Beach communities. Mr. Andasan advocated that all residents should be aware of safety procedures and nearby shelters for environmental disasters. He also emphasized the importance of educating the community

through Toxic Tours. Mr. Andasan asked South Coast AQMD for more information on their incinerator policies and invited the council to attend the East Yard Communities for Environmental Justice fundraiser.

Action Item: South Coast AQMD to follow up with Jan Victor Andasan about partnering with East Yard Communities for Environmental Justice for a Community Toxic Tour for next year. South Coast AQMD will request Compliance & Enforcement staff to present on policies and rules for incinerators.

Ms. Jessica Tovar is working to coordinate the next National Moving Forward Network meeting in New York and New Jersey from May 8 to May 10. She is also working with the Impact Project to monitor the action plans, to ensure goals are met to achieve zero-emissions, and to voice the concerns of the communities impacted by AB 617. She also found a report by the Urban and Environmental Policy Institute on the Disneyland Resort employees and their unlivable wages that she will share with the council.

Action Item: South Coast AQMD to follow up with Jessica Tovar about the concerns of the communities impacted by AB 617.

Ms. Paula Andrea Torrado Plazas is currently working on South Central LA PUSH with community organizations partners to understand and identify sources of air pollution in South Central Los Angeles. She added that the goal of the effort is to nominate those communities to be selected as AB 617 year-two communities. She added that Physicians for Social Responsibility-LA is working to end drilling in local neighborhoods as seen at the Inglewood Oil Fields.

Action Item: South Coast AQMD to follow up with Paula Andrea Torrado Plazas regarding community concerns on the Inglewood Oil Fields.

Ms. Rachel Pennington is working with the Southern California Regional Network to bring together a wide variety resources to homes, businesses, and public facilities and agencies to create better energy savings practices throughout Southern California. She invited the Council to recommend any agency that would benefit from being enrolled in the program.



What is the problem?



Each day, on average, **8 people** die, **5 children** are taken for an asthma-related ER visit, and **3,000 children** miss school, **1,090 people** miss work, and **8 people** have nonfatal heart attacks because of government failure to meet federal clean air standards for ozone (smog) and particulate matter.



What is up with the air in South Central LA?



Did You Know That...

- In South Central LA, there are 1,318 hazardous sites (like auto-body shops) within 500 feet of 585 sensitive populations (like schools).
- In 2010, the South Central -LA area had one of the highest asthma emergency visits and hospitalization rates in the county.
