# Agenda Item #4: Update on Draft Socioeconomic Report for the Revised Draft 2022 Air Quality Management Plan

Elaine Shen, Planning and Rules Manager of Planning, Rules Development, and Implementation, presented on the Draft Socioeconomic Report for the Revised Draft 2022 Air Quality Management Plan.

Ms. Hernandez asked for clarification on the mortality rates of environmental justice communities versus non environmental justice communities.

Mr. Yanez made comments regarding modeling data used in the Revised Draft 2022 AQMP.

Mr. Gongora expressed concern regarding the accuracy of air quality monitoring as visible pollution levels do not seem to be improving.

Dr. Andrea Polidori, Assistant Deputy Executive Officer of Monitoring and Analysis presented an update on the different types of air monitoring used by South Coast AQMD.

Angela Garcia asked about what actions would be taken when air monitoring revealed leaking oil or gas wells and requested clarification on the technology used to gather real-time data.

Mr. Yanez suggested compliance inspectors be equipped with infrared cameras to detect hazardous leaks during investigations.

Ms. Hernandez asked what sort of community alert system was in place to let residents know about hazardous air quality conditions when they happen, as well as to what extent decommissioned wells were also analyzed during monitoring efforts.

Mr. Yanez asked whether South Coast AQMD alerted local emergency services when a hazardous air quality threat is identified. Ms. Garcia suggested ensuring a network of contacts is in place to respond to active hazardous conditions.

Manuel Arredondo asked whether particle pollutants were also monitored, especially during times of storms, high wind conditions, and elevated dust conditions.

- Contribute to meaningful progress toward the achievement of environmental justice


EJAG members met quarterly in 2022 to receive updates and discuss environmental justice and air quality issues, with one Special Meeting scheduled in February.

#### **Key Items Addressed in 2022**

- Nomination of Environmental Justice Advisory Group member to South Coast AQMD
  Advisory Council: Pursuant to the charter and recommendations of the Blue Ribbon
  Panel, each advisory group shall appoint one of its members to serve on the District's
  Advisory Council. The Environmental Justice Advisory Group selected Ana Gonzales for
  the 2022 Advisory Council Roster.
- **Proposed Rule 2306: Indirect Source Rule for New:** Staff provided a presentation on the development of Rule 2306.
- Odor Issues at Rendering Facilities: Mayor Elizabeth Alcantar, City of Cudahy, provided an update on odor issues at rendering facilities. Members voted to submit and sign a letter from EJAG to the Governing Board regarding this matter.
- Rule 2305: Warehouse Indirect Source Rule Warehouse Actions and Investments to Reduce Emissions (WAIRE) Program and Outreach: Staff provided an update on Rule 2305.

- Facility Information Detail (F.I.N.D.) Update: Staff provided updates on the F.I.N.D. feature on the South Coast AQMD website including use of facility maps and sorting search results.

#### AB 2836 (E. Garcia) - Sponsor Bill - Signed into law

Reauthorizes Carl Moyer and AB 923 programs, to provide incentive funding for cleaner vehicles and equipment to air districts throughout the state, until January 1, 2034.



### AB 1749 (C. Garcia) - Key Support Bill - Signed into


Allows extension of time, from 1 to 2 years, to develop a CERP for AB 617 Community, with CARB and CSC approval.




#### AB 2141 (E. Garcia) - Sponsor Bill - Died

Secure ongoing funding for AB 617 incentives and implementation from the Greenhouse Gas Reduction Fund in the amount of 20% of annual proceeds, but not to exceed \$600 million.
