Background

This report summarizes the activities of Legislative and Public Affairs for January 2011. The report includes four major areas: Environmental Justice Update; Community Events/Public Meetings (including the Speakers Bureau/Visitor Services, Communications Center, and Public Information Center); Business Assistance; and Outreach to Business and Federal, State, and Local Governments.

ENVIRONMENTAL JUSTICE UPDATE

The following are key environmental justice-related activities in which staff participated during January 2011. These events involve communities which suffer disproportionately from adverse air quality impacts.

On January 20, staff attended a meeting at Saul Martinez Elementary School to discuss odor issues attributed to three recycling facilities on Cabazon Tribal land. The recycling facilities are working with petroleum fluids, green waste and mixed refuse processing and incinerating. The community affected is outside of Cabazon tribal lands including two public schools, residential and public housing and a community center. AQMD staff provided technical information, as well as information on how to file air quality complaints in English and Spanish.

COMMUNITY EVENTS/PUBLIC MEETINGS

Each year, thousands of residents engage in valuable information exchanges through events and meetings that AQMD sponsors alone, or in partnership with others. Attendees typically receive the following information: tips on reducing their exposure to smog and its health effects; invitations or notices of conferences, seminars, workshops and other public events, ways to participate in AQMD rule and policy development; and assistance in resolving air quality-related problems. Speakers Bureau/Visitor Services

AQMD receives requests for staff to speak on a variety of air quality-related issues. The requests come from organizations such as trade associations, chambers of commerce, community-based groups, schools, hospitals and health-based organizations. AQMD also hosts visitors from around the world who meet with staff on a wide range of air quality issues.

- On January 5, staff provided an overview of the AQMD and air quality issues affecting the region, to a delegation of 19 Chinese government officials, and a tour of the facility and the laboratory.
- On January 10, staff gave a presentation on Proposed Amended Rule 1150.1, Gaseous Emissions from Municipal Solid Waste Landfills, to the Coachella Valley Association of Governments.
- On January 14, staff provided a briefing and a tour of AQMD's facility and laboratory for 10 students from Fullerton Middle School
- On January 14, staff gave a presentation on the AQMD and air pollution to 22 students at Chadwick School, in the Palos Verdes Peninsula.

• On January 19, staff gave a presentation on Rule 1147, NOx Reductions from Miscellaneous Sources and Permits, to the California Auto Body Association's San Fernando Chapter in Simi Valley.
