Chair Dr. Clark E. Parker, Sr. and Supervisor Marion Ashley attended via videoconference. Vice Chair Dr. Joseph Lyou, Supervisor Sheila Kuehl, and Council Member Judith Mitchell were in attendance at SCAQMD headquarters in Diamond Bar. Mayor Pro Tem Larry McCallon was absent.

Call to Order

Chair Parker called the meeting to order at 9:03 a.m.

INFORMATIONAL ITEM:

1. Vehicle Scrapping Programs Overview

Dr. Philip Fine, Deputy Executive Officer/Planning, Rule Development & Area Sources, substituted for Dean Saito, Planning & Rules Manager, in the latter's absence, and presented on this item, regarding the three vehicle scrapping programs available to residents within SCAQMD's jurisdiction.

Dr. Parker recommended advertising the Replace Your Ride program in local newspapers in low income areas or other venues. Dr. Lyou stated that he would be concerned if broad advertising were conducted because SCAQMD could receive a high volume of applications resulting in participants having unsatisfactory experiences. He recommended consolidation into one program, if feasible, because

existing options may be overwhelming to the public. Council Member Mitchell commented that these program have been very successful. She added that the programs may appear confusing when viewed at the same time, but the individual programs are not confusing as presented to the public.

Dr. Parker indicated that discarding an older vehicle through scrapping is significantly better than trading in the vehicle, from an emissions standpoint. He recommended increased funding for vehicle scrapping. Council Member Mitchell informed the committee that the CARB Board, at its June meeting, will consider the appropriation of an additional \$60 million for the Enhanced Fleet Modernization Program and Plus-Up Car Scrap and Replace programs that would be available to multiple air pollution control districts.

Dr. Parker recommended that committee agendas continue to include information on these and other programs to keep committee members and participants informed.
