**Background**

At its September 2015 meeting, the Board approved a revised Procurement Policy and Procedure. Under the revised policy, RFPs for budgeted items over \$75,000, which follow the Procurement Policy and Procedure, no longer require individual Board approval. However, a monthly report of all RFPs/RFQQs over \$75,000 is included as part of the Board agenda package and the Board may, if desired, take individual action on any item. The report provides the title and synopsis of the RFP/RFQQ, the budgeted funds available, and the name of the Deputy Executive Officer/Asst. Deputy Executive Officer responsible for that item. Further detail including closing dates, contact information, and detailed proposal criteria will be available online at <http://www.aqmd.gov/grants-bids> following Board approval on November 3, 2017.

**Outreach**

In accordance with SCAQMD's Procurement Policy and Procedure, a public notice advertising the RFPs/RFQQs and inviting bids will be published in the Los Angeles Times, the Orange County Register, the San Bernardino Sun, and Riverside County's Press Enterprise newspapers to leverage the most cost-effective method of outreach to the South Coast Basin.

Additionally, potential bidders may be notified utilizing SCAQMD's own electronic listing of certified minority vendors. Notice of the RFPs/RFQQs will be emailed to the

Black and Latino Legislative Caucuses and various minority chambers of commerce and business associations, and placed on the Internet at SCAQMD's website (<http://www.aqmd.gov>) where it can be viewed by making the selection "Grants & Bids."

**Proposal Evaluation**

Proposals received will be evaluated by applicable diverse panels of technically-qualified individuals familiar with the subject matter of the project or equipment and may include outside public sector, academic or community expertise.

RFQQ #QQ-2018-09 Issue Request for Qualifications and Quotations to Prequalify Vendors to Provide Computer, Network, and Printer Hardware, Software and Installation

On February 5, 2016, the Board approved a vendor list for the purchase of computer, network, and printer hardware, software, and installation for a period of two years. The current vendor list expires on February 5, 2018. SCAQMD's operational efficiency and effectiveness are dependent on maintaining performance of its information technology equipment. Staff desktop computer systems, and many software applications (both off-the-shelf and in-house-developed applications) are exceeding capacity of the present systems. New desktop computer systems, with adequate capacity to support current software applications, are needed to replace older systems. These replacements are in accord with SCAQMD's Information Management Strategic Plan. This action is to issue a Request for Qualifications and Quotations to competitively develop a new list of vendors for computer, network, and printer, hardware, software and installation for a two-year term. Funds for these purchases (\$155,000) made under this prequalified vendor list are included in the FY 2017-18 Budget.
