BACKGROUND

This report summarizes the activities of the Legislative, Public Affairs and Media Office for September. The report includes: Major Events; Community Events/Public Meetings; Environmental Justice Update; AB 617; Speakers Bureau/Visitor Services; Communications Center; Public Information Center; Business Assistance; Media Relations; and Outreach to Community Groups and Governments.

MAJOR EVENTS (HOSTED AND SPONSORED)

Each year, staff engage in holding and sponsoring several major events throughout South Coast AQMD's four-county jurisdiction to promote, educate, and provide important information to the public regarding reducing air pollution, protecting public health, and improving air quality and the economy.

No major events were hosted or sponsored in September.

COMMUNITY EVENTS/PUBLIC MEETINGS

Each year, staff engage with thousands of residents and stakeholders, providing valuable information about the agency, incentive programs, and ways individuals can help reduce air pollution through events and meetings sponsored solely by South Coast AQMD or in partnership with others. Attendees typically receive the following information:

- Tips on reducing their exposure to smog and its health effects;
- Clean air technologies and their deployment;
- Invitations or notices of conferences, seminars, workshops, and other public events;
- South Coast AQMD incentive programs;
- Ways to participate in South Coast AQMD's rules and policy development; and
- Assistance in resolving air pollution-related problems.

Staff attended and/or provided information and updates at the following September events and meetings:

San Fernando Valley Council of Governments (SFVCOG)

On September 2, staff participated in a virtual SFVCOG Transportation Committee meeting to provide updates on the VW Mitigation Trust funds available for transit and shuttle buses, National Drive Electric Week, and other clean air programs.

Southern California Leadership Network (SCLN)

South Coast AQMD was the featured virtual speaker at the Los Angeles Chamber of Commerce SCLN meeting on September 17. Staff shared South Coast AQMD's background, ongoing efforts to improve air quality, and an overview on Rule 2305 - Warehouse Indirect Source Rule – Warehouse Actions and Investments to Reduce Emissions (WAIRE) Program.

Rialto Pollution Prevention Fair

Staff attended the Rialto Pollution Prevention Fair, which featured community groups, environmental organizations, water, safety, health, and other civic agencies. A hydrogen fuel cell vehicle was displayed, and materials were distributed on South Coast AQMD and air quality-related programs.

Harbor Association of Industry and Commerce (HAIC)

On September 23, staff attended a virtual HAIC Government Affairs Committee meeting to provide information on South Coast AQMD programs and Clean Air Awards nominations.

City of Lakewood Public Safety and Emergency Preparedness Expo

On September 25, South Coast AQMD staffed an in person informational booth at the City of Lakewood's Public Safety and Emergency Preparedness Expo. Approximately 200 people visited the booth to learn about South Coast AQMD, how to file an air quality complaint and other programs.

Watts Clean Air & Energy Committee's National Drive Electric Week

Staff participated in the 6th Annual Watts Clean Air & Energy Committee's National Drive Electric Week event on September 26. Information was shared with community members on the AB 617 program, air quality, how to file an air quality complaint, phone apps, and the health effects of air pollution.

THRIVE 90805 Community Conference

On September 28, staff participated in panel discussion at the Thrive 90805 Resiliency and Environmental Stewardship Community Conference, moderated by Board Member Vice Mayor Rex Richardson. Other panelists included representatives from the Rivers and Mountains Conservancy, the Long Beach Conservation Corps and the Project Lead for the Long Beach Climate Action & Adaptation Plan. Discussions focused on what the agencies are doing to protect the environment and improve public health. Staff provided information on the WAIRE program and the on-going efforts with the Ports.

ENVIRONMENTAL JUSTICE UPDATE

The following are key environmental justice related (EJ) activities in which staff participated during September. These events and meetings involve communities affected disproportionately from adverse air quality impacts.

Environmental Justice Community Partnership (EJCP) Advisory Council

Vice-Chair Delgado chaired a virtual quarterly meeting of the EJCP Advisory Council on September 1, with Board Member Veronica Padilla-Campos in attendance. Staff reviewed the 2022 Goals and Objectives and provided an update on the Clean Air Program for Elementary Students (CAPES), Inter-Agency Task Force, and the EJ Conference. An EJCP member presented on the Morongo Indian Reservations' Environmental Protection Department, Tribal Air Program, and air quality issues. Members shared information on environmental issues in their communities.

Pacoima Community Initiative

On September 10, staff participated in a virtual Pacoima Community Initiative monthly meeting and provided an update on CAPES. Members discussed upcoming events and shared information on projects and issues.

7th Annual Environmental Justice Enforcement Symposium

Staff participated in the 7th Annual Environmental Justice Enforcement Symposium's virtual session on Pesticide Awareness and Safety on September 15. The panel discussed who to call for questions about pesticide regulations and enforcement.

Coachella Valley EJ Enforcement Task Force

Staff participated in a virtual Coachella Valley EJ Enforcement Task Force meeting on September 22. Staff announced the upcoming AB 617 Eastern Coachella Valley (ECV) meeting and the registration link for the 7th Annual EJ Conference.

AB 617 UPDATE

The following are key AB 617 related activities in which staff participated during September. These events, workshops and meetings involve AB 617 communities to support the Community Steering Committees (CSCs), Community Air Monitoring Plans (CAMPs) and Community Emissions Reduction Plans (CERPs).

South Los Angeles (South LA) CSC

On September 2, approximately 55 people participated in a virtual South LA CSC meeting. A CSC co-lead summarized the August meeting for the Committee. Staff presented information on upcoming truck incentive workshops for AB 617 communities and an overview of the CERP and CAMP development process. CSC members asked about incentives outreach and funding. CSC members asked about information on BACT and BARCT technology, resources available for CAMP implementation, monitoring data collected with low-cost sensors, and how monitoring can inform air quality complaints received by staff. Public comments highlighted the impact of various pollutants and low-cost sensors in other communities, the importance of raising local issues in this process, and requested a grant writing session for the public.

CARB Public Meeting

On September 9, staff attended a virtual CARB public meeting during which their Board unanimously approved the CERP for the ECV community.

South LA Subcommittee on Mobile Sources

On September 14, approximately 30 people participated in the South LA Mobile Sources Subcommittee virtual meeting. CARB presented on its authority and enforcement of regulations for mobile sources. Staff and CARB addressed questions about enforcing rules that apply to truck idling, locomotives, and off-road equipment (e.g., construction equipment). Staff presented examples of mobile source actions in AB 617 CERPs, explained monitoring strategies for mobile sources, and provided an overview of the development timeline for the CERP and CAMP.

Southeast Los Angeles (SELA) CSC

Approximately 40 people participated in the SELA CSC virtual meeting on September 16. A committee member presented on the benefits of renewable natural gas for heavyduty trucks. Staff provided an overview of CERP and CAMP progress on the air quality priority for truck traffic, the AB 617 Annual Report, and the implementation budget. CARB presented updates on truck enforcement efforts and asked for feedback on locations for truck "no idling" signs. Committee members asked about outreach for truck incentives, air monitoring education programs for schools and expressed their continued interest in zero-emission truck projects.

Eastern Coachella Valley (ECV) Community Monitoring Working Team

On September 30, staff participated in a virtual meeting with two co-leads of the ECV Monitoring Working Team and provided an update on current and upcoming air monitoring activities.

Boyle Heights Neighborhood Council

On September 21, staff attended a virtual meeting organized by the Boyle Heights Neighborhood Council and provided information on air monitoring conducted as part of the East Los Angeles, Boyle Heights, West Commerce CAMP. Staff also provided information on outreach, compliance, and enforcement efforts.

ECV CSC

Approximately 40 people participated in the ECV CSC meeting on September 23. Staff provided opening remarks to acknowledge the ECV CERP approval from CARB and provided an overview of comments received on the Annual Progress Report. A committee member provided an update on the Annual Progress Report timeline. Staff provided an overview of the AB 617 implementation budget, Rules 403 and 403.1 (fugitive dust), and suggestions for developing road paving project plans. Committee members provided input on criteria for home air filtration and purification system project plans. Staff presented an update on monitoring technologies and future deployment location plans. Committee members asked about future meeting frequency, CERP action updates, the implementation budget, enforcement procedures for Rules 403 and 403.1, and available data and criteria to prioritize air filtration project locations.

South LA Subcommittee on Oil & Gas

The South LA CSC held a virtual Oil & Gas Subcommittee meeting on September 30. An Esperanza Community Housing representative presented on his experience and role in closing AllenCo, and recommended actions for the South LA CERP. A longtime resident of South LA and representative of Redeemer Community Partnership shared his experience living near oil drilling sites. A City of Los Angeles Office of Petroleum and Natural Gas representative presented on the history of oil drilling facilities in the community.

SPEAKERS BUREAU/VISITOR SERVICES

South Coast AQMD regularly receives requests for staff to speak on air quality-related issues from a wide variety of organizations, such as trade associations, chambers of commerce, community-based groups, schools, hospitals, and health-based organizations. South Coast AQMD also hosts visitors from around the world who meet with staff on a wide range of air quality issues. The following requests were received in September.

Pomona College

Staff presented to Pomona College students an overview of South Coast AQMD, air quality issues, and clean air vehicles. A hydrogen fuel cell vehicle was displayed. Staff also participated in a question-and-answer session.

COMMUNICATION CENTER STATISTICS

The Communication Center handles calls on South Coast AQMD's main line, 1-800-CUT-SMOG®, the Spanish line, and after-hours calls to those lines. Total calls received in the month of September:

Major Media Topics:

- Special Air Quality Advisory: Pitches were sent on September 23 and 26 to local news outlets for two special air quality advisories due to the Central California fires, resulting in coverage from television, radio and print outlets. Staff participated in interviews with CBS, Los Angeles Times, ABC7 and KCRW. Written responses were provided to Crescenta Valley Weekly and USC Annenberg Media. KESQ requested an interview regarding smoke conditions specifically impacting the Coachella Valley.
- Volvo Construction Event: Two rounds of pitches were sent to local and national news outlets with the media advisory, for the Volvo construction equipment event on September 21.
- **Public Consultation Meeting:** Inside EPA requested information regarding the September 7 public consultation meeting discussing the redesignation request and maintenance plan for 24-hour PM2.5 standardsand what it means for attainment. A written response was provided.
- Wildfire Preparedness: Inside Edition requested an in-person interview to demonstrate household items to use during wildfires. Unable to accommodate the request.
- AB 617: CalMatters interviewed staff on AB 617 BARCT requirements and

implementation deadlines. Reporter submitted follow-up inquiries and written responses and resources were provided.
