**CALL TO ORDER**: Chair Benoit called the meeting to order at 9:05 a.m.

Supervisor Perez was absent for roll call and joined the meeting at 9:12 a.m.

Opening Comments

Wayne Nastri, Executive Officer, announced that on November 3, 2022 South Coast AQMD was awarded two grants from U.S. EPA for enhanced community monitoring; and that Aaron Katzenstein, Deputy Executive Officer/Technology Advancement Office, was appointed to the U.S. EPA Mobile Sources Technical Review Subcommittee. Mr. Nastri noted that staff recommended pulling Item No. 26, the public hearing for Proposed Amended Rule 1148.2, from the agenda.

Outgoing Presentation to Board Member Sheila Kuehl

Chair Benoit presented Supervisor Kuehl with an award to recognize her service on the Board, representing the County of Los Angeles. Board Members thanked Supervisor Kuehl for her legacy of public service, leadership, and thoughtful perspective on the issues.

Supervisor Kuehl reflected on her career and expressed appreciation for her fellow colleagues and others with whom she has served. She spoke of the important role that the Board plays in improving air quality for the region, and the multi-representative composition of the Board that brings an expanded perspective. She thanked staff for their work and devotion.

During public comments, several commenters expressed appreciation to Supervisor Kuehl for her public service and contributions to environmental issues.

These commenters provided testimony on the Draft 2022 AQMP regarding the following issues:

 Acknowledged the need for zero-emission technologies, but noted the Draft 2022 AQMP should include options when zero-emission

- technologies are not practical, available, or affordable;
- Concerned that the full cost of zero-emission technologies has not been fully estimated and will result in significant job loss annually
- Strongly recommended that the Draft 2022 AQMP include a technology and fuel neutral policy
- Emphasized the need to evaluate whether the electrical grid will have the infrastructure and grid capacity needed to support widespread electrification
- The socioeconomic report should include costs of electrical grid infrastructure, as well as societal cost such as stranded assets, job losses and consumer crisis.
- Implementation costs of the Draft 2022 AQMP, including the burden the cost will put on businesses and residents.

These commenters provided testimony on the Draft 2022 AQMP regarding the following issues:

- The significant number of days with unhealthy ozone levels
- Concern about a cost-effectiveness threshold that is too low
- Concern about efforts to delay adoption of the 2022 AQMP for additional analysis;
- The importance for a majority zero-emission plan that focuses on mobile and stationary sources;
- Need for strong control measures;
- Rulemaking for indirect source rules must be achieved in a timely manner;
- CARB and U.S. EPA need to do their fair share;
- Need to start implementing control measures in the 2022 AQMP and initiate rulemaking;
- Allocate funding and incentive programs for stationary sources;
- For stationary sources, the Draft 2022 AQMP relies on combustion technologies, and needs to have more zero-emission technology;
- The need for freight facility measures; and
- Ensure Spanish interpretation is provided at Board meetings

Dawny'All Heydari, Pacific Environment – Clean Ports Southern California, commented on the need to set strong emission targets for commercial marine ports to support zero-emissions for all vessel categories, set zero-emission standards for commercial harbor craft and accelerate at-berth emissions for tanker vessels. Ranji George, a member of the public, expressed support for solar renewable energy to reduce reliance on fossil fuels and requested that the Draft 2022 AQMP include a component for solar. For additional details, please refer to the Webcast beginning at 58:06.

Bill LaMarr, California Small Business Alliance, expressed concerns that there is no viable pathway to achieve the needed reductions without widespread adoption of zero-emission technologies across all mobile and stationary sources, without federal action and without radical improvements to the electrical grid and related infrastructure. He also expressed concerns about the cost of the Plan to businesses and individual taxpayers, and the possibility of federal sanctions being imposed on businesses for failure to attain the standards. She emphasized the need for staff to provide more detail in the 2022 AQMP on the costs for the grid expansion needed to support zero-emissions electrification. # Item Pulled for Discussion (Agenda Item No. 19)

Mayor Cacciotti commented on the 2023 South Coast AQMD-sponsored state legislative proposal presented at the October Legislative Committee meeting to increase the AB 2766 DMV fees. He noted that there were only three committee members present

at that meeting and only two voted in support of the proposed concept. Since three concurring votes are required for action to be taken, Mayor Cacciotti pulled this item to inquire about presenting it to the full board. For additional details, please refer to the Webcast beginning at 1:24:12.

Derrick Alatorre, Deputy Executive Officer/Legislative, Public Affairs and Media, provided an overview of the proposed legislative concept to increase AB 2766 DMV Fees. He explained that staff is seeking approval to discuss the concept of increasing the AB 2766 DMV fee with legislators.

Mr. Nastri emphasized that this item was brought before the Legislative Committee only as a potential concept to seek approval from the Committee for staff to see if there is interest among legislators to support and/or sponsor a bill. He clarified that specific language for a bill would be brought back to the Legislative Committee for consideration and action.

Chair Benoit commented that discussions have been taking place at the state level regarding changes to the DMV registration fee structure, therefore, this may be the appropriate time to explore this concept. For additional details, please refer to the Webcast beginning at 1:29:45.

#### Agenda Item No. 5

Board Member Kracov expressed support for the goods movement port cargo fee. He commented that the pollution at the Ports is far from resolved and commented on the importance of progress on the Indirect Source Rule for Ports and CARB's drayage rule. He suggested that the current container fee is not sufficient and legislation for a container fee is a good idea. He also highlighted the importance as policymakers and as an agency to focus efforts on the needed infrastructure. Board Member Kracov provided several examples when the Ports want to take quick action they make it possible as shown with container fees for dwell times, moving ships 40 miles off port during periods of long dwell times, and meeting CARB's regulation for cargo handling equipment and cranes. Dr. Sarah Rees, Deputy Executive Officer/Planning, Rule Development and Implementation, gave the staff presentation on this item.

Supervisor Perez inquired about whether the public provided input to the proposal. Dr. Rees responded that a public consultation meeting was held at the end of September and it was mentioned at the last AB 617 Eastern Coachella Valley Community Steering Committee meeting. These commenters provided testimony on the reclassification of the Coachella Valley regarding the following issues:

- Importance that future commitments are met and the motor vehicle emission budgets (MVEB) are not revised.
- Recognized consequence of failure to reach attainment.
- Pointed out the drawbacks to combustion-based strategies that are not as effective.
- Concerned that reclassification will push the attainment deadline.

Sarah Jepson, SCAG/Planning Director, explained what caused the Coachella Valley MVEB shortfalls and the resulting transportation conformity lockdown that can impact the implementation of transportation projects worth millions of dollars. The voluntary reclassification of the Coachella Valley was identified by SCAG, South Coast AQMD, CARB, and U.S. EPA as the solution needed to expeditiously resolve the conformity lockdown. She urged the Board to consider and approve the staff recommendation. For additional details, please refer to the Webcast beginning at 1:48:52.

Dr. Rees stated that staff takes attainment very seriously and commented on the importance and significance of transportation projects. Dr. Rees explained that the issue with the MVEB is a change in the model and that there was no change in vehicle activity. Dr. Rees also explained that attainment in the Coachella Valley largely depends on the work we do in South Coast, because emissions in Coachella Valley generally flow in from the Basin and that there is relatively few emission sources in the Coachella region. Supervisor Perez thanked staff for their work and recognized the difficulty of the situation because of the need to achieve attainment but also the need for transportation projects. He requested working with the AB 617 Eastern Coachella Valley CSC going forward for guidance and to educate them on this issue. 27. Certify Final Subsequent Environmental Assessment for Proposed Amended Rule 1168 – Adhesive and Sealant Applications; and Amend Rule 1168

Heather Farr, Planning & Rules Manager/Planning, Rule Development and Implementation, gave the staff presentation on this item.

Agenda Item No. 27 was opened for public comment; and the following individuals addressed the Board.

Doug Raymond, Raymond Regulatory Resources (3R), LLC on behalf of The Chemours Company, requested that the Board consider their request to change the wording from a prescribed reference exposure level to a hazard banding for Opteon 1100 in Subparagraphs (c)(33)(B) and (c)(33)(C) of the rule language. He noted that Opteon 1100 is a blowing agent that can only be used in two-component foam products and is not for consumer use. In response to Mayor Cacciotti's request to provide more detail about twocomponent foam products, Mr. Raymond responded that the foam is used in manufacturing settings, where workers wear protective equipment and follow guidelines to reduce potential risks, and there is no off-gassing. Susan Nakamura, Chief Operating Officer questioned if the application of the foam sealant met the applicability of Rule 1168. Ms. Farr confirmed that the foam sealant is applicable to Rule 1168. For additional details, please refer to the Webcast beginning at 2:12:52.

Dr. Rees explained that there is not enough information to assess hazard banding and that the additional information is needed to develop a specific proposal. Dr. Rees explained that it is best to wait for OEHHA's assessment and if the assessment shows that the toxicity is close to the toxicity of the current materials used, then staff is willing to consider amending Rule 1168. Dr. Rees also explained that after OEHHA completes their analysis, staff is committed to returning to the Stationary Source Committee, where additional guidance can be provided to staff. Chadwick Collins, Cohen Company on behalf of the Roof Coatings Manufacturers Association, questioned the accuracy of the cost analysis for alternative solvents and product reformulation in the socioeconomic impact assessment. He noted there were earlier discussions about considering other solvents and higher VOC limits for roofing categories; however, those options were not presented. Rita Loof, RadTech International, spoke to oppose the staff proposal, and expressed concern that removing the definition of energy curable materials to avoid

disapproval by U.S. EPA was premature, given that U.S. EPA has not issued a disapproval, but rather has asked for public comments on a proposed disapproval. She requested that the proposed amendments be delayed, allowing for U.S. EPA to review the UV/EB/LED industry's comments. She also requested that staff join their efforts to obtain U.S. EPA's approval of the test method. For additional details, please refer to the Webcast beginning at 2:23:40.

Mark Abramowitz, Community Environmental Services, expressed support for the proposed amendments, noting that the proposal allows additional time to comply with the rule while reducing toxic exposures. He opposed the proposed changes requested by Mr. Raymond for an exemption and emphasized the need to address foregone VOC reductions. Katy Wolf, a consultant, expressed support for the staff recommendation, ban on pCBtF and t-BAc, and conditional VOC exemption for Opteon 1100 based on OEHHA's evaluation.

There being no further requests to speak, the Public Comment Period was closed.

Supervisor Rutherford expressed concern that staff is acting on the assumption that U.S. EPA will disapprove the thin film test method for UV/EB/LED materials. She stated that she would be opposing the proposal, unless staff has something to offer if U.S. EPA changes course. For additional details, please refer to the Webcast beginning at 2:32:45.

Dr. Rees explained that U.S. EPA has issued a partial SIP disapproval for Rules 1106 and 1107 for referencing ASTM Test Method D7767-11 when they became aware that the test method was not U.S. EPA approved. She also emphasized the serious consequences for including a test method not approved by U. S. EPA if action is not taken. For additional details, please refer to the Webcast beginning at 2:33:27.

Mr. Nastri added that per the Board's recommendation, staff did request clarity in this matter but U.S. EPA has made their decision so we are reacting accordingly. 28. Determine That Proposed Rule 1460 – Control of Particulate Emissions from Metal Recycling and Shredding Operations Is Exempt from CEQA, and Adopt Proposed Rule 1460

Michael Krause, Assistant Deputy Executive Officer/Planning, Rule Development and Implementation, gave the staff presentation on this item.

In response to Mayor Cacciotti's inquiry about how the 200 unpermitted facilities are being regulated and by what other agencies, Mr. Krause responded that these facilities are subject to South Coast AQMD Rule 403 for fugitive emissions, but this new rule imposes more requirements specific to these types of metal facilities. In addition, they are permitted and regulated by the Reginal Water Quality Control Board. For additional details, please refer to the Webcast beginning at 2:43:56.

Agenda Item No. 28 was opened for public comment; and the following individuals addressed the Board.

Joe Weiss who represents a small business that operates scrap metal facilities expressed support for the proposal. However, he expressed concern regarding the use of water to minimize fugitive dust emissions, given that water runoff activities are regulated by the State Water Resources Board. He inquired about guidance on how that will be regulated because daily watering will create runoff. For additional details, please refer to the Webcast beginning at 2:45:06.

Mr. Krause responded that Proposed Rule 1460 provides options other than water to control fugitive dust such as covering or doing these operations, like within an enclosure. For additional details, please refer to the Webcast beginning at 2:47:44.

Moses Huerta, Paramount resident and former Paramount Planning Safety Commissioner, thanked staff and commended industry for their constructive input. He commented on the importance of this rule for the community. For additional details, please refer to the Webcast beginning at 2:48:30.

James Simonelli, California Metals Coalition, stated that the Coalition is in support of Rule 1460 and that comments raised during the rulemaking process were addressed. Regarding the water issue, he explained that facilities are permitted by the state water board in terms of having a stormwater permit and have the proper controls in place, including water testing.
