21 1. I am a Program Supervisor for the Planning, Rule Development and Implementation  
22 Division of the South Coast Air Quality Management District. I am directly involved with the rule  
23 development process for Proposed Amended Rule 1135. The following statements are made based  
24 upon my personal knowledge or information that has been provided to me from my staff or  
25 management.

26 2. Proposed Amended Rule 1135 is currently anticipated to go before the Governing  
27 Board in the Summer of 2024. Rule staff anticipates the rule amendment will address the current  
28

1 prohibition in the Rule that no new diesel internal combustion engines may be installed on Santa  
2 Catalina Island after January 1, 2024, as well as modify the mass emission limits for NOx from all  
3 electric generating units located on Santa Catalina Island. The date Proposed Amended Rule 1135  
4 goes before the Governing Board is subject to change.
