It is my understanding that LASAN is attempting to shutdown their reporting hotline on the grounds that they are not receiving enough calls to indicate that there continue to be an issue or that justifies the continuation of it

There are many reasons these calls have appeared to dwindled residents are tired of making these calls because:

1) They are told that the smell is due to the neighbor fertilizing their yard, the porta potty at the construction site

around the corner, it's trash day.

- 2) They are told that everything thing is functioning properly (even when citations are issued)
- 4) That there is no smell or Hyperion staff don't smell anything (when residents are present for their monitoring

and it is verified by AQMD inspectors)

- 5) The Hotline is not functioning
- 6) The Hotline phones are not being answered therefore reports are not taken
- 7) The attitude and actions of certain Hyperion administration frustrates residents as their manner and tone of

said administrator is felt to be belittling, demeaning, and dismissive.

Attached are some of my calls to the hotline. A follow up call and a written report was been requested. Often either a report was not received in the timely matter as required by previous AQMD hearings or was never received at all.

While LASAN promotes that they are being a good neighbor, many residents are tired and frustrated with LASAN's lack of transparency, their unprofessionalism, and inhumane behavior.
