Call to Order/Opening Remarks:

Ms. Fabian Wesson, Assistant Deputy Executive Officer, called the meeting to order at 12:30 p.m.

Agenda Item #1: Approval of October 24, 2018 Meeting Minutes

Mr. José Trinidad Castañeda moved to approve the October 24, 2018 Advisory Council meeting minutes. The motion was seconded and approved.

Agenda Item #2: Adoption of YLAC Goals and Objectives for 2019

Mr. Castañeda proposed an addition to the Goals and Objectives to add a non-voting member to the South Coast AQMD Governing Board, elected by the members of YLAC. Ms. Nancy Feldman responded that she would look into the legal requirements for such an appointment. Mr. Castañeda made a motion for the item be added to the Goals and Objectives. Ms. Mikayla Winfery seconded. The motion was approved.

Agenda Item #3: Adoption of 2019 YLAC Meeting Schedule

Ms. Winfery moved to approve the 2019 Meeting Schedule; the motion was seconded by Ms. Rush. The meeting schedule was approved without amendments.

Agenda Item #4: South Coast AQMD's Compliance and Enforcement Division

Mr. Terrence Mann, Assistant Deputy Executive Officer, presented an overview of South Coast AQMD's C&E Division, including the process of receiving and investigating public complaints.

Ms. Janielle Vidal asked whether leaf blowers were considered agricultural equipment subject to regulation or inspection by South Coast AQMD. Mr. Mann stated that they were not subject to inspection and regulation, but South Coast AQMD did have exchange programs to help replace gas-powered leaf blowers and lawnmowers.

Mr. Castañeda asked how complaints were handled in the case of no-burn violations in public or outdoor areas. Mr. Mann stated that they were addressed in the same manner as other types of complaints.

Mr. David Herman requested clarification of when and how asbestos is addressed. Mr. Mann stated that the asbestos rules apply during renovation or demolition where asbestos is present.

Mr. Castañeda asked for the rule numbers corresponding to the various complaint types. Mr. Mann stated that Rule 461 refers to gasoline dispensing facilities, Rule 1403 refers to asbestos demolition and renovation, and Rule 1469 refers to hexavalent chromium.

Mr. Herman asked for clarification on the table data point designated "Spots." Mr. Mann stated he would look into the matter.

Action Item: Staff to look into "spots."

Staff explained that "spots" refers to a type of complaint where residents see unidentifiable spots or stains on their vehicles.

Ms. Nithya Palani asked whether there were certain facilities which might be exempt from South Coast AQMD permit rules based on business size. Ms. Feldman stated that permit requirements were based on the technology being used, rather than business size. Mr. Mann added that even if a business did not require or possess a permit, they would still be subject to South Coast AQMD rules.

Ms. Vidal asked if businesses would consult South Coast AQMD on questions on rules or rule guidelines, or if they would be expected to consult an outside consultant for advice. Mr. Mann explained that businesses could address inquiries to South Coast AQMD or seek advice from the South Coast AQMD Small Business Group, but that some elected to consult outside advisors.

Ms. Winfery asked how South Coast AQMD responds when certain types of technologies are either updated, changed, or newly introduced. Mr. Mann stated that, as technology advances, South Coast AQMD has implemented new and different steps to address changing needs. Ms. Feldman expanded that amendments might be required to permits in order to accommodate new or changing equipment which might not be specifically named by a rule, but would have a significant effect on emissions.

Ms. Wesson requested a brief explanation on the process by which complaint calls were processed. Mr. Mann confirmed that each complaint call is handled as a singular incident, and complainants were not required to make additional calls before their concerns would be addressed.

Agenda Item #5: Check Before You Burn

Ms. Elle Carlos, Assistant Account Executive at Westbound Communications, provided a presentation on South Coast AQMD's Check Before You Burn Program.

Mr. Herman asked about the statistics on the number of residences found to be burning wood during no-burn advisory periods.

Action Item: Staff to check on the number of warnings and violations issued on no-burn days.

South Coast AQMD received 69 complaints during the 2017-18 Check Before You Burn Season. One warning letter was issued, as well as 13 Notice of Violation letters.

Ms. Vidal asked how No-Burn regulations are enforced at local beaches. Ms. Feldman explained that there are concentrated efforts to enforce No-Burn regulations as appropriate with beach fire pits, but acknowledged that the matter is an ongoing challenge.

Mr. Herman asked if there was data to back up whether the Check Before You Burn pledge forms were demonstrating effective behavioral change. Ms. Carlos pointed out concrete data based around the pledge forms had not been gathered, but that the forms were primarily used to educate, to gather information, to sign residents up for air alerts, and to encourage social change rather than provide enforceable action. Ms. Kim White also added that though data was not currently available, residents had been responding and enforcement had increased.

Mr. Herman also asked if South Coast AQMD had information or data pertaining to similar programs in other areas of the country in which fireplaces were more utilized. Ms. White replied that there has not been an official study conducted by South Coast AQMD.

Mr. Joshua Bell expressed a concern regarding low-income and homeless communities that might not have any alternatives for heat during cold periods. Ms. White explained that exceptions were made for residents who had no other heating alternatives.

Ms. Wesson asked if there were ways to educate and inform organizations such as homeowner's associations. Ms. Carlos and Ms. White both confirmed speakers could be arranged through South Coast AQMD's Legislative and Public Affairs department.

Ms. Cassie Nguyen asked how it was determined that a No-Burn alert would go into effect. Ms. White explained the South Coast AQMD Meteorology department calls No-Burn periods based on particulate matter forecasts.

Ms. Winfery asked if alternatives to wood logs such as Duraflame logs were allowed on No-Burn days. Ms. White explained that Duraflame logs still emit particulate matter and cannot be burned on No-Burn days, but gas logs can be burned.

Mr. Castañeda asked if South Coast AQMD materials and presentations are available in Korean. Ms. White confirmed that materials were available in Korean.

Agenda Item #6: Member Updates

Ms. Palani announced a recent change in roles with her company, and that she is now working in air quality inspection. She explained her future work would intersect with AB 617 efforts in the future.

Ms. Leeann Tran introduced herself and commended the efforts of South Coast AQMD in her local area of Riverside.

Ms. Kimberly Duong introduced herself as a Ph.D. student at UC Irvine, and expressed an interest in coordinating with the Irvine Water District at which she interns.

Ms. Vidal announced an opportunity to apply for an AAAS Workshop geared to send applicants to DC to speak with representatives.

Mr. Herman announced he would be attending an AWMA health conference in Quebec, and that he had two reports on air quality and health effects coming out this year.

Ms. Ana Gonzalez introduced herself as a local activist and school district employee, and expressed an interest in helping communities negatively impacted by air pollution. She stated that she is part of the Center for Community Action Environmental Justice Board of Directors.

Mr. Bell, a member of the community steering committee for San Bernardino/Muscoy, briefed the Advisory Council on AB 617 Steering Committee activities for the San Bernardino/Muscoy area. He stated his concern that attendees did not have enough time to comment during the meetings. Ms. Wesson explained that the structure of the meeting was designed to be as undisruptive to the meeting as possible and that the public could speak during the public comment portion.

Ms. Winfery announced she would soon be transferring to a university. She also recommended South Coast AQMD look into working with Dr. Afif El-Hasan and possibly inviting him to speak to YLAC.

Action Item: Staff to look into inviting Dr. Afif El-Hasan to speak to YLAC at a future meeting.

Dr. Afif El-Hasan is tentatively scheduled to present at the October 23, 2019 meeting.

Mr. Castañeda requested a discussion on the subjects of low-income housing and environmental justice. Ms. Feldman offered some commentary on the issue of low-income housing clashing with environmental justice goals, and suggested a possibility of inviting representatives from either side of the conflict to present to the committee.

Action Item: Staff to agendize a discussion item regarding low-income housing and environmental justice for the April 24, 2019 meeting.

A discussion item regarding low-income housing and environmental justice has been agendized for the April 24, 2019 meeting.

Mr. Albert, a member of the community steering committee for San Bernardino/Muscoy, added some comments on the AB 617 steering committee meetings from the San Bernardino/Muscoy, and suggested in similar committee meetings he'd seen Public Comment periods offered at the beginning of a meeting as opposed to the end. He also reminded members of the upcoming Earth Week.





