Introduction to the Voucher Incentive Program (VIP)

The VIP is a streamlined approach to reduce emissions by replacing older, higher-polluting vehicles with newer, lower-emission vehicles. This program is limited to owners/operators with fleets of **10 or fewer** vehicles that have been operating at least 75% (mileage-based) in California during the previous twenty-four (24) months. The goal of this program is to reduce emissions from in-use heavy-duty trucks in small fleets by replacing Engine Model Years 2009 and older with new replacement trucks that are certified to the optional Low NOx standard of 0.02 g/bhp-hr or cleaner.

The VIP is implemented by South Coast AQMD through contractual agreements with Dealers and Dismantlers. The Dealers apply to the South Coast AQMD for the vouchers on behalf of the applicant. If approved, the voucher amount will be deducted from the total purchase price of the truck by the Dealer. Applicants interested in replacing their truck must purchase their replacement truck through an South Coast AQMD-approved VIP Participating Dealership that has completed the required training for the VIP. New for 2022

Since the final implementation deadline for the Truck and Bus Regulation is less than a year away, funding for trucks under this year's program will be exclusively limited to technologies that are certified at the 0.02 g/bhp-hr NOx standard or cleaner, including zero emission vehicles. Applicants pursuing these options may be eligible to receive up to \$160,000 for Low NOx trucks and up to \$410,000 for Zero Emission trucks.

Program Highlights

1. First-Come First-Served Basis (no application deadline; open until funds are exhausted)
2. Rapid Response Time: Applicant is notified within 15 business days of submitting application for funding
3. Exclusively for small fleets (**10 or fewer trucks**), including drayage trucks
4. Maximum of \$160K available per truck for replacements meeting 0.02 NOx and up to \$410K available for Zero Emission replacements
5. No contract required between applicant and South Coast AQMD
