This bimonthly publication satisfies the requirements for reporting on air quality in the South Coast Air Basin set by California legislation (Chapter 1301, Statutes of 1987; Health and Safety Code Section 40451(d)), and supplies similar information for the Coachella Valley area of the Salton Sea Air Basin served by the District.

May and June 2005 Air Quality

Shown and summarized in the following tables are air quality statistics for the South Coast Air Basin and the desert area of Coachella Valley in the Salton Sea Air Basin for the months of May and June. Table 1 (below) summarizes the maximum concentrations recorded and location of the maximum during May-June 2005.

Figure 1 shows the location of the District's air monitoring stations in each source/receptor area. The number of days exceeding the state and federal standards and the maximum concentrations of the pollutants in each source/receptor area for the months of May and June 2005 are summarized in Tables 2 and 3, respectively.

Current Revisions to Air Quality Standards

The 1-hour average federal ozone standard was revoked (replaced by the 8-hour average standard) effective June 15, 2005.

California Air Resources Board established a new 8-hour average California ozone standard of 0.070 ppm effective May 17, 2006.

U.S. EPA has strengthened the level of the 24-hour PM_{2.5} standard to 35 µg/m³ effective December 17, 2006, and has revoked the annual PM₁₀ standard. The 24-hour PM₁₀ standard is retained.

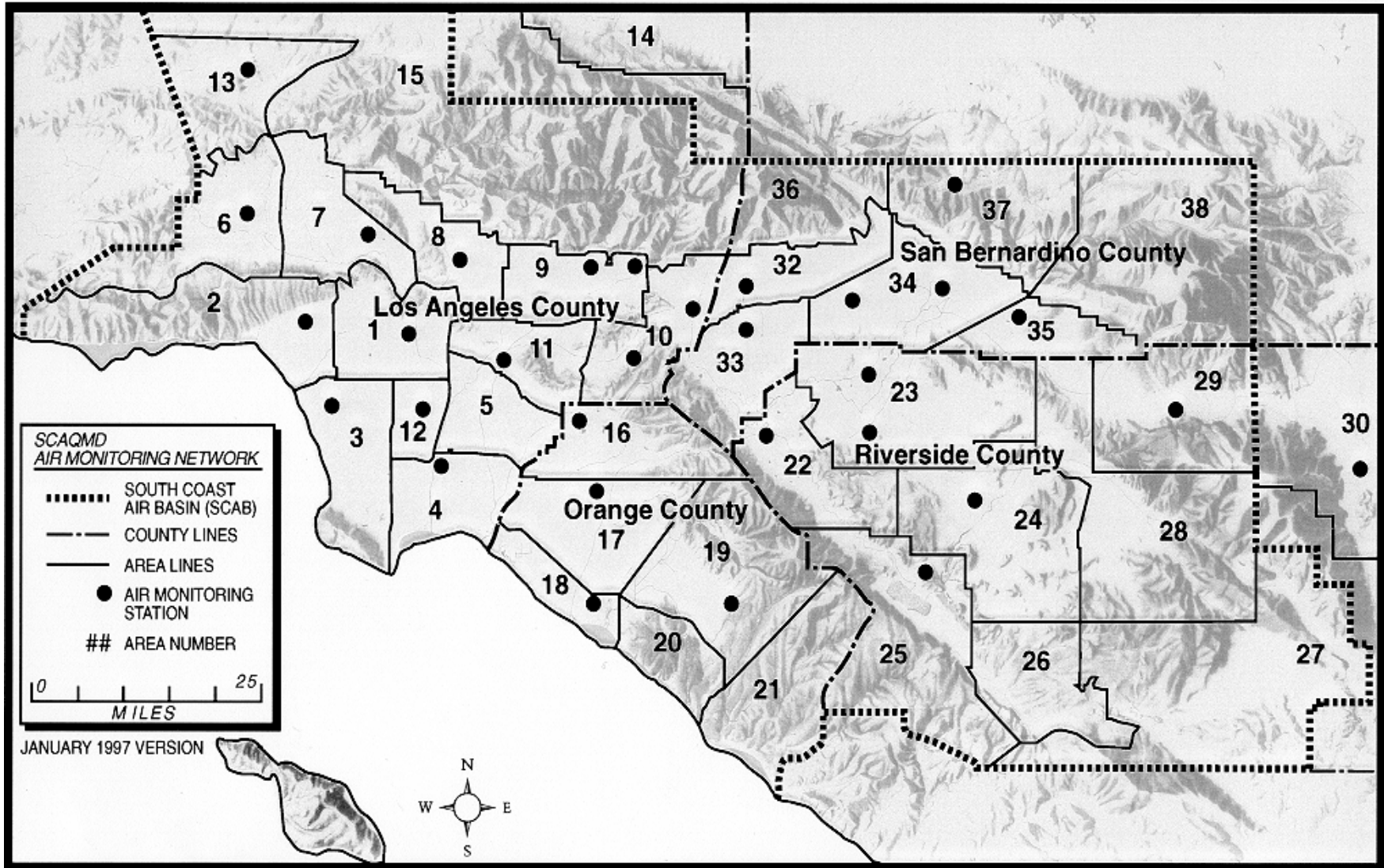
