A facility or site inspection may be required as part of the Laboratory Approval. The cost for this is \$144.45/hr up to \$423.41 additional.

Inspections/visits may be conducted concurrently for more than one method.

Audit sample analysis may also be required, and the costs are \$192.56/hr up to \$564.51 additional (per analysis).

\*Method 100.1 system audits are mandatory for approval (may also be required subsequently for renewal). The cost is \$192.56/hr up to \$564.51 additional (per analyzer).
