

On March 21, 2012, the San Joaquin Valley Air Pollution Control District (SJVAPCD) will host a training class for the new California Emission Estimator Model (CalEEMod) at the SJVAPCD Governing Board Room. CalEEMod is the newest statewide computer emissions estimating model developed by the South Coast Air Quality Management District in collaboration with other California air districts. The model calculates criteria pollutant and greenhouse gas (GHG) emissions from a variety of land uses, including residential and commercial projects. CalEEMod also calculates both direct and indirect GHG emissions from energy use, water conveyance, wastewater treatment and vegetation planting/removal. In addition, the model calculates the benefits from implementing mitigation measures, including GHG mitigation, in a project. The model was released in February 2011 and air districts throughout the state are recommending the use of this model for air quality analysis. Air quality analysis is necessary for compliance with the California Environmental Quality Act (CEQA), National Environmental Policy Act (NEPA) and useful for pre-project planning and showing compliance with local air quality rules and regulations.

The training will benefit those who would use the model, such as government agencies, land use planners, consultants and environmental professionals required to quantify and review air emissions associated with the construction and operation of a land use or transportation project. **The training is free of charge and does not require a reservation in advance.** The training will include an overview of the model, a detailed hands-on demonstration of the operation, user tips and an explanation of the quantification of the GHG mitigation measures derived from a document prepared by the California Air Pollution Control Officers Association (CAPCOA).

The model is also free of charge and can be downloaded onto your computer. The model files, User's Guide, user's tips, frequently asked questions, etc. can be accessed at www.caleemod.com.
