

Public Workshops, California Environmental Quality Act (CEQA)/Socioeconomic Scoping Meetings on the Draft 2016 Air Quality Management Plan (AQMP)



The South Coast Air Quality Management District (SCAQMD) has developed a draft of the 2016 Air Quality Management Plan (AQMP) in partnership with the California Air Resources Board (CARB), U.S. Environmental Protection Agency (U.S. EPA), and the Southern California Association of Governments (SCAG) with input from stakeholders throughout the region including local and state government, businesses, academia, and environmental organizations. While air quality has dramatically improved over last several decades, the region still exceeds the national ambient air quality standards (NAAQS) for both ozone and particulate matter and experiences some of the worst air pollution in the nation. The 2016 AQMP includes actions to ensure that rapidly approaching attainment deadlines are met, that the public health is protected to the maximum extent feasible, and that the region is not faced with economically onerous sanctions if the NAAQS are not met. The 2016 AQMP includes a comprehensive analysis of emissions, meteorology, atmospheric chemistry, regional growth projections, and the impact of existing and proposed control measures. The result is a strategy that demonstrates attainment of the NAAQS for the South Coast Air Basin and Coachella Valley. Public workshops are scheduled take place throughout the region to discuss the Draft 2016 AQMP as well as an environmental impact analysis of the AQMP in accordance with CEQA. The meetings will also serve as scoping meetings for the socioeconomic analysis of the 2016 AQMP.
