John Wayne Airport, Orange County



- Owned & operated by County of Orange
- 503 acres
- Two runways
 - ✓ 5,700 feet
 - ✓ 2,887 feet (general aviation)
- Thomas F. Riley Terminal
 - ✓ 20 gates (loading bridge)
- \$6 Billion to the local economy





Settlement Agreement 2014

Million Annual Passengers (MAP)

- ✓ Phase 1: **10.8** MAP through December 31, 2020
- ✓ Phase 2: 11.8 MAP from January 1, 2021 through December 31, 2025
- ✓ Phase 3:
 - 12.2 MAP from January 1, 2026 through December 31, 2030 if less than 11.21 MAP is served in one calendar year between January 1, 2021 and December 31, 2025, OR;
 - 12.5 MAP from January 1, 2026 through December 31, 2030 if more than 11.21 MAP is served in one calendar year between January 1, 2021 and December 31, 2025





Settlement Agreement 2014

Average Daily Departures (ADDs)

- Maximum of 85 Class A ADDs for passenger service through December 31, 2020
- ✓ Maximum of 95 Class A ADDs for passenger service from January 1, 2021 through December 31, 2030
- ✓ 4 Class A ADDs designated for priority allocation to allcargo service through December 31, 2030. Two of these may be allocated for passenger service. Historically, 2 allcargo service Class A ADDs are requested and allocated to the cargo carriers.

Emission Sources Evaluated by JWA

Direct Control

- ✓ JWA Fleet: licensed on-road vehicles, unlicensed vehicles and equipment owned by JWA
- ✓ Contract fleet: parking lot shuttles

No Direct Control


- \checkmark Vehicles owned/contracted by airlines
- \checkmark Ground support equipment (GSE) and fuel trucks
- ✓ Permit vehicles: limousines, shuttles, buses, taxis, transportation network companies (TNCs)
- ✓ Rental cars, delivery vehicles
- ✓ Personal vehicles owned by passengers, tenants and concessionaires; JWA employee vehicles

JWA Measures Under Development

Measure 1: Ground Support Equipment (GSE)
 ✓ Annual gr/bhp-hr fleet-wide target

Measure 2: Jet Fuel Delivery Trucks

✓ Eliminate routine truck trips upon startup of new pipeline system

- Measure 3: Concessions Nighttime Delivery Policy
 ✓ Delivery during least congested traffic time
- Measure 4: JWA Owned Vehicle Clean Fleet Policy ✓ Cleaner, alternative fuel or electric upon replacement
- Measure 5: Parking Shuttle Bus Electrification



✓ Early progressive electrification of shuttle buses



JWA Measures Under Development (Cont.)

- Measure 6: Clean Construction Program
 ✓ Tier 4 off-road engine emission standards
- Measure 7: Smart Parking Features
 ✓ Lighted parking spaces, pay-on-foot, credit card entry/exist
- Measure 8: Congestion and Passenger Vehicle Reduction

✓ Cell phone and taxi waiting lots

Measure 9: TNC Vehicle Miles Traveled Reduction
 Policy








JWA Initiatives Under Development

Initiative 1: Taxi Clean Fleet Policy

- ✓ Contract terms for progressively cleaner vehicle replacements
- Initiative 2: Electric Vehicle Charging Infrastructure
 - ✓ Addition of chargers in parking lots, as demand dictates
- Initiative 3: Passenger Transportation Mode Shifts ✓ Continuing coordination with OCTA and mass transit links
- Initiative 4: Orange County Employee Rideshare Program
