SCAQMD Continues Smoke Advisory for Canyon 2 Fire

This advisory is in effect today, Wednesday, Oct. 11, through Thursday morning, Oct. 12. SCAQMD will issue an update if additional information becomes available.

A brush fire, named the Canyon Fire 2, is burning in Orange County near Gypsum Canyon, Anaheim Hills and towards the cities of Tustin and Orange. The burn area is reported to be 8,000 acres, with 40 percent containment. Winds will remain from the southwest through Wednesday, although weaker nighttime and morning winds may cause smoke to accumulate in some areas. Smoke and ash impacts will be greatest in the vicinity of the fire in northern and central Orange County and into portions of Riverside County, depending on evolving fire conditions. Air quality may reach Unhealthy levels or higher in areas directly impacted by smoke.

Areas of direct smoke impacts and Unhealthy air quality may include portions of:

- Central Orange County (Forecast Area 17);
- Saddleback Valley (Forecast Area 19); and
- Corona/Norco Area – Riverside County (Forecast Area 22).

All individuals are urged to exercise caution and avoid unnecessary outdoor activities in any area directly impacted by smoke. This includes areas where residents can see or smell smoke.

In any area directly impacted by smoke: Everyone should avoid any vigorous outdoor or indoor exertion; people with respiratory or heart disease, the elderly, and children should remain indoors. Keep windows and doors closed or seek alternate shelter. Run your air conditioner if you have one and keep the fresh air intake closed and the filter clean to prevent bringing additional smoke inside. Avoid using a swamp cooler or whole-house fan to prevent bringing additional smoke inside. To avoid worsening the health effects of wildfire smoke, don't use indoor or outdoor wood-burning appliances, including fireplaces.
