## South Coast AQMD Issues Windblown Dust Advisory for Portions of the Coachella Valley and Eastern Riverside County

## Valid: Tuesday, April 18 through Wednesday, April 19, 2023

This advisory is in effect through 5 a.m. Wednesday. South Coast AQMD will issue an update if additional information becomes available.

A PM10 Dust Advisory is in effect from noon on Tuesday through 5 a.m. on Wednesday morning due to strong winds in the San Gorgonio Pass, Coachella Valley, and Eastern Riverside County. As of Tuesday morning, the National Weather Service (NWS) has posted Wind Advisories in the region. Visit the NWS San Diego (<u>https://www.weather.gov/sgx/</u>) and NWS Phoenix (<u>https://www.weather.gov/psr/</u>) websites for information regarding these wind advisories.

High winds can lift dust and soil and lead to poor air quality. Blowing dust during this event may result in Air Quality Index (AQI) levels that are **Unhealthy for Sensitive Groups** or worse. Air quality can vary hour by hour and by location depending on wind conditions.

In areas directly impacted by high levels of windblown dust, limit your exposure by remaining indoors with windows and doors closed and avoiding vigorous physical activity. Run your air conditioner or air purifier if available and avoid using whole house fans or swamp coolers that bring in outside air. Exposure to high particle pollution levels can cause serious health problems, including asthma attacks, heart and lung disease symptoms, and increased risk of respiratory infections. People with heart or lung diseases should follow their doctor's advice for dealing with episodes of unhealthy air quality. Children, older adults, and people with respiratory or heart disease should avoid prolonged exposure and strenuous activities when particle pollution levels are high.

Areas of direct impacts and poor air quality may include portions of:

• **Riverside County**: San Gorgonio Pass (Area 29), Coachella Valley (Area 30), East Riverside County (Area 31)



**In areas directly impacted by windblown dust:** Everyone should avoid any vigorous outdoor or indoor exertion; people with respiratory or heart disease, the elderly, and children should remain indoors.
