## PROPOSED ADOPTION OF, OR AMENDMENT TO, THE RULES AND REGULATIONS OF THE SOUTH COAST AIR QUALITY MANAGEMENT DISTRICT AND PROPOSED SUBMISSION INTO THE STATE IMPLEMENTATION PLAN

## **<u>RE:</u>** Proposed Amended Rule 461.1 – Gasoline Transfer and Dispensing for Mobile <u>Fueling Operations</u>

**NOTICE IS HEREBY GIVEN** that a public hearing on the matter of adoption of rules and regulations for the South Coast Air Quality Management District (South Coast AQMD), or the amendments thereto, will be held **at 9:00 a.m. on Friday, February 2, 2024 in the Dr. William A. Burke Auditorium at South Coast AQMD, 21865 Copley Drive, Diamond Bar, CA 91765**, at which time evidence will be taken and all interested persons will be heard by the South Coast AQMD Governing Board. The meeting will be conducted through a hybrid format of in-person and/or virtual attendance via videoconferencing and by telephone with opportunities for public comment. Please refer to the instructions on South Coast AQMD's website regarding the format of the Public Hearing, updates if the meeting is changed to a full remote via webcast format, and for details on how to participate:: <u>http://www.aqmd.gov/home/news-events/meeting-agendasminutes</u>.

**NOTICE IS FURTHER GIVEN** that the South Coast AQMD is considering the adoption of Proposed Amended Rule 461.1 – Gasoline Transfer and Dispensing for Mobile Fueling Operations (PAR 461.1). The objective of PAR 461.1 is to clarify that aviation gasoline, which is used to fuel smaller aircraft, is exempt from the rule. The amendment will align Rule 461.1 with Rule 461, which is applicable to gasoline dispensed into motor vehicles. At the time of adoption, the applicability of Rule 461.1 included gasoline dispensed into equipment or containers; however, the intent was not to include aviation gasoline dispensed into aircraft.

**NOTICE IS FURTHER GIVEN** that PAR 461.1 will be submitted to the California Air Resources Board and the United States Environmental Protection Agency for inclusion into the State Implementation Plan.

**NOTICE IS FURTHER GIVEN** that PAR 461.1 implements Sections 110, 172, and 182(e), and 189 of the Clean Air Act.

**NOTICE IS FURTHER GIVEN** that the PAR 461.1 does not impose a new emission limit or standard, make an existing emission limit or standard more stringent, or impose new or more stringent monitoring, reporting, or recordkeeping requirements and therefore, a comparative analysis pursuant to Health and Safety Code Section 40727.2 is not required.

**NOTICE IS FURTHER GIVEN** that pursuant to the California Environmental Quality Act (CEQA) Guidelines Sections 15002(k) and 15061, the proposed project (PAR 461.1) is exempt from CEQA pursuant to CEQA Guidelines Section 15061(b)(3). A Notice of Exemption will be prepared pursuant to CEQA Guidelines Section 15062, and if the proposed project is approved, the Notice of Exemption will be filed for posting with the State Clearinghouse of the Governor's Office of Planning and Research, and with the county clerks of Los Angeles, Orange, Riverside, and San Bernardino Counties.

**NOTICE IS FURTHER GIVEN** that PAR 461.1 does not significantly affect air quality or emission limitations, so no socioeconomic impact assessment pursuant to Health and Safety Code Sections 40440.8 and 40728.5 is required.
