Purpose of These Meetings

The South Coast Air Quality Management District (South Coast AQMD) has scheduled a community meeting and public workshop to present information and solicit comments from the public on Proposed Rule (PR) 2305 – Warehouse Indirect Source Rule – Warehouse Actions and Investments to Reduce Emissions (WAIRE) Program; and PR 316 – Fees for Rule 2305. PR 2305 and PR 316 are scheduled for adoption consideration at a public hearing before the South Coast AQMD Governing Board on April 2, 2021.

Proposed Rule 2305 and Proposed Rule 316 Background

PR 2305 would apply to operators and owners of existing and new warehouses with floor space equal to or greater than 100,000 square feet within a single building. These facilities are used to receive, store, and serve as a distribution point for goods. The majority of emissions associated with warehouses are from on-road vehicles such as trucks that deliver goods, and off-road vehicles such as cargo handling equipment. PR 2305 would require facilities to annually take actions that either reduce emissions, or that facilitate emission reductions. PR 316 has been developed to establish fees to be paid by warehouse operators subject to PR 2305 to recover South Coast AQMD administrative costs associated with ensuring compliance with PR 2305.

Objectives and Summaries of Proposed Rules

The objective of PR 2305 is to reduce regional and local emissions associated with warehouses to assist in meeting state and federal ozone and fine Particulate Matter (PM) air quality standards. The key pollutants of interest for PR 2305 include nitrogen oxides (NOx, a key precursor pollutant for ozone and fine PM) and Diesel PM (a component of fine PM, and a toxic air contaminant). Under PR 2305, warehouse operators will be required to annually comply with one or more of three options. First, they may choose to implement actions from a prescribed menu. Menu items include actions such as purchasing or ensuring the use of near-zero (NZE) or zero emissions (ZE) trucks or ZE cargo handling equipment, installing fueling/charging infrastructure for ZE vehicles, installing and

using solar panels, or installing filtration for building ventilation systems at nearby sensitive land uses such as schools to reduce exposure to PM. Second, they may choose to prepare and implement a site-specific custom plan from actions that are not on the menu. Custom plans could include onsite and offsite measures within the control of the operator that can be demonstrated to reduce emissions of NOx and/or diesel PM. Finally, they could instead choose to pay a mitigation fee to South Coast AQMD. These funds would then be used to provide financial incentives for truck owners to purchase NZE or ZE trucks, or for the installation of fueling and charging infrastructure. Funds would be directed towards projects in the communities near warehouses that paid the fee. Warehouse operators and owners would also have reporting and recordkeeping requirements. The objective of PR 316 is to recover the cost of South Coast AQMD programs related to PR 2305. Fees will be required for actions requiring South Coast AQMD resources, such as enforcement and plan reviews.

California Environmental Quality Act

Pursuant to the California Environmental Quality Act (CEQA) and South Coast AQMD's certified regulatory program (Public Resources Code Section 21080.5, CEQA Guidelines Section 15251(l) and South Coast AQMD Rule 110), the South Coast AQMD, as lead agency for the proposed project, prepared and circulated a Notice of Preparation/Initial Study for a 32-day public review and comment period between Friday, November 13, 2020 and Tuesday, December 15, 2020. South Coast AQMD is preparing a Draft Environmental Assessment that will also be circulated for public review and comment.
