## 2012 AQMP Development and Plan Outreach Now in Process

**D**evelopment is continuing on SCAQMD's Draft 2012 Air Quality Management Plan (AQMP), the comprehensive clean air blueprint for the South Coast Air Basin. The Draft AQMP will describe the control strategies proposed to achieve federal clean air standards by specified deadlines. Past control measures resulted in cleaner trucks and cars, cleaner household paints and lubricants, as well as pollution reduction from petroleum operations, fireplaces, and composting processes.

SCAQMD staff are also meeting monthly with the AQMP Advisory Group and the Scientific, Technology and Modeling Peer Review Advisory Group. Both groups have been tasked with providing both policy and technical feedback on the development of the AQMP. This is SCAQMD's tenth plan, incorporating the latest technical information and planning assumptions, including the Southern California Association of Government's (SCAG) recently approved 2012 Regional Transportation Plan and Sustainable Communities Strategy, updated emission inventory methodologies

for various source categories, and SCAG's latest growth forecasts.

In conjunction with the development of the AQMP, staff is conducting an extensive outreach program to inform and engage a wide range of stakeholders on the process, goals and impacts of the AQMP. Staff has been meeting with key stakeholders including the California Air Resources Board (CARB), SCAG, Council on California Economic and Environmental Balance, the Ports of Los Angeles and Long Beach, Southern California Edison, and the Gas Company, to discuss plan development, emissions inventory data and growth assumptions.

Staff has been invited to provide presentations to community and business organizations and to participate in CARB's Goods Movement conference as part of the continuing effort to meet with and inform public agencies, government officials, business leaders, community representatives, environmental groups and health advocates on AQMP issues. The AQMP outreach program will continue into this summer



with additional workshops, focus groups, peer review, and stakeholder meetings now being scheduled

Once the draft plan has been fully developed, expected by June 2012, it will be made available for public review and comment. Public workshops and hearings will be held during the review period. The draft plan is scheduled to be considered by the SCAQMD's Governing Board in the fall of 2012, after which it will be submitted to CARB for approval, and subsequent submittal to the U.S. Environmental Protection Agency by December 2012.

## Proposals Requested for Emission Reduction Projects in the Coachella Valley

**I**n February, South Coast Air Quality Management District released a request for proposals for emission reduction projects in the Coachella Valley. Approximately \$53 million is available to fund a wide variety of air pollution reduction projects that could include such things as school bus and heavy-duty truck retrofit or replacement, truck stop electrification, school air filtration systems, renewable-energy power projects, alternative fuel refueling/charging stations, and infrastructure improvements such as paving dirt roads, parking areas, or others.

SCAQMD is holding office hours in the Coachella Valley to provide guidance and assistance to bidders. The Request for Proposals, Number 2012-17, is downloadable at [www.aqmd.gov/rfp](http://www.aqmd.gov/rfp). Attendance at the office hours is voluntary, and assistance is not a guarantee of project funding. Rather, it is intended as an aid in developing a complete and comprehensive proposal for consideration.

Appointments are recommended to meet with SCAQMD staff during the office hours, although walk-ins are welcome, but there may be some wait time. The remaining office hours will be held Friday, May 18 from 2:00 p.m. to 8:00 p.m. and Saturday, May 19 from 9:00 a.m. to 2:00 p.m. at the Palm Desert Center of University of California, Riverside, 75080 Frank Sinatra Drive, Palm Desert, CA 92211.

# Contract for Marine Vessel Retrofit Technology Demonstration Project Approved by SCAQMD

**T**he South Coast Air Quality Management District Governing Board on April 6 approved spending up to \$100,000 in U.S. EPA grant funds to cosponsor a marine vessel retrofit technology project which will demonstrate a combined diesel particulate filter (DPF) and selective catalytic reduction (SCR)

technology on a marine vessel.

SCAQMD will execute a contract with Hug Filtersystems, which designs, manufactures, installs, and maintains DPF and SCR technologies for reducing criteria and toxics emissions from marine, stationary, and mobile engines, and is the sole provider of the Mobiclean® technology. Funding is also being provided by the Ports of Los Angeles and Long Beach, and Sause Brothers, a marine transportation services company.

Commercial harbor craft are a significant contributor to the South Coast Air Basin's nitrogen oxides (NOx) and diesel particulate matter (PM) emissions and are estimated by the California Air Resources Board to emit 14 tons per day of NOx and 0.6 tons per day of diesel PM emissions. The use of DPF and SCR technology on marine vessels is expected to reduce NOx and PM emissions by more than 80%. This project

facilitates the commercialization of DPF and SCR technologies for a range of vessels and engines. Similar emission reductions are expected from other marine vessels.

On June 4, 2010, the Governing Board authorized \$5 million of U.S. EPA grant funds in the Carl Moyer Program Fund to be used for diesel emission reduction projects. A total of \$4.9 million of the grant is being used to cosponsor the installation of shore power infrastructure and diesel truck replacement projects. The marine vessel retrofit technology demonstration project will utilize the remaining \$100,000 of the grant.

## Symposium Held on Metalworking Fluids and Lubricants

**S**outh Coast Air Quality Management District and the Independent Lubricant Manufacturers Association (ILMA) held a one-day joint symposium on March 8, 2012 to discuss SCAQMD Rule 1144 — Metalworking Fluids and Direct-Contact Lubricants. The symposium included discussions regarding technology advancements, case studies, formulating options, measurement, and manufacturing impacts of that rule. District staff discussed rule requirements, supplier and distributor reporting and test method procedures. The symposium originated from a Governing Board resolution directing staff to meet and confer with interested parties to explore the feasibility of establishing a 25 g/l limit for metalworking fluids. That resolution also requires interested parties to discuss any technical adjustments to laboratory methods for determining VOC content. Over 90 people attended the symposium with 250 hits on the associated webcast. Many of those attending in person were able to tour SCAQMD's laboratory to see the equipment involved in VOC content determination.

Six metalworking formulating company representatives presented their experiences with developing compliant and Super-Compliant (<50 g/L) alternative products. This included representatives of Houghton International, Inolex, the Lubrizol Corporation, American Research Products, Taminco, and Timely Industries who spoke on specific testing methodologies, new advances in rust prevention, reformulating issues, and a case study of the rule. Two presentations also examined the science behind the VOC determination and the development of the test method.

The symposium reflected the success of the working group that met regularly throughout the rule development process and continued the collaborative process from which the rule was derived.

## Clean Air Choices Cleaner Certification Program Provides Opportunities for Businesses

**T**he South Coast Air Quality Management District's new "Clean Air Choices" voluntary certification program seeks to raise the profile of ultra-low-polluting commercial cleaning products in the marketplace. Commonly used cleaning products are a source of volatile organic compound (VOC) emissions in Southern California, and contribute to the formation of smog.

The Clean Air Choices Cleaner Certification Program focuses on very low-polluting cleaning products used by maintenance and cleaning workers at commercial office buildings, schools, retail stores and hotels, as well as vehicle fleets. Such products include air fresheners, floor care products, all-purpose cleaners and degreasers, bathroom and tile cleaners, carpet and upholstery cleaners, automobile soaps, glass cleaners, and metal polishes/cleaners.

The program is intended to increase awareness of existing environmentally friendly products as well as to encourage manufacturers to develop additional low-emission formulations for products used by maintenance and janitorial workers at government and commercial office buildings, schools, retail stores, and hotels, as well as vehicle fleets.

To become certified, a product must meet environmentally preferable qualifications which includes having a VOC limit of 10 grams per liter or less. Manufacturers, suppliers and users can apply for certification which is valid for three years and can be renewed.

## Smog Season is now Underway and Avoiding Air Pollution is Important

**A**nother smog season officially started on May 1, 2012, in the South Coast Air Basin, and will run until October 31, 2012. These are the warmest months of the year, and hot, stagnant days favor the formation of ground level ozone, commonly known as smog. Although smog levels in the Southland have declined significantly over the past few decades, progress has slowed in recent years. If there are hotter-than-normal temperatures this summer, there is a greater chance of more unhealthy days.

Ground-level ozone can cause short-term health effects, including chest pain, coughing, and noise and throat irritation. It is also linked to increased symptoms for those with asthma and bronchitis. Therefore, avoiding activities and exposure to air pollution is very important for people's health. SCAQMD continues to balance emission controls and market incentives, particularly those targeting diesel emissions, in order to clean the air and protect public health.

In order to avoid unnecessary exposure to outdoor air pollution, residents can view current forecasts and other air quality information on SCAQMD's web site at [www.aqmd.gov](http://www.aqmd.gov). Information and brochures on the Air Quality Index (AQI), the health effects of smog, and other topics can be downloaded at [www.aqmd.gov/pubinfo/brochures.htm](http://www.aqmd.gov/pubinfo/brochures.htm).

The AQI provides guidance to all residents as to what activities should not be engaged in during high smog level days, ranging from Unhealthy for Sensitive Groups (0-50), to Very Unhealthy (201-300). Depending on the current and forecasted levels of air pollution, it may be advisable to reduce or avoid prolonged outdoor activities.

Current forecasted AQI information is also available from the SCAQMD's smart-phone application. In 2010, SCAQMD launched the nation's first full-featured air quality smart-phone application. The free application, designed for the iPhone and iPod Touch, features real-time and forecasted air quality levels for user-selected areas; a user-friendly carbon footprint calculator to reduce greenhouse gases, and an interactive map for locating alternative fuel stations throughout California. The app allows users to report smoking vehicles, either through a direct-dial to SCAQMD's 1-800-CUT-SMOG hotline, or a voice recording that can be sent at a later time.

# SCAQMD's Darlene Valenzuela Receives Rodney Swartzendruber Outstanding Inspector Award

One of the South Coast Air Quality Management District's inspectors, Darlene Valenzuela, was the proud recipient of the California Air Pollution Control Officers Association's Rodney Swartzendruber Outstanding Inspector Award at the November 2011 CAPCOA Enforcement Managers Fall Conference.

This is the second year in a row that an SCAQMD inspector has received this award (Larry Israel received it the previous year). The award was created in honor of Rodney Swartzendruber, an inspector with the San Joaquin Valley Air Pollution Control District who gave his life in the line of duty on October 7, 1999 while helping CARB with air monitoring of the Westley tire fire in Central Valley. This annual award recognizes three air quality inspectors throughout California (one each in a small, medium, and large air district), who had outstanding performance or made significant contributions that have benefited air pollution control efforts in an exemplary way.

Darlene has worked at SCAQMD since 1976

and is currently an Air Quality Inspector III. During her past 18 years as an inspector, she has acquired extensive knowledge and experience conducting complex inspections and investigations of RECLAIM and Title V sources, as well as performing commercial and industrial inspections and complaint investigations involving a diverse array of facilities.

Among her most noteworthy accomplishments has been her work over the past few years on SCAQMD's implementation of California's Portable Equipment Registration Program (PERP). She coordinated and provided field training for inspectors, developed standards and guidelines for PERP inspections, developed and implemented strategies for greater efficiency and provided inspectors and the public with information and presentations concerning PERP regulations.

# Registration is Now Open for 2012 Lawnmower Exchange

**R**egistration is now open for the tenth annual “Mow Down Air Pollution” electric lawn mower exchange program. Southern California residents can save money and help reduce air pollution by exchanging a working gasoline-powered lawn mower for a new electric mower at a deeply discounted price. There are six exchange events scheduled throughout the region, to be held between May and July. The events will be held in Indio, Long Beach, Pasadena, Anaheim, Riverside and Rancho Cucamonga.

This year’s program will have 4,000 electric mowers available with six models to choose from ranging in price from \$100 to \$280, depending on which lawn mower is selected by the consumer. Residents living within AQMD’s four-county jurisdiction must show proof of residency and can register for any exchange event regardless of where they reside in the region. Pre-registration is required to participate in the lawn mower exchanges. ## Ask The SCAQMD Advisor

**Q:** If I need a permit, how do I fill out an application form, and what is the process for submitting it?



**A:** The SCAQMD permitting program has been established to implement the requirements of the federal Clean Air Act, state Clean Air Act, the Air Quality Management Plan (AQMP), and air quality rules and regulations by specifying operating and compliance requirements for stationary sources that emit air contaminants.

The most common types of permit applications filed at SCAQMD are the Permit to Construct and the Permit to Operate. Prior to installation of new or relocated equipment, or prior to modification of an existing equipment, the operator of the equipment is required to obtain a Permit to Construct from SCAQMD.

Once a piece of equipment is installed, modified and/or operated, SCAQMD processes the application for a Permit to Operate. In cases where equipment is installed without a prior Permit to Construct, SCAQMD also processes the application directly for a Permit to Operate. In cases of off-the-shelf type equipment, SCAQMD issues a one-step Permit to Construct/ Permit to Operate.

The first step is to fill out an application for a permit. This can be done by visiting SCAQMD’s Permit Application Forms web page at: [www.aqmd.gov/permit/forms.html](http://www.aqmd.gov/permit/forms.html).

If you need assistance with filing an application, see the Permitting Staff Locator on the Permit Applications Forms web page for a directory of contacts for your particular equipment or business type.

Once completed, the permit application should be mailed to the address on the application form. If you need help to make sure that all the necessary information is provided, SCAQMD Permit Services representatives are ready to help you and can be reached by calling (909) 396-3385.

### Rule 1110.2 – Emissions from Gaseous and Liquid Fueled Engines

Amendments to Rule 1110.2 are proposed to address the impact of contaminants in biogas used to fuel power generators at landfills and municipal waste facilities. The amendments may result in a delay or loss of emission reductions.

### Rule 1177 - Liquid Petroleum Gas Transfer and Dispensing

Proposed Rule 1114 will establish emission limits and other requirements for the operation of coking units at petroleum refineries.

## September

### Rule 219 - Equipment Not Requiring a Written Permit Pursuant to Regulation II

Staff will consider exempting low emitting processes/equipment that require written permits, and include them under the Rule 222 Filing Program, thus streamlining the permitting process and reducing the cost for facilities and clarify permitting requirements for several other processes.

### Rule 222 - Filing Requirements for Specific Emission Sources Not Requiring a Written Permit Pursuant to Regulation II

Staff will evaluate currently permitted equipment with very low emissions and consider incorporating into the Rule 222 Filing Program. In addition, staff will evaluate other equipment currently exempt from permits, but subject to source-specific rules, for inclusion into the Rule 222 Filing Program.
