SCAQMD Mourns Passing of Vice Chairman Roy Wilson

Dr. S. Roy Wilson, **Riverside County Supervisor** and Vice-Chairman of the South Coast Air Quality Management District (SCAQMD) Governing Board, passed away on August 26th. He served on the SCAQMD Governing Board for nearly 22 years, holding the position of Vice Chairman since 2003. When Wilson first joined the Board, he represented the cities of Riverside County, and then later represented the county itself. He was first elected **Riverside County Supervisor** representing the Fourth District in November 1994. Prior to that he was a City Councilman of Palm Desert, serving as mayor four times.

In 2008, Supervisor Wilson was honored by his fellow SCAQMD Governing Board Members with a special commendation recognizing his years of service in clean air policymaking. His notable contributions to the SCAQMD included leading the efforts to implement fugitive dust control strategies for the Coachella Valley, and bringing alternative fuel infrastructure and vehicles to the Inland Empire. His was a



powerful voice for forward-looking public policies, including funding actions to help industry capture emerging global markets for low-emission technologies and products, and helping advance zero-emission technologies such as solar energy and fuel cells. In recent years, he was very active in supporting solar roofs, especially for large commercial facilities, along with related enabling legislation and policies.

Supervisor Roy Wilson's personal commitment to agency policymaking efforts earned him the respect and appreciation of his fellow Governing Board Members, staff, local businesses, environmental organizations and the general public. His tireless dedication toward improving the well-being and quality of life for all residents of Southern California will be missed.

\$60 Million In Federal Stimulus Grants Awarded To SCAQMD

Volume 16 Number 5 September 2009 n August, SCAQMD was awarded three grants totaling more than \$60 million from the U.S. Department of Energy (DOE) through programs funded under the President's economic stimulus bill, the American Recovery and Reinvestment Act. The first, a \$45.4 million grant will be used by SCAQMD to accelerate the development of U.S.-manufactured next-generation batteries and electric vehicles, while the other two grants, totaling \$5.6 million and \$9.4 million, will help speed the transformation of the region's Liquified Natural Gas (LNG) infrastructure.

The largest award will help SCAQMD develop a fully integrated, production plug-in hybrid electric vehicle (PHEV) system for delivery trucks and shuttle

buses. The goal is to produce a fleet of 378 PHEV vehicles which will be utilized by utility and fleet partners. More than 100 of these vehicles will be demonstrated in California with the remaining vehicles delivered for nationwide testing in daily long-term fleet use.

"This is a significant investment by the federal government and will help accelerate the development of cleaner, medium-duty work vehicles and reduce the amount of air pollution in Southern California as well as the nation," said Barry R. Wallerstein, SCAQMD executive officer.

The \$5.6 million award will help finance the completion of a long-planned 700-mile LNG fueling corridor along one

of the nation's most heavily traveled truck routes. This project will make the final connection between the existing LNG fuel infrastructure in Southern California and LNG fuel stations in Utah.

The \$9.4 million grant, meanwhile, will fund the purchase of LNG trucks to replace 180 diesel drayage trucks at the Ports of Los Angeles and Long Beach along with instruction for truck operators and technicians working on LNG trucks. DOE estimates that this project alone will help displace an estimated 1.8 million gallons of petroleum annually.

The Small Business Assistance staff strives to respond to the needs of small business owners and operators within the SCAQMD jurisdiction.

If a small business has difficulty complying with air pollution control laws, and needs temporary relief while working toward a solution without being subject to penalties, it may be necessary to obtain a variance. The Small Business Assistance staff can help the small business to prepare for variance petition filings with the Hearing Board.

SCAQMD Provides School Districts Millions To Replace Dirtiest Diesel School Buses

A t its July meeting, the South Coast Air Quality Management District Governing Board awarded nearly \$43 million to help school districts in the Southland purchase clean-burning compressed natural gas and propane buses to replace the dirtiest diesel school buses in their fleets.

Additionally, SCAQMD awarded more than \$3 million to help school districts retrofit 176 newer diesel school buses with particulate traps to reduce diesel emissions.

"The number of school buses being replaced or retrofitted with this award is extraordinary and it's a giant step toward our goal of cleaning up all school bus fleets in the region," said William A. Burke, Ed.D., Chairman of the SCAQMD Governing Board. "This will help thousands of school children and their communities breathe a little easier." SCAQMD has been a leader in providing incentives to help replace older diesel school buses with cleaner buses. Since 2000, SCAQMD has approved \$151.5 million to replace 925 older diesel school buses with cleaner models and retrofit 2,918 newer diesel buses with particulate traps.

SCAQMD Testifies at EPA Hearing Regarding Marine Vessel Emissions

S CAQMD has taken an active role in the development of legislation and new regulations to address marine vessel emissions. Such vessels are a substantial source of emissions and until recently, have been mostly unregulated. In August, the U.S. Environmental Protection Agency (U.S. EPA) held a public hearing in Long Beach regarding its proposal to control emissions from large marine diesel engines on U.S.-flagged vessels. These engines are used primarily to power container ships, tankers, and cruise ships.

As part of SCAQMD's continuing involvement in this issue, staff testified at the public hearing. In particular, SCAQMD is focused on ensuring that U.S. EPA's proposed regulations result in emissions being controlled sufficiently and guickly enough for this region to meet federal clean air deadlines.

U.S. EPA is proposing emission standards that are equivalent to the nitrogen



oxides (NOx) limits recently adopted pursuant to the International Maritime Organization's (IMO) MARPOL Annex VI international treaty. U.S. EPA also proposed to IMO to limit the sulfur content of marine fuel oil to 1,000 ppm sulfur for use in U.S.

waters. The IMO rules, would be generally applicable within 200 nautical miles of U.S. coastlines.

The EJAG is comprised of an ethnically and geographically diverse membership, with at least two members from each county and representatives from the most highly impacted communities within SCAQMD's jurisdiction. The meetings provide an opportunity for members to share community updates, discuss policy issues and formulate recommendations that will help SCAQMD make meaningful and continuous progress toward the achievement of

environmental justice. To date, the advisory group has met twice and has considered topics such as the health effects of air pollution and the EJAG's goals and objectives for their first year.

U.S. House Passes Major Climate Change Bill

n March 2009, Rep. Henry A. Waxman (D-Cal.), Chairman of the Energy and Commerce Committee of the U.S. House of Representatives and Rep. Edward J. Markey (D-Mass.), Chairman of the Energy and Environment Subcommittee, released draft climate and clean energy legislation, known as the American Clean Energy and Security Act of 2009 (ACES), aimed at combating global warming. On June 26, the House passed ACES, which, among other things, would implement a cap-and-trade program to limit greenhouse gas (GHG) emissions. The bill creates emission caps to reduce aggregate GHG emissions from covered entities to 17% below 2005 levels by 2020, and 83% below 2005 levels by 2050. ACES includes provisions regarding renewable energy and energy efficiency, carbon capture and sequestration, clean transportation and transportation efficiency, and green jobs and worker training programs, among others. The bill is currently being considered

by the U.S. Senate, which is expected to take action on this legislation this year.

SCAQMD has been actively engaged in the policy discussion surrounding this bill. SCAQMD efforts are focused on facilitating the reduction of GHG emissions within the South Coast basin, along with achieving simultaneous reductions of other pollutants, to continue to improve air quality throughout the region.
