Purpose of This Meeting

The South Coast Air Quality Management District (South Coast AQMD) has scheduled a public workshop to present and solicit information and comments on Proposed Amended Rule (PAR) 1107 – Coating of Metal Parts and Products. PAR 1107 is scheduled for a Public Hearing before the South Coast AQMD Governing Board on February 7, 2020.

Rule Background

Rule 1107 applies to all metal coatings operations except those performed on aerospace assembly, magnet wire, marine craft, motor vehicle, metal container, and coil coating operations. Typical facilities include metal furniture manufacturers, fabricated metal product manufacturers, small and large appliance manufacturers, metal finishers, and the paint and coating manufacturers that supply products to the metal manufacturing shops. Rule 1107 sets volatile organic compound (VOC) limits for twenty-two categories of coatings classified as air-dried (cured below 194 degrees F) or baked (cured at or above 194 degrees F).

Objective of Proposed Amended Rule

PAR 1107 will revise exemptions for High-Performance Architectural, Vacuum-Metalizing, and Pretreatment coatings and Electrocoatings to be consistent with Reasonable Available Control Technology requirements as recommended in United States Environmental Protection Agency's *Control Techniques Guidelines for Miscellaneous Metal and Plastic Parts Coatings (September 2008)*. Other amendments address work practices for coating-related activities, update test methods, remove obsolete provisions, and make clarifications.

California Environmental Quality Act

Pursuant to the California Environmental Quality Act (CEQA) and South Coast AQMD's Certified Regulatory Program (Rule 110), the South Coast AQMD, as lead agency for the proposed project, is reviewing PAR 1107 to determine if it will result in any potential adverse environmental impacts. Appropriate CEQA documentation for the proposed project will be prepared based on the analysis.
