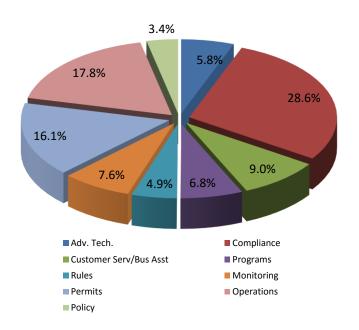

Regulation III Fees - Background

- Fees seek to recover costs of mandatory services, such as:
 - Permit Processing (new, modification/alteration, new operator, etc.)
 - Compliance Assurance (annual renewals and emissions fees)
 - Hearing Board
 - Source Tests and Lab Analysis
 - **Plans**
 - Transportation programs
 - Area Sources programs
 - "Toxic Hot Spots" program
- ~ 63% of agency revenues from Regulation III fees

Why Increasing Fees is Necessary

- In spite of streamlining operations, we are still not recovering our costs, including resources required to perform extensive engineering evaluations/activities; reliance on use of fund balance is not sustainable.
 - >\$5.9M shortfall projected for FY 2017-18 without proposed fee adjustments.
- Stationary source fees have not kept pace with inflation.
 - Compared to FY 1991-92, fees have increased by about 29%; however when adjusted for inflation, stationary source revenues have decreased by 24% over this same time period.

Proposed Amended Regulation (PAR) III

- Proposed amendments to REG III consist of the following four (4) components:
 - CPI (inflation-based adjustment)
 - Non-Title V permit-related services (partial cost recovery)
 - Title V permit-related services (cost recovery)
 - Administrative (updates with no fiscal impact)
- No increase in emissions fees beyond CPI

Component 1 – CPI Adjustment

- Increase in most fees in Reg III by the 2.5% change in the CY 2016 CPI (inflation-based adjustment)
- Pursuant to Rule 320 Automatic Adjustment Based on Consumer Price Index for Regulation III - Fees
- Example: Rule 301(j)(6)(A) Certification of Barbecue Charcoal Igniter Products (min. processing fee/product):

Current Fee (FY 2016-17)	Adjusted Fee (FY 2017-18)
\$640.46	\$656.47

Despite CPI adjustment program costs are underrecovered

Component 2 – Non-Title V Adjustment

- Partially recover Non-Title V operational costs
- Staff's cost recovery proposal: additional 4% per year increase, above CPI, for each of the next two (2) fiscal years (FYs) for Non-Title V permit related fees
- No increase above CPI for emissions-related fees
- Example: Rule 301(c)(1)(J) Standard Streamlined Permits application processing fee (non-small business):

Component 3 - Title V Adjustment

- Based on USEPA's 9/30/2016 "SCAQMD Title V Operating Permit Program Evaluation Final Report"
- Finding: Title V fees insufficient to recover program costs
- Recommendation: raise fees to cover costs
- Staff's cost recovery proposal: additional 16% per year increase, above CPI, for each of the next two (2) fiscal years (FYs) for Title V permit-related fees
- No increase above CPI for emissions-related fees
- Example: Rule 301(m)(7) Title V Permit Revision Fee:

Component 4 - Admin Updates

- For FY 2017-18 proposed administrative updates to Regulation III Fees will have <u>no</u> fee impact and include:
 - Deleting obsolete provisions (e.g., FY 2007-08 six month transitional period emissions fee rates)
 - Increasing the grace period for certain fees from 60 to 75 days in Rule 301
 - Correcting or clarifying existing provisions (e.g., the Rule 301(q) fee for optional expedited permit processing already includes a charge for mileage)
 - Recommencing publication of Rule 314(g) fees to 3 decimal places (total fee is paid to the nearest cent)
 - Reformatting the Rule 306(h) plan fees table by Rule number

Socioeconomic Assessment

- Staff annually prepares a socioeconomic assessment of the automatic across-the-board CPI fee increase, which was posted on March 15*
- An additional socioeconomic assessment was prepared for the overall PAR III fee increases (CPI & beyond CPI), and was posted to SCAQMD's website on April 7th. It examines:
 - Current SCAQMD fee amounts by industry (FY 2015-16)
 - Estimated fee increase amounts by industry (FY 2017-18 & FY 2018-19)
 - Macroeconomic job impact analysis of estimated fee increases (using the REMI model)
