LARGE CONFINED ANIMAL FACILITY (LCAF) CONSISTING OF:

1. LAYING HENS AND BROODERS
2. SIXTY (60) SINGLE LAYER, NATURALLY VENTILATED HEN HOUSES
3. THREE (3) NATURALLY VENTILATED BROODER HOUSES
4. ONE (1) MECHANICALLY VENTILATED BROODER HOUSE
5. THIRTY FIVE (35) FEED TANKS
6. SCRAPE TYPE MANURE HANDLING SYSTEM
7. MANURE STOCK PILES

**Conditions :**

1. OPERATION OF THIS EQUIPMENT SHALL BE CONDUCTED IN ACCORDANCE WITH ALL DATA AND SPECIFICATIONS SUBMITTED WITH THE APPLICATION UNDER WHICH THIS PERMIT IS ISSUED UNLESS OTHERWISE NOTED BELOW.
2. THIS EQUIPMENT SHALL BE PROPERLY MAINTAINED AND KEPT IN GOOD OPERATING CONDITION AT ALL TIMES.
3. THE MAXIMUM NUMBER OF LAYING HENS AND BROODERS AT THIS FACILITY SHALL NOT EXCEED 1,040,000 ANIMALS IN ANY ONE DAY.
4. THE MAXIMUM NUMBER OF LAYING HENS AT THIS FACILITY SHALL NOT EXCEED 890,000 ANIMALS IN ANY ONE DAY.
5. THIS EQUIPMENT IS SUBJECT TO THE APPLICABLE REQUIREMENTS OF RULE 223 - EMISSION REDUCTION PERMITS FOR LARGE CONFINED ANIMAL FACILITIES.

## PERMIT TO OPERATE

6. THE OPERATOR SHALL IMPLEMENT THE MEASURES IDENTIFIED IN THE APPROVED EMISSIONS MITIGATION PLAN PRIOR TO (ONE YEAR FROM PERMIT ISSUANCE.)
7. THE OPERATOR SHALL SUBMIT A WRITTEN ANNUAL REPORT BY JANUARY 15TH OF EACH YEAR AFTER JANUARY 1, 2008 PER THE REQUIREMENTS OF RULE 223. THE REPORT SHALL BE SENT TO: SCAQMD, COMPLIANCE DIVISION, PO BOX 4941, DIAMOND BAR, CA 91765-0941.
8. THE OPERATOR MAY TEMPORARILY SUSPEND IMPLEMENTATION OF PORTIONS OF THE DAIRY LCAF EMISSIONS MITIGATION PLAN PROVIDED REQUIREMENTS OF RULE 223(J)(2) ARE MET. NOTIFICATION TO THE DISTRICT SHALL BE MADE BY CALLING 1 800 CUT SMOG.
9. THE OPERATOR SHALL MAINTAIN RECORDS THAT SPECIFY THE MONTHLY AVERAGE NUMBER OF ANIMALS MAINTAINED AT THIS FACILITY.
10. THE OPERATOR SHALL MAINTAIN RECORDS, IN A MANNER APPROVED BY THE DISTRICT, TO DEMONSTRATE COMPLIANCE WITH CODITION NOS. 3, 4 AND 9. THE RECORDS SHALL BE RETAINED AT THE FACILITY FOR AT LEAST THREE YEARS AND BE MADE AVAILABLE TO DISTRICT PERSONNEL UPON REQUEST.

### NOTICE

IN ACCORDANCE WITH RULE 206, THIS PERMIT TO OPERATE OR COPY SHALL BE POSTED ON OR WITHIN 8 METERS OF THE EQUIPMENT.

THIS PERMIT DOES NOT AUTHORIZE THE EMISSION OF AIR CONTAMINANTS IN EXCESS OF THOSE ALLOWED BY DIVISION 26 OF THE HEALTH AND SAFETY CODE OF THE STATE OF CALIFORNIA OR THE RULES OF THE AIR QUALITY MANAGEMENT DISTRICT. THIS PERMIT CANNOT BE CONSIDERED AS PERMISSION TO VIOLATE EXISTING LAWS, ORDINANCES, REGULATIONS OR STATUTES OF OTHER GOVERNMENT AGENCIES.
