The California Air Resources Board's (CARB or Board) October meeting was held on October 26, 2017 in Riverside at the Riverside County Administrative Center. Key items presented are summarized below.

CONSENT ITEMS

17-10-2: Public Meeting to Consider Supplemental Transportation Conformity Budgets for the Portola Fine Particulate Matter (PM2.5) Attainment Plan

The Board approved the supplemental transportation conformity budgets (budgets) for the Portola Fine Particulate Matter (PM2.5) Attainment Plan (Plan). The California Air Resources Board will submit the budgets to the United States Environmental Protection Agency as a revision to the California State Implementation Plan.

17-10-3: Public Meeting to Consider 11 Research Proposals

The Board approved 11 research proposals that were developed in response to the Board-approved FY 2017-2018 Annual Research Plan, these proposals are:

1. A Tool to Prioritize Sources for Reducing High PM2.5 Exposures in Environmental Justice Communities in California, University of Texas, at Austin.

DISCUSSION ITEMS

17-10-5: Public Meeting to Hear an Update on the Implementation of Assembly Bill 617 (The Community Air Protection Program)

The Board heard an update on efforts underway to implement the mandates of Assembly Bill (AB) 617. AB 617, known as the Community Air Protection Program (CAPP), is the most significant criteria and toxics air quality legislation passed in California in the last three decades. CAPP is designed to provide important new tools to address pollution exposures in California's most heavily impacted communities, disadvantaged communities, and sensitive receptor locations. Specifically, AB 617 requires the California Air Resources Board to identify communities with the highest exposure burden and develop a Statewide Monitoring Plan and Statewide Reduction Strategy by October 2018. The Board heard that CARB staff has begun the public process meeting with community and environmental justice organizations, air districts, and additional stakeholders to determine the most appropriate focus of community air monitoring in addition to defining goals and metrics for community level actions in reducing exposure to air pollution. **SCAQMD Staff Comments/Testimony:** The Executive Officer provided comments regarding the implementation of AB 617 and the importance of the role of local air districts in that process. Support was expressed for the process that will be implemented over the next several months. Staff stressed the need for fast action on incentive funding in order to show the successes of early action to secure ongoing funding in the future, and described the significant resources required to carry out various community monitoring efforts. The need for quick action to achieve necessary emissions reductions was emphasized as well as a commitment for continued collaboration with CARB staff on implementation of the CAPP.

17-10-1: Public Meeting to Consider the Ozone State Implementation Plan for Imperial County

The Board adopted the Imperial County 2017 State Implementation Plan for the 2008 8-hour Ozone Standard (Ozone SIP). The item was removed from the consent calendar to provide the Board an opportunity to discuss the effects of emissions from Mexico on Imperial County ozone. The Ozone SIP demonstrated that Imperial County would have attained the standard but for the emissions from Mexico. The Executive Officer updated the Board on efforts working with Mexican authorities to minimize emissions from vehicles originating in Mexico. The Ozone SIP will be submitted to U.S. EPA as a revision to California's State Implementation Plan.

17-10-4: Public Meeting to Hear an Update on California's Allocation of the Volkswagen Environmental Mitigation Trust (First Partial Consent Decree, Appendix D)

The Board heard a summary of the Volkswagen (VW) Consent Decree's Appendix D requirements for California's allocation of the VW Environmental Mitigation Trust (Trust). Funds from the Trust, about \$423 million in California, will address excess emissions of Nitrogen Oxides (NOx) caused by the VW deception and will be used to replace older heavy-duty vehicles and equipment, and fund light-duty electric vehicle infrastructure. The California Air Resources Board (CARB) is developing, through a public process, the Beneficiary Mitigation Plan (Plan) that summarizes how California will allocate the Trust funds. The Plan will be based on guiding principles being developed with stakeholders and following Senate Bill 92 direction to dedicate 35 percent of the funds to benefit low income or disadvantaged communities, and to be consistent with other State priorities. CARB staff provided the Board with a summary of the public comments received to date, a schedule of upcoming public meetings, and an outline of potential guiding principles for the Plan. CARB staff is scheduled to return to the Board with the final Plan in the spring of 2018.
