

# Exide Vernon Facility Timeline

- Exide technologies in Vernon, California recycled lead from used car batteries.
- The facility began operations in 1922, and it was acquired by Exide in 2000.
- The facility has not been in operation since March 2014.
- In March 2015, DTSC required the facility to close.
- On December 8, 2016, DTSC released a Final Closure Plan.
- Closure implementation began in November 2017.
- In March 2020, Exide stopped all closure activities in response to the COVID-19 pandemic.
- On May 19, 2020, Exide filed for Chapter 11, liquidation bankruptcy.

# Exide Vernon Facility Timeline (continued)

- In October 2020, a bankruptcy court approved a settlement agreement that released Exide from its obligation to clean up the Vernon facility. The settlement provided for the transfer of the facility to an environmental response trust (the “VERT”) to ensure an orderly transition of ownership and maintenance responsibility for the site.
- In November 2020, VERT hired a contractor to decontaminate and remove the main RCRA-regulated units, concluding in May of 2022.
- In April 2022, due to diminishing VERT funds, DTSC engaged a new contractor, ensuring that maintenance and cleanup work continued uninterrupted.
- In April 2025, DTSC’s contractor completed decontamination and removal of the 14 remaining, highly contaminated non-regulated structures, and DTSC completed the facility’s closure.
- In May 2025, DTSC published an update to communicate details of the facility closure and the removal of the non-regulated structures to the public.

# Facility Milestones Completed

- **October 2024** – Decontamination and deconstruction of fourteen non-regulated structures at the facility were completed.
- **February 2025** – All closure-related activities were completed.
- **April 2025** – Final closure certification report was received, and the DTSC closure verification letter was issued.
- **May 2025** – The Facility Title V permit was closed.
- **July 2025** – Five ambient air monitoring stations were removed.

# Activities in Progress and Estimated Timeline

- **2Q 2025** – Annual groundwater and surface impoundment (SI) monitoring field work was completed.
- **3Q 2025** – Annual groundwater and SI monitoring draft reports submittal.
- **3Q 2025** – Revised Screening Level Human Health Risk Assessment and Qualitative Ecological Assessment (SLHHRA) draft report received on July 11, 2025.
- **2Q and 3Q 2025** – Soil, soil gas, and groundwater Data Gap investigation field implementation.
- **3Q 2025** – Soil vapor extraction (SVE) pilot test implementation to begin.
- **4Q 2025** – Remedial Investigation (RI) draft report submittal.
- **Ongoing** – Facility operations and maintenance (O&M) and annual groundwater and SI monitoring activities will continue.







# Daily Ambient Air Monitoring - Lead



- After Title V permit closure, the ambient air monitors were removed in July 2025.





# Background

- South Coast AQMD regulated Exide through Title V Permit and South Coast AQMD rules
- In 2010, South Coast AQMD adopted Rule 1420.1 - Emission Standards for Lead and Other Toxic Air Contaminants from Large Lead-Acid Battery Recycling Facilities
  - Applied to two secondary lead smelters
  - Stringent requirements to reduce toxic emissions of lead, arsenic, benzene, and 1,3 butadiene.
  - Amendments in 2014 and 2015
- Rule 1420.1 requirements include:
  - Exhaust stack emission limits, source testing, fenceline ambient air monitoring, negative pressure total enclosures, and housekeeping



# Facility Closure Requirements

- In 2015, Exide's Vernon facility permanently closed
- Historical contamination was a source of fugitive emissions of lead and arsenic
- Rule 1420.1 amendment addressed facility closure requirements
  - Requirements to minimize fugitive emissions
  - On-going fenceline ambient air monitoring during closure activities
- In 2017, South Coast AQMD adopted Rule 1466 - Control of Particulate Emissions from Soils with Toxic Air Contaminants
- DTSC required Exide to develop Facility Closure Plan for decontamination and deconstruction of facility



# South Coast AQMD Permitting

## Title V Program

- Title V is the federal permitting program for major sources of air pollution. “Title V” comes from Title V of the 1990 federal Clean Air Act Amendments
- Title V permit remained active and enforceable through the remediation efforts
  - Facility Closure Plan incorporated into Title V permit
- After 2020 Exide bankruptcy, Title V permit transferred to Vernon Environmental Response Trust (VERT)



# Facility Closure

## Rule 1420.1(p) Facility Closure - Offramp Provisions




- The 2015 Rule 1420.1 amendment included a pathway to offramp from rule requirements
  - Arsenic and lead fugitive emission potential reduced due to remediation efforts
  - DTSC approval of closure
  - Compliant fenceline ambient air monitoring results and removal of permitted equipment
- South Coast AQMD review and approval prior to removing Rule 1420.1 applicability
  - If 1420.1(p) requirements not met, site must continue implementing Rule 1420.1 requirements.

# Facility Closure Verification

- Rule 1420.1(p) offramp provisions requires completion and verification of the following:
  - All permits have been surrendered
  - Certification of Closure approved by DTSC
  - One year of compliant fenceline ambient air monitoring
  - Additional 30 days of compliant fenceline results after submittal of Certification

Past Ambient Air Monitoring Sites



On May 30, 2025, South Coast AQMD verified and approved VERT request and inactivated Title V permit

Any future work at the site may be subject to Rule 1466 requirements

# What is a Heat Pump?

## *¿Qué es una bomba de calor?*

- Heat pumps are zero-emission appliances that can be used to heat air or water  
*Las bombas de calor son aparatos de cero emisiones que pueden utilizarse para calentar aire o agua*
- Work like an air conditioner in reverse: moving heat from the outside to the inside of the home  
*Funcionan como un aire acondicionado, pero a la inversa: trasladan el calor del exterior al interior de la casa*
- Most heat pumps draw heat from the air, but others can use the ground or water  
*La mayoría de las bombas de calor extraen el calor del aire, pero otras pueden utilizar el suelo o el agua*





A voluntary reservation system will allow property owners or installers to submit applications during the enrollment period to reserve funds prior to installing the heat pump appliance.

Applicants will be selected on a first-come first-served basis while funding is available. Funds will be made available upon completion of the project. The upcoming rebate application portal will provide more details.

### **What is a small business? *¿Qué es una pequeña empresa?***

This means a business which is independently owned and operated, has 10 employees or less and gross annual receipts of \$500,000 or less; or a not-for-profit training center.





- Awarded ~\$500 Million for INVEST CLEAN in October 2024

## Program's Purpose/Goals:

- Modernization of SoCal Goods movement and logistics network

# Charging Infrastructure Deployment Incentive Program (Measure 1)

## ► Eligible Entities:

- Entities that propose to develop and operate electric charging infrastructure to support HD vehicles involved in goods movement

## ► Location:

- Proposed infrastructure must be in one of the two MSAs

## ► Requirements:

- Build America Buy America
- EVIPT certified electricians

Available Funding Rebate Amount
Infrastructure equipment      up to \$700/kW

- Some installation costs are eligible for the rebate
- The rebate can only be used for the equipment on the consumer's side of utility meter or behind-the-meter

# Battery Electric Heavy-Duty Trucks Program (Measure 2.1)

## ► **Eligible Entities:**

- Fleet/Equipment Owner

## ► **Operating Location:**

- Equipment must be domiciled in one of the two MSAs

## ► **Existing Equipment Requirements:**

- Class 8 HHD Vehicles (GVWR of 33,001 pounds or greater) involved in good movement
- Diesel fueled

## ► **Replacement Equipment Requirements:**

- New Battery Electric Class 8 HHD Vehicle

► Rebate-based with a geographic funding minimum for each county within the two MSAs, when possible

Vehicle	Rebate Per Vehicle
BE Class 8 HHD Vehicle	Up to \$400,000

# Last Mile Freight Program - Class 4 & 5 Vehicle Replacement Program (Measure 2.2)

- ▶ SCAG will administer a rebate program to fund Class 4/5 battery-electric vehicles (max rebate \$67,000 per vehicle)
- ▶ Develop an implementation plan and program announcement for how the rebate program will be administered
- ▶ Include stakeholder engagement and outreach seeking input from public agency, industry, and local communities
- ▶ Require vehicle replacement through scrappage to achieve the emission reduction goals



# Last Mile Freight Program - Class 4 & 5 Vehicle Replacement Program (Measure 2.2) (Cont'd)

- Fleet Owners, OEMs, and Dealerships

## Operating Location:

- Vehicles must be domiciled in one of the two MSAs

## Existing Equipment Requirements:

- Diesel fueled mobile vehicles

- New Battery Electric Class 4 and Class 5 vehicles used in goods movement



- Rebates not to exceed \$67,000 per vehicle



# Battery Electric Switcher Locomotive Program (Measure 4)

- ▶ Accepting applications on June 6, 2025
- ▶ Eligible Applicants
  - ▶ Manufacturer partnered with a rail operator
  - ▶ Locomotive Switcher owners and/or operators
- ▶ Parallel path for locomotive and infrastructure build
- ▶ Flexible staggered deployment and scrappage opportunities of existing diesel locomotives
- ▶ Minimum usage requirement




# Battery Electric Locomotive Program

## Two Displacement Options

Implement BE Switcher locomotive and infrastructure prior to scrappage of existing locomotive

- ▶ Allows time to fix deficiencies on the BE switcher locomotive
- ▶ Allows for proper workforce training

# Voucher Incentive Program (VIP) – Opening Late 2025

- ▶ Limited to fleets of 20 or fewer vehicles
- ▶ Fleets must be in compliance with CARB Regulations
- ▶ At least 75% operation in CA
- ▶ First-come first-served basis
- ▶ Streamlined Process – Dealerships apply on your behalf
- ▶ Class 4 (GVWR  $\geq$ 14,001 pounds) and above
- ▶ Replacement truck must be Zero-Emission
- ▶ Up to \$410K/truck (Voucher based on annual miles for past two 12-month periods)
- ▶ Old truck must have engine model year 6+ years old
- ▶ Existing truck can be diesel or alternative fuel (e.g. natural gas)






