Agenda Item #1: Call to Order/Opening Remarks

Mr. Derrick Alatorre called the meeting to order at 12:02 PM. Ms. Julie Franco went over the housekeeping rules for the virtual meeting.

Agenda Item #2: Review of Follow-Up/Action Items

Ms. Alicia Lizarraga provided a response to the September 2, 2020, action items:

- *Action Item:* South Coast AQMD staff to share the Environmental Justice Conference outreach material with the Advisory Council members.
 - An email with Environmental Justice Conference outreach flyer was sent to all Advisory Council members on October 7, 2020.
- Action Item: Ms. Lizarraga to follow-up with Ms. Paula Torrado regarding her suggestions for the EJ Conference.
 - Ms. Lizarraga met with Ms. Torrado on September 11, 2020.
- *Action Item:* South Coast AQMD staff to follow- up with Ms. Theresa Martinez regarding monitoring of Exide and Air Quality in the Region.
 - An email response was sent to Ms. Martinez on November 20, 2020. The email contained links to South Coast AQMD's news update on Exide. Ms. Martinez was also provided with recent air quality information in the region and a link to the presentation on the 2020 Ozone Season and Wildfire impacts that was given at the November South Coast AQMD Governing Board meeting.

Agenda Item #3: Approval of Minutes

Ms. Alicia Lizarraga called for a motion to approve the September 2, 2020, Meeting Minutes. Mr. Eddie Marquez moved to approve the minutes and Mr. Oscar Rodriguez seconded the motion. Ms. Franco conducted a roll call vote. The motion passed.

The motion passed 11 aye votes, 0 no votes, and 1 abstention.

Derrick Alatorre excused himself for another meeting and Ms. Alicia Lizarraga presided over the meeting.

Agenda Item #4: Goals and Objectives for 2021

Ms. Julie Franco presented the 2021 Goals and Objectives. Ms. Alicia Lizarraga called for a motion. Ms. Ada Briceño moved to approve the Goals and Objectives for 2021 and the motion was seconded by Ms. Italia Garcia.

The motion passed 10 aye votes, 1 no vote, and 1 abstention.

Ms. Lisa Hart requested that in the future, staff provide a formal presentation on the Goals and Objectives to allow the Advisory Council members with an opportunity for further discussion if needed.

Agenda Item #5: Update on Federal Legislation

Ms. Lisa Tanaka O'Malley provided an overview of the environmental justice legislative bills and the goals for the 117th U.S. Congress term. She presented on the bill packages pertaining to Transportation, Infrastructure and Energy. Ms. O'Malley also spoke of the 2020 Fiscal Year Appropriations, COVID-19 and Economic Stimulus package under consideration.

Mr. Oscar Rodriguez inquired if there is any funding for Community Choice Energy and Community Choice Aggregation programs per city. Ms. O'Malley suggested that Mr. Rodriguez look at Representative Nanette Barragán's *Energy Resilient Communities Act* bill which will provide grants to communities to create sustainable energy clean microgrids. Ms. Theresa Martinez asked if this bill passed. Ms. O'Malley responded that the bill was introduced in October 2020, and has not passed, but the intention is to reintroduce the bill in January 2021.

Ms. Martinez requested that South Coast AQMD staff keep the Advisory Council members updated on the progress of this bill.

Ms. Rebecca Zaragoza inquired whether South Coast AQMD is monitoring Congressman Raúl Ruíz's *H.R.* 8775 - the Salton Sea Public Health and Environmental Protection Act especially since it relates to AB 617 implementation. Ms. O'Malley confirmed South Coast AQMD is tracking this bill and are looking to reach out to a Congressmember to partner with once the South Coast AQMD's Legislative and Governing Board approve to support the bill. Ms. O'Malley shared other efforts Congressman Ruíz is working in coordination with Federal Agencies on environmental issues related to the Salton Sea. Ms. O'Malley mentioned that the Advisory Council Members may be interested in the Small Environmental Justice Grants that are a part of the Energy Bill that would help communities plan like AB 617.

Ms. Zaragoza inquired where Advisory Council Members would be able to find and apply for the grants. Ms. O'Malley said that this bill did not make it out in this Congressional term.

Ms. Lisa Hart inquired how the Advisory Council Members could stay informed about the progress of federal legislation and when grants are made available. Ms. O'Malley responded that staff will keep the Advisory Council Members informed. She also shared that federal agencies publish their grants and administrative actions on the Federal Register website and is updated daily.

• *Action Item:* South Coast AQMD to provide link to the Federal Register to EJCP Advisory Council members.

Agenda Item #6: Illegal Dumping on the Torres Martinez Indian Reservation

Ms. Sienna Thomas provided an overview of illegal dumping incidents occurring on the Torres Martinez Reservation and other tribal lands. She presented historical context and details on the causes of illegal dumping. In addition, their team is currently collaborating with AB 617 and other community-based organizations to submit an EPA open dump survey forum detailing potential regional air quality contaminants. Ms. Thomas expressed the need for assistance in funding and enforcement.

Ms. Rebecca Zaragoza offered to reach out to Ms. Thomas to assist with developing the programs to help mitigate illegal dumping.

Mr. Todd Heibel expressed that on behalf of San Bernardino Community College, they will be reaching out to Torres Martinez Indian Reservation to extend further support and collaboration.

Agenda Item #7: Update on EJCP Efforts

Ms. Lizarraga provided an update of the programs under EJCP including the Annual Environmental Justice Conference, Environmental Justice Advisory Group (EJAG), Inter Agency Task Force, Clean Air Program for Elementary School Students (CAPES), and ongoing community engagement programs.

Ms. Lizarraga highlighted the successes of the 6^{th} Annual Environmental Justice Conference – A New Era of Environmental Justice -Our Community Survival on October 28, 2020 and thanked all Advisory Council members who participated. She shared the survey results and feedback from conference participants.

Ms. Vallerie Gonzalez inquired if there were any differences noted in the attendance of non-English speakers at this year's Environmental Justice Conference. Ms. Lizarraga responded that the Environmental Justice Conference did see the same number of Spanish speakers as in previous years.

Ms. Debra Mendelsohn introduced herself as the Board Assistant to Governing Board Member Janice Rutherford and was the former Board Assistant to Supervisor Mike Antonovich who help initiate the Clean Air Program for Elementary Schools (CAPES) many years ago. She expressed her gratitude in seeing how the CAPES program is developing as a result from those efforts.

Ms. Paula Torrado asked how the Advisory Council could better coordinate their goals and objectives with the regulatory efforts. What are the steps in supporting and engaging beyond AB 617 including the Air Quality Management Plan? Ms. Lizarraga asked Ms. Torrado if it would be helpful to present an overview of the Air Quality Management Plan at the next meeting. Ms. Torrado agreed emphasizing a review of goals to Environmental Justice Community Members.

• *Action Item:* South Coast AQMD staff to coordinate a presentation on the Air Quality Management Plan overview at their next meeting.

Ms. Theresa Rodriguez expressed her concern over economic barriers across disadvantaged communities of the transition to electric vehicles. Ms. Lizarraga stated that her team will reach out to find the appropriate speaker to present the status of that initiative.

Ms. Rodriguez emphasized the importance of receiving the presentation to better educate the impacted communities on their choices.

Ms. Hart said there are huge incentives for the vehicles and suggested <u>www.ncsa.la</u> as a resource. Ms. Daphne Hsu suggested moving this discussion to the agenda for the next meeting. Ms. Lizarraga agreed to move this to the March 2021 agenda. Ms. Lizarraga also mentioned that there are Advisory Council Members that can connect off-line to discuss further.

• *Action Item:* South Coast AQMD staff to coordinate a presentation or update of South Coast AQMD's *Replace Your Ride Program* at an upcoming meeting.

Ms. Hart shared her thoughts on the Environmental Justice Conference. She hopes that the next virtual Environmental Justice Conference be more interactive.

Agenda Item #8 Member Updates

Ms. Paula Torrado shared that Physicians for Social Responsibility- Los Angeles (PSR-LA) is continuing to work on advocating and mobilizing South Los Angeles to ensure the selection of communities for AB 617. Ms. Torrado also mentioned ongoing research of air toxins sourcing from industries of concern that community members have identified. Lastly, PSR-LA are looking at a partnership with UCLA to do research around zero-emissions and building electrification in South Los Angeles.

Ms. Sienna Thomas reported that the Torres Martinez Reservation is near completion of their second air monitoring station located at Salton Sea Beach. Ms. Thomas praised the huge achievement after several years in the process. This would allow for the Reservation to be able to collect PM 2.5 and PM 10 at that site.

Ms. Lisa Hart shared that the Los Angeles City Council's Energy, Climate Change and Environmental Justice Committee voted to move toward a citywide phase-out of oil drilling sites. She also shared that the City Council voted to begin reducing their investments on fossil fuel companies and agreed to start moving toward divesting employee pensions from fossil fuels.

Mr. Hiebel offered collaboration through San Bernardino Valley Community College to support any initiatives that the Advisory Council Members are working toward including providing GIS data. Mr. Hiebel mentioned that he is still interested in supporting South Coast AQMD's Virtual Bus Tour project.

• *Action Item:* Ms. Lizarraga to follow up with Todd Heibel regarding an informational webinar for college students on South Coast AQMD and Environmental Justice issues.

Environmental Justice Community Partnership Advisory Council 2020 Accomplishments

The mission of the Advisory Council is to ensure that the Environmental Justice Community Partnership (EJCP) programs address the air quality concerns of diverse communities throughout South Coast AQMD's jurisdiction.

The goals of the Advisory Council are to:

- 1. Advise South Coast AQMD on local environmental justice issues affecting the South Coast Air Basin.
- 2. Assist in the development, implementation, and ongoing EJCP program efforts.
- 3. Create, strengthen, and build upon South Coast AQMD's relationships with community stakeholders.
- 4. Identify, develop, and implement ideas to support tribal communities.
- 5. Learn more about the members, their organizations, and efforts in their community.
- 6. Promote and encourage relationships and partnerships among members.
- 7. Increase awareness of relative Environmental Justice legislation and legislative issues.

In 2020, the Advisory Council Members met by convening virtually to continue to receive program updates and discuss environmental justice and air quality issues due to the pandemic.

Key Items Addressed in 2020

Continued EJCP Program Input

South Coast AQMD held quarterly Advisory Council meetings in 2020. Staff provided members with ongoing updates on the EJCP events, workshops, and meetings. Advisory Council members also provided feedback on these initiatives and assisted with outreach.

Advisory Council Members: Community Efforts

At the first meeting of the year, Ms. Vallerie Gonzalez presented an overview of the Solar On Multifamily Affordable Housing (SOMAH) program. Ms. Gonzalez shared the differences between SOMAH and other solar programs targeted for multifamily housing. SOMAH helps provide tenants with greater benefits through solar credits and direct economic benefits to disadvantaged community members by creating access to solar, which lowers pollution. Ms. Gonzalez informed the Advisory Council that SOMAH is

accepting applications and offered the criteria of program eligibility for stakeholders to apply for the program.

At the June Advisory Council meeting, the first meeting after COVID-19 closures, Ms. Hart helped moderate a discussion regarding the impacts of the pandemic on their organizations and communities. Ms. Hart framed the conversation for the group in terms of the disproportionate health and economic impacts on disadvantaged and environmentally impacted communities of color. Advisory Council members spoke of the challenges and opportunities that came from the pandemic to help their communities.

In September, Ms. Italia Garcia provided a brief overview and history of the Center for Community Action and Environmental Justice (CCAEJ) and their work in the Inland Empire to empower community members to advocate for their environment. Ms. Garcia explained CCAEJ members take part in policy advocacy as it relates to the federal, state, and local levels. Ms. Garcia also shared their COVID-19 Emergency Relief Fund and encouraged members to reach out to CCAEJ if they knew of any families or community members that need extra resources during the global pandemic.

At the December Advisory Council meeting, Sienna Thomas, Environmental Technician of Torres Martinez Desert Cahuilla Indians, provided a presentation on illegal dumping on tribal reservation and other tribal lands. She provided the Advisory Council with details of the types of illegal dumping occurring on their land. Ms. Thomas explained the programs and community collaborations that have been created to help deter dumping.

Clean Air Program for Elementary Students (CAPES)

South Coast AQMD adopted Clean Air Program for Elementary Students (CAPES) and the program was restructured to be rolled out virtually to adapt to distance learning. Staff is working on materials to produce videos to share with educators and their students. Advisory Council members are partners in helping South Coast AQMD staff connect with schools in impacted communities and provide meaningful input to improve the program.

Inter-Agency Task Force Meetings

In 2020, South Coast AQMD held quarterly Environmental Justice Inter-Agency Task Force meetings in May, August, and November. The Task Force hosted a staff training, created the "Who to Call Guide" and is available to the public in English and Spanish. The Task Force also made incremental progress on the goals to increase inter-governmental collaboration.

Held Inter-Agency Task Force Staff Training

South Coast AQMD hosted a virtual Inter-Agency Task Force Staff Training. The training brought together various local, state, and federal environmental agency customer service representatives and complaint processing staff. Attendees learned about other agencies' jurisdiction and complaint processes, how to appropriately handle and refer complaints, how to empathize with the community, and to effectively refer and follow up on complaints.

Hosted the 6th Annual Environmental Justice Conference

South Coast AQMD hosted over 700 participants at the 6th Annual Environmental Justice Conference, *A New Era in Environmental Justice – Our Community Survival*. This half-day virtual conference highlighted the current environmental justice and health challenges facing communities within South Coast AQMD jurisdiction and beyond. COVID-19 has brought to light the importance of continuing efforts to improve air quality and social justice efforts.

Presentation on the South Coast AQMD App

Staff presented on South Coast AQMD's smart phone application that allows users to search for Air Quality Index in their neighborhoods and explained the additional features. Members were encouraged to download and share the app with others.

South Coast AQMD Complaint Reporting Process and Investigation Process for Auto Body Shops

At the request of EJCP members, staff presented an overview on South Coast AQMD's complaint reporting system, types of complaints received, complaint trends, and the investigation process for Auto Body Shops.

South Coast AQMD 2020 State Legislative Update

Staff presented an overview of the state legislative bills that South Coast AQMD has taken a position on, the state budget, and an update on environmental justice legislation.

South Coast AQMD 2020 Federal Legislative Update

Staff presented an overview of environmental justice legislation that the 116th U.S. Congress considered and the goals for the 117th U.S. Congress term.

Overall Control Approach for Attaining 2015 8-hour Ozone Standard

- Extensive transition to near-zero (NZE) and zero-emissions (ZE) technologies in mobile and stationary sources, where feasible
- Transition to cleanest available technologies if NZE/ZE not feasible
- Regulatory measures; Incentive programs
- Eliminate/minimize reliance on 182(e)(5) measures
- Seek legislative authority where applicable
- Seek new sources of funding for new/existing incentive programs
- Work closely with state and local governments to maximize reductions from residential and commercial buildings
