CALL TO ORDER: Chair Delgado called the meeting to order at 9:03 a.m.

- Opening Comments

Vice Mayor Olmos thanked staff for joining her on April 10, 2025 for a tour of areas of Calabasas affected by debris being transported from the Palisades fire to the Calabasas Landfill. For additional details, please refer to the [Webcast](#) beginning at 6:31.

Executive Officer Wayne Nastri announced that the Public Hearing for PARs 1111 and 1121 is scheduled for the June Board meeting and that a comment letter from the South Coast AQMD Local Government & Small Business Advisory Group regarding PARs 1111 and 1121 was included as part of Agenda Item No. 18 in today's package. Executive Officer Nastri reported on the timeframe for this year's Summer Internship program and the number of interns that were selected. He also reported that air monitoring efforts and data reporting continued for the Eaton and Palisades fires and the results can be viewed on South Coast AQMD's website.

Chair Delgado congratulated Mayor Lock Dawson on her appointment by Governor Newsom to the California Air Resources Board.

PUBLIC COMMENT PERIOD – (Public Comment on Non-Agenda Items, Pursuant to Government Code Section 54954.3)

Patrick Walsh, Apex Logistics International, commented on the mitigation fee for the WAIRE Program; however, he was interrupted and asked to comment during the public comment period for that item, Agenda Item No. 27.

The following individuals spoke in opposition of PARs 1111 and 1121.

- Kevin Barker, SoCalGas, expressed concerns with the cost and limited consumer choice of appliances. He urged the Board to vote against the rules as written, develop a feasibility fuel neutral regulation that imposes lower NOx limits to protect consumer choice, still achieves meaningful emission reductions and get SIP credit.

- George Boutrous, Orange County Business Council, expressed concerns with the cost, impact to the housing market, and jobs. He requested that staff continue to engage with stakeholders and the public to develop cost effective and practical solutions.

Thomas Jelenić, Pacific Merchant Shipping Association, expressed concern that there are still unanswered questions about the Port ISR and the public process for the proposed rule. He urged the Board to direct staff to complete the schedule they laid out for the public process before starting the formal rulemaking process. Councilmember Raman reported that she had no financial interest in Agenda Item No. 11 but is required to identify for the record that she is a Councilmember for the City of Los Angeles, which is involved in this item.

Supervisor Nguyen announced that she was recusing herself from Agenda Item No. 8 because of a financial interest in Zoom Video Inc., which is materially affected by this item.



Supervisor Nguyen expressed concerns that PAR 1171 could be overly prescriptive and its impact on the UV/EB/LED industry. She requested that staff work with that industry to work toward a consensus. Executive Officer Nastri responded that staff would reach out to Ms. Rita Loof of RadTech International to discuss the issues. Supervisor Nguyen and Mayor Pro Tem Rodriguez asked for the record to show that they are in support of the following legislation in Agenda Item No. 19: AB 605 (Muratsuchi) – Lower Emissions Cargo Handling Equipment Pilot program; and SB 712 (Grove) – Smog check: collector motor vehicles: exemption. Agenda Item No. 2

Key comments from the above speakers include:

- Cannot support current proposed amendments to Rule 1171;
- Opposes new additional requirements for reporting, recordkeeping and labeling;
- Seeks exemption for materials associated with UV/EB/LED processes and at essential public water treatment facilities; and
- Concerned about safety issues associated with the use of electrical equipment around highly flammable acetone-based cleaners and water-borne materials.

Agenda Item No. 19

Al Sattler commented on AB 306 (Schultz), a proposed legislation that would impose a moratorium on the adoption or modification of new state and local building standards affecting residential units through 2031. He recommended that staff seek an amendment to the legislation to require that energy efficient measures be included.

(Margee Hills, Dalinef Leon, Uma Armien Funk, and Jennifer Cardenas commented on PARs 1111 and 1121, and/or the Port ISR therefore, their comments were moved to the General Public Comment Period for Non-agenda items portion of the meeting.)

There being no further requests to speak, the public comment period was closed for Agenda Item Nos. 1 through 24.

In response to Mayor ProTem McCallon's inquiry regarding comments on PAR 1171, Dr. Sarah Rees, Deputy Executive Officer/Planning, Rule Development and Implementation, pointed out that staff is working with stakeholders to address their issues and that the focus of the rulemaking is to eliminate toxic components. Mike Krause, Assistant Deputy Executive Officer/Planning, Rule Development and Implementation, commented that staff has been working with the water districts and that the proposed usage limits were established with input from the Los Angeles Department of Water and Power and the Metropolitan Water District. Staff could revisit the usage limit at a future date, if the utilities have some increased usage. For additional details, please refer to the [Webcast](#) beginning at 57:30.

Supervisor Perez requested an update on SB 712, specifically asking what amendments staff is seeking and whether it is better to leave the bill as proposed.

Philip Crabbe, Senior Public Affairs Manager/Legislative, Public Affairs, and Media, explained that SB 712 is in the Appropriations Committee and is moving through the legislative process. Executive Officer Nastri explained that part of the concern was a rolling exemption that would increase the number of cars that would be exempt from smog checks. Supervisor Mitchell commented that she would like to see a distinction between a classic car and an old car that is not considered a classic. For additional details, please refer to the [Webcast](#) beginning at 58:06.

Supervisor Nguyen recommended that staff ask the legislator to better define what cars would be eligible for the exemption and commented that she believes that this will narrow the exemption.

Vice Chair Cacciotti commented that he prosecuted smog check stations for 20 years and that these cars can be serious sources of air pollution. For additional details, please refer to the [Webcast](#) beginning at 1:03:42.

Supervisor Perez asked for clarification on AB 712. Executive Officer Nastri explained that it was his understanding that staff is going back to the author to better define the exemption such as model year and wanted to underscore the importance of the air quality benefits. Supervisor Nguyen inquired about the increase in permitting fees and whether South Coast AQMD fees are comparable to other air districts. Executive Officer Nastri explained that staff did not have this information readily available, but would provide data comparing South Coast AQMD fees to the other large air districts in California at a later date. Curt Coleman, Southern California Air Quality Alliance, commended the reasonable and necessary increase in fees. He reinforced prioritizing actions to reduce the permit backlog, expediting permit evaluations and filling Engineering & Permitting vacancies. He thanked Chair Delgado and the Board for making permit processing a priority and committed to continue working with staff to address issues to remove bottlenecks in the permitting process. 28. Report on South Coast AQMD Vacancies, and Recruitment and Retention Efforts for 2024

John Olvera, Deputy Executive Officer/Administrative & Human Resources, gave the staff presentation on Agenda Item No. 28. For additional details, please refer to the [Webcast](#) beginning at 1:15:19.

The following South Coast AQMD employees addressed the Board on behalf of the SCPEA and Teamsters Local 911 bargaining units: Brian Vlasich, SCPEA and Jennifer Nessler and Keith Brown, Teamsters.

Supervisor Mitchell thanked the representatives from the bargaining units for bringing forward their recommendations and asked Mr. Olvera whether the data collected

from exit interviews have identified a pattern of reasons behind the departure of employees. Mr. Olvera responded that the data reflects varied reasons for employees leaving. For additional details, please refer to the [Webcast](#) beginning at 1:51:40.

Supervisor Perez suggested that staff conduct a market compensation analysis to see how salaries and benefits compare to other agencies. He commented on the importance of finding the right balance between internal and external recruitment and suggested employing a holistic approach that bridges the gap between practical experience and academic knowledge. In response to Mayor Lock Dawson's inquiry about a salary survey and reclassification study, Mr. Olvera responded that it was agreed to in last year's labor negotiations to conduct salary surveys for the Teamsters benchmark classifications and a full compensation study for the SCPEA positions. Both studies are in the final stages and will be finalized this month. For additional details, please refer to the [Webcast](#) beginning at 1:57:03.

The public comment period was opened for Agenda Item No. 28. The following individual addressed the Board.

Bettina Burleigh Sanchez-Castro, a South Coast AQMD employee and SCPEA member, expressed concerns with communication from leadership and how it impacts employee morale and productivity. She commented on how important it is to acknowledge and show appreciation to employees for their hard work and contributions to the agency and urged the Board to direct management to actively work to increase employee engagement and help promote open and honest information sharing. Al Sattler expressed support for South Coast AQMD employees and commented on the swift response and professionalism of staff that he has experienced. For additional details, please refer to the [Webcast](#) beginning at 2:01:45.

There being no further requests to speak, the public comment period for Agenda Item No. 28 was closed.

Supervisor Perez commented on the value of communication in an organization and expressed support for efforts to improve overall communication at the South Coast AQMD. He commented on the importance of creating a safe space where employees feel comfortable sharing their ideas and concerns and suggested exploring ways to improve communication. Vice Chair Cacciotti inquired about the reason for the high vacancy rate in the Technical & Enforcement and Office Clerical & Maintenance bargaining units. For additional details, please refer to the [Webcast](#) beginning at 2:05:05.

Mr. Olvera explained that many of those vacancies resulted from employees being promoted to a higher-level position within the organization. The internal promotions create vacancies at the lower-level positions, resulting in a continual effort to balance the different priorities. Vice Chair Cacciotti commented on the current trend that shows employers moving away from teleworking. He asked Mr. Olvera to comment on the South Coast AQMD survey that shows a high percentage of employees consider telework as the top factor that contributes to them working and staying at the South Coast AQMD. Mr. Olvera commented that the revised telework program was implemented effective April 1, 2025 and nearly all employees have submitted their telework applications. He reported that there has been a good response to the program, but noting that some employees would like to telework more.
