PROPOSAL: Recognize Revenue, Appropriate and Transfer Funds, Issue

Solicitation and Purchase Order for One Vehicle

SYNOPSIS: South Coast AQMD is expected to receive up to \$2,238,000 from

the U.S. Government for the Enhanced Particulate Monitoring Program. This action is to recognize revenue, appropriate and transfer funds between Major Objects in the Monitoring and

Analysis Budget to realign expenditures and issue a solicitation and

purchase order for one vehicle.

COMMITTEE: Administrative, May 9, 2025; Recommended for Approval

RECOMMENDED ACTIONS:

- 1. Recognize revenue in the General Fund up to \$480,000 and appropriate up to \$480,000 from the Undesignated (Unassigned) fund balance upon receipt (\$1,758,000 for Salaries and Employee Benefits is already included in the budget) into the Monitoring and Analysis (MAD) FY 2024-25 and/or FY 2025-26 Budgets, Services & Supplies and Capital Outlays Major Object, as set forth in Attachment 1;
- 2. Transfer up to \$350,000 between MAD's FY 2024-25 and/or FY 2025-26 Budgets, Salaries and Employee Benefits Major Object (Org. 46), and Services & Supplies Major Object (Org. 47), Temporary Agency Services account as needed to realign expenditures for the Enhanced Particulate Monitoring Program; and
- 3. Authorize the Procurement Manager, in accordance with South Coast AQMD's Procurement Policy and Procedure, to issue a purchase order based on a solicitation or cooperative agreement for one vehicle, not to exceed \$45,000 as listed in Table 1.

Background

South Coast AQMD has provided enhanced particulate monitoring support as part of a national monitoring program since 2003. South Coast AQMD is expected to receive up to \$2,238,000 in grant funds from the U.S. Government for the operation and maintenance of the Enhanced Particulate Monitoring Program for FY 2024-25 and/or FY 2025-26.

The Enhanced Particulate Monitoring Program allocates dedicated vehicles as part of the annual budget to support sample collection and other operations and maintenance activities. These vehicles undergo regular replacement due to high mileage and prohibitive repair costs.

Proposal

This action is to recognize revenue upon receipt, and appropriate up to \$480,000 (\$1,758,000 for Salaries and Employee Benefits is already included in the budget) into the Monitoring and Analysis FY 2024-25 and/or FY 2025-26 budgets, as set forth in Attachment 1. Staff proposes purchasing one vehicle in an amount not to exceed \$45,000 to continue to fulfill operational needs (see Table 1). The vehicle will be selected through a solicitation process or cooperative purchasing agreement. Low emission vehicles are available from vendors through cooperative purchasing under the State of California, Department of General Services, Procurement Division, and Alternative Fueled Vehicles Contract 1-22-23-23A through I.

South Coast AQMD relies on temporary staffing to sustain the Enhanced Particulate Monitoring Program. This action is also to approve a transfer of up to \$350,000 from the Salaries and Employee Benefits Major Object (Org. 46) to Services & Supplies Major Object (Org. 47), Temporary Agency Services account as needed to realign expenditures for the program operations.

Resource Impacts

U.S. Government funding will fully support the Enhanced Particulate Monitoring Program.
