# **Background**

This report summarizes the activities of the Legislative, Public Affairs and Media Office for April 2025. The report includes Major Events, Community Events/Public Meetings, Environmental Justice (EJ) Update, Speakers Bureau/Visitor Services, Communications Center, Public Information Center, Small Business Assistance, Media Relations, and Outreach to Community Groups and Governments.

# **Major Events Hosted and Sponsored**

Each year, staff engage in hosting and sponsoring several major events throughout South Coast AQMD's four-county jurisdiction to promote, educate, and provide important information to the public regarding reducing air pollution, protecting public health, and improving air quality while minimizing economic impacts.

### 2025 OC Children's Water Education Festival

On April 23 and 24, South Coast AQMD hosted a booth at the OC Children's Water Festival, which had approximately 2,000 students in attendance. Staff conducted a live demonstration on how smog is formed in the Basin as well as educated students on the agency, air quality, and careers.

### **Community Events/Public Meetings**

Staff engaged with residents and stakeholders in different communities to provide information about the agency, incentive programs, and ways individuals can help reduce air pollution through events and meetings sponsored by South Coast AQMD or in partnership with others. - Clean air technologies and their deployment;
- Invitations to or notices of conferences, seminars, workshops, and other public events;
- South Coast AQMD incentive programs;
- Funding/grant opportunities by South Coast AQMD and partner agencies;
- Rule updates;
- Ways to participate in South Coast AQMD's rules and policy development; and
- Assistance in resolving air pollution-related problems.

# Major Media Topics:

- Chiquita Canyon Landfill (CCL): Staff participated in an interview with Bloomberg Businessweek on ongoing enforcement activities at the landfill. Reporter also requested a copy of a video taken by staff at the landfill. KCAL requested information regarding CCL's compliance with previous abatement orders and potential enforcement actions by our agency Responses were provided.
