The September Joint Meeting of the California Air Resources Board and the Assembly Bill 32 Environmental Justice Advisory Committee Meeting and the September Board meeting of the California Air Resources Board were held in Sacramento, California at the California Environmental Protection Agency Headquarters Building. Key items presented are summarized below.

September 11, 2025

DISCUSSION ITEM

The California Air Resources Board (Board) and the Assembly Bill 32 Environmental Justice Advisory Committee (Committee) discussed the Committee's recommendations to the Board on Building Decarbonization, including proposed Zero-Emission Space and Water Heater Standards, and on the Cap-and-Trade Program. CARB staff also presented an overview of the Committee's ongoing efforts.

CONSENT ITEMS

25-6-1: Public Meeting to Consider Proposed Research Contract with the University of California, Berkeley, Titled "Laboratory and Community Evaluation of Advanced Portable Air Cleaners and HVAC Filters for Indoor Gas Pollutants"

The Board approved \$600,000 in funding for the research proposal that will evaluate the effectiveness of various air cleaning filtration technologies in removing Volatile Organic Compounds, odor-causing substances and other air pollutants such as Nitrogen Dioxide from indoor air.

25-6-2: Public Meeting to Consider Proposed Research Contract with the University of California, Irvine, Titled "Improving Estimates of CO2 and CH4 Emissions from Southern California Coastal Wetlands and BVOC Emission Estimates from All California Landscapes"

The Board approved \$800,000 in funding for the research proposal to quantify the fluxes of greenhouse gases from southern California coastal wetlands and biogenic volatile organic compounds from California landscapes. The research contract will support CARB's future Natural and Working Lands Carbon Inventory and Scoping Plan updates, broaden wetland types in scenario modeling, and inform the State Implementation Plan.

25-6-3: Public Meeting to Consider Proposed Research Contract with the University of California, Davis, Titled "Accelerated Evaluation of Ambient PM2.5 in Regions Affected by the 2024 NAAQS Update"

The Board approved \$1,000,000 in funding for the research proposal to expand CARB's high resolution PM2.5 measurement efforts using advanced Aerosol Chemical Speciation Monitors (ACSMs) in the non-attainment areas throughout California. The high resolution monitors will help address the U.S. Environmental Protection Agency's new annual PM2.5 National Ambient Air Quality Standards (NAAQS) criteria of 9 $\mu g/m^3$.

25-6-4: Public Meeting to Consider Proposed Research Contract with the University of California, Davis, Titled "Assessing Long-Term Health Effects of Wildfire Smoke Exposure: Insights from an Established Birth Cohort Study"

The Board approved \$700,000 in funding for the research proposal that aims to address knowledge gaps on the long-term health effects of wildfire smoke and the long-term health impacts associated with wildfire-related pollutants including PM2.5 and heavy metals. The research contract will also explore differences by sociodemographic and neighborhood factors to evaluate wildfire-related health disparities.

25-6-5: Public Meeting to Consider Proposed Research Contract with the University of California, Riverside, Titled "Improving Commercial Cooking Emissions Estimates in California"

The Board approved \$750,000 in funding for the research proposal that will update the restaurant activity data to refine PM2.5, nitrogen oxides (NOx), and volatile organic compounds (VOCs) emission estimates. It will also conduct laboratory-controlled studies to update and expand emission factors from various cooking devices for different cooking processes and provide information on source profiles for PM2.5, NOx, and VOCs.

DISCUSSION ITEMS

25-6-6: Public Meeting to Consider Two Proposed New Members for the California Air Resources Board's Research Screening Committee

The Board approved a resolution to appoint two new members of the CARB Research Screening Committee (RSC). As required by State law (Health and Safety Code § 39700), CARB sponsors a research program that is guided by the mission to provide sound and timely scientific results to support CARB's policies and programs. State law also requires that CARB establish an RSC to review proposed and completed research projects. The new RSC members include Dr. Danae Hernandez-Cortes, Arizona State University and Dr. Bradley Thomas, Colorado State University.

25-6-7: Public Meeting to Consider the Proposed Five-Year Strategic Research Plan for 2025-2030

The Board approved the Proposed Five-Year Strategic Research Plan for 2025-2030. In establishing the state's approach to achieving clean air, the Legislature declared that an effective research program is an integral part of the broad-based statewide effort to combat air pollution. In response to this mandate, CARB staff develops a list of research projects every year guided by the research initiatives outlined in the Proposed Five-Year Strategic Research Plan. The proposed research initiatives in the Five-Year Plan will advance CARB's fundamental air quality, climate, health, mobile sources, and sustainable communities research, support new and improved strategies to reduce air pollution and greenhouse gas emissions, and monitor program implementation and effectiveness.

25-6-8: Public Hearing to Consider Proposed Amendments to the Advanced Clean Fleets and Low Carbon Fuel Standard Regulations

The Board approved amendments to the Advanced Clean Fleets (ACF) and the Low Carbon Fuel Standard (LCFS) regulations. These amendments repeal the requirements for Drayage Trucks and High Priority Fleets that are no longer subject to the ACF regulation and delay the 100% zero-emission vehicle (ZEV) purchase requirements for State

and local government fleets to 2030. The ACF amendments fully satisfy the requirements of Assembly Bill 1594 (Garcia, E., Stats. 2023, ch. 585) which give more flexibility to public agency utilities. And 15-day changes extend those flexibilities to all State and local government fleets as well as streamline the exemption process. Lastly, the LCFS amendments increase crediting levels for hydrogen fueling stations to accelerate buildout of higher-capacity ZEV fueling for medium trucks. Staff are drafting 15-days changes and anticipates submission to the Office of Administrative Law in 2026 for approval before 2027 compliance requirements begin.
