#### **ACTION/DISCUSSION ITEMS:**

##### **1. Update on South Coast AQMD Sponsored State Legislation**

Carlos Gonzalez, Assistant Deputy Executive Officer, Legislative, Public Affairs and Media provided an update on South Coast AQMD sponsored state legislation.

AB 1338 (Solache): Fenceline Monitoring at Metal Shredding Facilities. This is a 2-year bill that would allow South Coast AQMD to recover costs relating to fenceline monitoring requirements for metal shredding facilities. Staff is continuing to work with Assemblymember Mia Bonta and legislative staff on potential bill amendments.

AB 907 (Chen): Fair Compensation for Air District Representatives on the CARB Board. This bill would allow air district representatives on the CARB Board to

receive similar compensation to other CARB Board Members. AB 907 passed the Assembly but was converted into a 2-year bill due to budget constraints. Staff will continue to work with the author's office and legislative staff to move this bill forward during this legislative session.

Chair Cacciotti inquired about compensation for air district representatives on the CARB Board in comparison to other CARB Board Members. Lisa Tanaka, Deputy Executive Officer, Legislative, Public Affairs and Media, responded that the local air district representatives who serve on the CARB Board are not compensated as opposed to the other Board Members who receive annual compensation.

### *HOUSE/SENATE*

#### *Congress*

The House and Senate are out of session for the holiday break. The House will reconvene on January 6, 2026 and the Senate will reconvene on January 5, 2026. Prior to breaking for recess, Congress passed the National Defense Authorization Act, an annual authorization bill for defense spending and policy direction for the Department of Defense (DOD) and other federal agencies. Among the energy and environment provisions in the bill were 1) a direction to DOD to accelerate the remediation of PFAS in its facilities and 2) a ban on DOD procuring solar components from companies linked in China.

On December 18<sup>th</sup> the House passed the Standardizing Permitting and Expediting Economic Development (SPEED) Act, a comprehensive permitting reform package that includes several changes to the National Environmental Policy Act. 11 Democrats voted in favor of the legislation despite language added in the amendment process that would allow the Administration to continue to block renewable energy permits. Staff level bipartisan discussions on permitting reform are ongoing, but the recent move by the Department of the Interior to pause all offshore wind construction caused key Democratic negotiators to publicly announce that they will not continue such negotiations until the offshore wind pause is lifted.

## EPA

On November 20, the Environmental Protection Agency (EPA) and Army Corps of Engineers released a proposed rule updating the definition of “Waters of the United States,” or waters federally covered under the Clean Water Act. This update is designed to align with the U.S. Supreme Court’s 2023 decision in *Sackett v. Environmental Protection Agency* and narrows and clarifies federal jurisdiction. The comment period on the proposed rule closes on January 5, 2025.

On December 11, EPA launched the Clean Air Act (CAA) Resources for Data Centers webpage to provide data center developers and local stakeholders with a central hub for CAA related resources to provide regulatory information and technical tools to assist with modeling and air quality permitting for AI-related infrastructure.

Cassidy and Associates support in December:

- Provided guidance for the FY 26 appropriations process;
- Updated AQMD staff on surface transportation reauthorization;
- Continued conversations on permitting reform efforts in Congress and the Administration;
- Worked with SCAQMD staff to strategize on future DC outreach and plan for DC visits; and
- Participated in weekly strategy sessions with SCAQMD staff.

## ***IMPORTANT LEGISLATIVE DATES***

**January 30, 2026:** Deadline to fund the federal government. In November, Congress passed a Continuing Resolution (CR) providing Congress more time to complete its consideration and pass FY 2026 funding.

**Congress:** In December, the Senate wrapped up its year-end business by confirming 97 presidential nominees en bloc and passing the annual National Defense Authorization Act, but failed to act on an enhanced ACA tax credit extension and a package of 5 additional appropriations bills leaving these critical items to January and dangerously close to the current government shutdown date of January 30, 2026. Confirmations of note include: Jeffrey Hall to be an Assistant Administrator for the Office of Enforcement and Compliance Assurance of the Environmental Protection Agency, and Douglas Troutman to be Assistant Administrator for Toxic Substances of the Environmental Protection Agency.

In the House of Representatives, the SPEED Act passed which is a permitting reform bill designed to accelerate federal environmental reviews for energy and infrastructure projects. While bipartisan, the bill passed 221-196 and it's unclear if it will secure 60 votes for final passage in the Senate. In addition, a discharge petition forcing a vote on a 3 year extension of the enhanced ACA tax credits received enough signatures setting up a floor vote in January.

## **Environmental Protection Agency**

**EPA Unveils Clean Air Act Resource to Support Data Center Permitting:** In December, EPA launched a centralized Clean Air Act (CAA) resource [page](#) for data center/AI facility developers and local communities, intended to clarify permitting considerations and available CAA-related tools. The EPA says these resources are designed to provide state and private sector partners with regulatory information, guidance and technical tools that can assist with modeling, air quality permitting, and regulatory interpretations relevant for data centers and AI facility development. EPA staff will also be available to consult with permit reviewing authorities.

## **Department of Transportation**

**DOT Unveils “Freedom Means Affordable Cars” Proposal to Reset Fuel Economy Standards:** In December, USDOT announced a [proposed rulemaking](#) that will reset

NHTSA's CAFE standards, framing it as a deregulatory action and projecting reduced vehicle costs and changes in fleet turnover that can affect emissions trajectories. The new proposal would apply to passenger cars and light trucks for model years 2022-2031. Comments are due on January 20, 2026.

**DOT Unveils First-Ever National Advanced Air Mobility Strategy:** In December, USDOT announced a national Advanced Air Mobility [strategy](#) intended to guide deployment of new aviation/air mobility operations; long-term relevance for local air quality, noise, and community exposure as new flight operations scale. This strategy is for advanced air mobility (i.e. electric/novel aircraft operations), which could have downstream implications for aviation emissions, noise, and local air quality planning as deployment accelerates. This strategy was created as an output of the Advanced Air Mobility Coordination and Leadership Act that was signed into law in 2022 and the President's Executive Order on Unleashing American Drone Dominance from June.

**FRA to Enforce English Language Proficiency:** In December, the FRA Administrator announced that the FRA will be cracking down on cross-border train operators who lack basic English language proficiency to make rail operations safer in the US. This fall, FRA inspectors discovered instances with Union Pacific Railroad and Canadian Pacific Kansas City Limited inbound crews having difficulty interpreting safety requirement and track bulletins.

## **Department of Energy**

**DOE Rescinds National Definition of “Zero Emissions” Buildings:** In December, the DOE [announced](#) it is removing support for a 2024 national “zero emissions building” definition and will no longer provide technical assistance related to this definition. DOE says that this action lowers the costs and removes guidelines that never had the force or effect of law.

**DOE Releases National Petroleum Council Recommendations on Permitting Reform:** In December, DOE released key studies and [recommendations](#) from the National Petroleum Council (NPC) focused on removing regulator barriers to modernize America's oil and natural gas infrastructure permitting. Two studies were released, one on gas-electric coordination and the other on oil and natural gas infrastructure permitting. The NPC is a federal advisory committee composed of leaders from the oil and natural gas industries, academia and other stakeholders.

Congress adjourned for the year without extending the Affordable Care Act (ACA) tax credits, thus ensuring that subsidies will expire. This sets up health care costs as a key political fight in 2026. On a near-party-line vote, the House did approve a health care bill before adjourning, but it did not address the health insurance subsidies.

Speaker Johnson is walking a difficult tightrope with his caucus on this issue: after a week-long intra-party debate, four members of his party crossed the aisle to join 214 Democrats in signing a discharge petition that will force a vote on a three-year extension of the ACA credits. This is the same procedural mechanism used to force a vote on the Justice Department's Epstein files: when a majority of House members (218 when the chamber is at full strength) join a discharge petition, that bill is discharged from committee and brought directly to the floor. The ACA credits vote will be scheduled in January.

House Republican leadership also publicly discussed whether to schedule another reconciliation bill in the new year, potentially giving the party a legislative path focused on health care costs. Speaker Johnson has suggested this as an option.

Some progress was made on FY26 appropriations bills, but the deadline is looming without any imminent votes. As a reminder, three full-year bills — Legislative Branch, Agriculture, Legislative Branch and MilCon-VA — were included in the November CR, which leaves nine more to be finalized. The Senate spent the early part of December negotiating the parameters of a five-bill “minibus” (that is, a smaller combination than a complete “omnibus”) that would merge together appropriations bills covering Interior-EPA, Labor-HHS-Education, Defense, Transportation-HUD, and Commerce-Justice-Science. These discussions stalled following the White House’s announcement that it would defund the National Center for Atmospheric Research, located in Boulder, Colorado; Colorado’s two Senators announced that they would hold up debate on the minibus until the NCAR funding was reinstated.

The current CR expires on January 30, and the House and Senate will return to Washington the week of January 5. However, the Senate is currently scheduled to be in recess the week of January 19, and the House has planned a recess the week of January 26, leaving only two scheduled session weeks to come to a resolution on FY26 bills.

#### ❖ **AB 907 (Chen).** Assemblymember Philip Chen introduced AB 906, sponsored legislation for South Coast AQMD dealing with the inequity of pay for air district board members appointed to serve on the CA Air Resources Board.

The bill has been referred to Senate Environmental Quality Committee. The bill has been made into a 2-year bill.

## **Legislative Session Update**

On December 23, Senate President Pro Tempore Monique Limón announced the Senate Democratic Leadership team and committee membership assignments for the 2026 legislative year. These announcements outline several significant leadership changes that will shape the Senate's legislative and budget agenda.

Under the announcement, changes to the Budget and Budget Subcommittees and the Natural Resources and Water Committee take effect immediately. All remaining committee assignments will become effective on February 1, following the passage of the two-year bill deadline.

Several key leadership changes are particularly noteworthy:

- Sabrina Cervantes (Riverside) has been appointed Chair of the Senate Appropriations Committee.
- John Laird (Santa Cruz) will serve as Chair of the Senate Budget Committee, overseeing the development and negotiation of the state's annual spending plan.
- Eloise Gómez Reyes (Colton) has been named Chair of Budget Subcommittee No. 2 on Resources, Environmental Protection, and Energy, a key panel with jurisdiction over funding for the AB 617 program.
- Josh Becker (Menlo Park) will assume the role of Chair of the Senate Natural Resources and Water Committee.
- Senator Caroline Menjivar (San Fernando Valley) will become the Democratic Caucus Chair.

The Legislature is scheduled to reconvene in Sacramento on January 5. During the first week of session, Governor Gavin Newsom will deliver the State of the State address on January 8

at 10:30 a.m. This will mark the first time the Governor has appeared before a joint session of Legislature since 2020, and it will also be his final State of the State. Given that he is required to formally present his proposed budget to the Legislature by January 10, we expect there will be several references to what his budget priorities will be during the speech.

### **Budget Update**

According to the Department of Finance's monthly budget report, preliminary General Fund agency cash receipts in November were \$454 million, or 3.9 percent, above the Budget Act forecast. This variance was primarily driven by personal income tax receipts, which exceeded projections by \$543 million due to higher withholding and lower-than-anticipated refunds. Partially offsetting this overperformance, sales and use tax receipts came in \$169 million below forecast, while corporation tax receipts were \$59 million under projections. Cumulatively since April, preliminary General Fund agency cash receipts total \$9.1 billion, or 6.5 percent, above projections, including an overage of \$2.7 billion attributable to cash collected during the 2024–25 fiscal year. However, as we reported last month, the Legislative Analysts Office (LAO) still expects a significant budget deficit even with these reports of a surplus.

The month of December is typically quiet in Sacramento, and this year was no different. Legislators are back in their Districts focusing on constituent work while their capitol staff are starting to prepare their legislative package for 2026. The Legislature will reconvene on Monday, January 5, 2026, and they will have until the end of January to move all 2-year bills out of their house of origin. Additionally, all new bills must be submitted to Legislative Counsel for drafting by January 23, 2026, with all new bills being introduced by February 20, 2026.

The following will provide you with updates of interest to the District:

## **\$1.1B IN ZERO-EMISSION TRANSIT**

On December 8, the California Transportation Commission (CTC) approved \$1.1 billion in transportation investments to advance zero-emission buses, charging infrastructure, and clean transportation projects, while also addressing critical needs to repair aging bridges, improve highway safety, and enhance local mobility.

Consistent with the Governor's Build More, Faster – For All infrastructure agenda, the funding is intended to strengthen climate resilience and improve safety and accessibility across California communities. Notable allocations include \$53 million for 12 clean-energy locomotives to replace diesel engines on Southern California's Metrolink system and \$13 million to restore fire-damaged portions of State Route 38 in San Bernardino County.

Of the total approved this month, \$463 million is funded through SB 1, the Road Repair and Accountability Act of 2017, with an additional \$190 million from the federal Infrastructure Investment and Jobs Act (IIJA). Since its enactment, SB 1 has provided roughly \$5 billion annually for transportation improvements statewide, accelerating project delivery for both state and local agencies. Looking ahead, California is expected to receive nearly \$42 billion in federal infrastructure funding over five years, supporting

broad upgrades to roads, bridges, rail, public transit, airports, ports, and the statewide electric-vehicle charging network.

### **MAKING BIG POLLUTERS PAY**

On December 10, Governor Newsom announced more than \$865 million in new California Climate Investments, funded entirely by major greenhouse-gas emitters, to support affordable housing, transit expansion, and climate-resilience efforts statewide.

The funding will deliver 39 affordable housing projects across 21 communities, enable the construction of thousands of new homes, and finance significant sustainable transportation improvements. Notably, \$185.6 million is allocated to Los Angeles County to help rebuild critical infrastructure following this year's devastating wildfires. These investments are financed through the state's Cap-and-Invest program and the funding directly advances the Governor's vision of building a California for All by addressing housing needs while confronting climate change.

The California Strategic Growth Council (SGC) surpassed a historic \$5 billion investment milestone with its largest single funding announcement to date. Nearly \$1 billion was awarded to projects that link affordable housing with transit access, protect agricultural lands, and support community-led climate solutions that deliver environmental, health, and economic benefits. The awards include \$835.3 million through the Affordable Housing and Sustainable Communities Program for 21 housing and green transportation projects, \$29.5 million through the Transformative Climate Communities Program using anticipated Proposition 4 funds to fully support four projects, and \$2.1 million through the Sustainable Agricultural Lands Conservation Program for capacity-building efforts across 25 counties.
