This letter is to inform you that we have been unable to communicate with **Meter Device ID:5912141** associated with **Resource ID: LGHHP_6_ICEGEN** as of 3/25/2025.

This issue may currently be preventing us from submitting accurate meter data on your behalf used within the settlement process.

Thank you for your email. I am not sure I understand your answers.

I don't understand why would we apply Missing Data Procedures? We are not subject to this Rule under the current situation, as communication via the approved coper line modem is broken. We are not likely to be subject to this Rule as we will ensure we attempt to transmit our data within 48 hours of a restored modem line.

I also don't know what we would file a variance over. Would you please elaborate on what relief we would be seeking? In her most recent testimony, Ms. Manwaring pointed out that a variance would only be appropriate if we were in violation of a Rule or were imminently in violation of a Rule. This situation is not the case, as I described above.

We have been working with our CEMS provider to ensure our data is stored in an AQMD approved database. We have been assured that that is the case as AQMD has approved CEMTEK to provide such products, which we license.

Reference your comment "work with your CEMS vendors to explore methods to collect stored CEMS data and transmit the data", that is the direct request of my previous email. I apologize if I was not clear. Working with CEMTEK, we know that we can transmit our data via the internet as a database. However, we do not believe such methods are defined in the Rules. That is the purpose of my asking you, as a representative of AQMD, what an alternative method of transmitting our data would be acceptable.

Now that our flanges have been removed, we are subject to generation at any time and for any duration. How do we work together in the face of AT&T's systemic issue to get AQMD the data it required to ensure ICEGEN is meeting its permit obligations?
