With regard to Petitioner's Carson Terminal (Facility ID No. 800372), located at 20945 S. Wilmington Avenue, Petitioner Equilon Enterprises LLC dba Shell Oil Products US ("Petitioner" or "Shell") and Respondent South Coast Air Quality Management District ("South Coast AQMD", collectively "the Parties") hereby request that in Case No. 4982-137, the hearing on Shell's Petition for Short Variance, scheduled for a public hearing on March 18, 2025 at 9:30 am, be placed on that date's consent calendar. Pursuant to Hearing Board Rule 4(a), the Parties stipulate to the following:


1. The Parties agree to have the matter placed on the consent calendar for March 18, 2025 at 9:30 a.m.
2. The Parties agree that the declaration of Christopher Sherman (filed concurrently herewith) and Petitioner's Petition for a Short Variance shall be admitted into evidence.
3. The Parties have agreed on the [Proposed] Findings and Decision and Order in support of Shell's February 26, 2025 Petition for Short Variance (filed concurrently

herewith).

4. Based on all of the evidence in this case, the South Coast AQMD does not oppose the granting of the petition.
5. Operations under the variance are not expected to result in a violation of Health and Safety Code Section 41700 or South Coast AQMD Rule 402.
6. The Parties may execute and deliver this Stipulation by transmitting an authorized signature by fax or .pdf document. Copies of this Stipulation signed and delivered by means of faxed signatures or signatures in a .pdf document shall have the same effect as copies executed and delivered with original signatures.


