All speakers will be limited to three (3) minutes, unless directed by the Chair, based on the number of the members of the public who wish to provide testimony or comments. (Government Code Section 54954.3)

Board Member Comments

Any member of the Hearing Board may make a brief announcement or report on his or her own activities, provide a reference to the Hearing Board regarding factual information, request South Coast AQMD staff to report back at a subsequent meeting concerning any matter, or may take action to direct the Clerk of the Board to place a matter of business on a future agenda. (Government Code Section 54954.2)
