21 I, Krystal Stangeland, declare:

22 1. I am employed by Southern California Edison Company (SCE). I am a Senior Project
23 Manager for Catalina Operations & Planning within SCE's Generation organizational unit. I have
24 had this role since 2023. I oversee the Pebbly Beach Generating Station (PBGS) Repower Project
25 from a program management perspective. I have worked on the PBGS Repower Project since
26 2023.

1 2. In 2007, I earned a bachelor's degree in business administration from California State
2 University Long Beach. In 2013, I earned a master's degree in business administration from the
3 University of La Verne. I have been with SCE since 2011. My current responsibilities at SCE
4 include portfolio management and strategic initiatives for Catalina Island's electric grid. Before
5 joining SCE, I worked at Raytheon Company starting in 2007, where I managed Department of
6 Defense contracts.

8 3. SCE has complied with the requirements listed in paragraph 1 on pages 13-14 of the
9 Hearing Board's order dated June 11, 2025. Specifically:

10 a. Condition 1(a): SCE hired a company to search the secondary market to identify an
11 appropriate substitute for the U.S. EPA-certified Tier 4 Final engine listed in the
12 Permit to Construct (Cummins Model No. QSK60-G17). The company located a
13 never-used Cummins U.S. EPA-certified Tier 2 Final unit from a third-party owner
14 (see bullet b(ii) below).

16 b. Condition 1(b): SCE conducted a formal Request for Proposals from 9/12/25 to
17 10/17/25. SCE received three proposals:

18 i. Purchase a new Cummins Tier 2-certified unit (from Cummins) intended
19 for emergency use and add aftermarket controls to bring emissions into
20 compliance with SCAQMD Rules 1135 and 1470;

21 ii. Purchase a secondhand (but never used) Tier 2-certified Cummins unit
22 manufactured in 2019 from a third-party owner and add aftermarket
23 controls to bring emissions into compliance with SCAQMD Rules 1135 and
24 1470; and

iii. Purchase new Tier-2 certified non-Cummins unit intended for emergency use from a different manufacturer and add aftermarket controls to bring emissions into compliance with SCAQMD Rules 1135 and 1470.

c. Condition 1(c): SCE provided written biweekly updates to Chris Perri and Mary Reichert, in addition to periodic meetings with staff.¹

d. Condition 1(d): SCE has identified grounds on which U.S. EPA can grant an exemption pursuant to 40 CFR Part 1068, Subpart C allowing Cummins to sell to SCE a new Tier 2 diesel generator for a non-emergency application (baseload generation at PBGS). If Option (b)(i) above is selected, SCE will seek Cummins' approval to send a joint letter requesting an exemption to U.S. EPA once the federal government has resumed operations.

4. SCE is completing its evaluation of the three proposals and anticipates finalizing a decision by 11/14/25. SCE will enter into negotiations with the preferred vendor to work toward a purchase order. SCE will notify SCAQMD staff on 11/14/25 which option was selected and will begin preparing a revised application for a Permit to Construct.

5. Operation under the proposed order is not expected to result in a violation of Health and Safety Code Section 41700.
