SHORE TERMINALS LLC (FID 117851) CASE NO. 6281-1 PROPOSED SHORT VARIANCE CONDITIONS

- 1. Petitioner shall inform South Coast AQMD compliance personnel by calling 1-800-CUT-SMOG and via email (Attention: Air Quality Inspector Morgan Kossak at mkossak@aqmd.gov) to report a Variance Notification at least four (4) hours prior to the start of the removal of product from Tank No. 8019.
- 2. Petitioner shall inform the South Coast AQMD compliance personnel by calling 1-800-CUT-SMOG and via email (Attention: Air Quality Inspector Morgan Kossak at mkossak@aqmd.gov) within one (1) hour of receiving any complaint(s) from the public.
- 3. Petitioner shall monitor Tank No. 8019, calculate breathing loss emissions, loading emissions, and provide the calculations to the South Coast AQMD upon request.
- 4. During the variance period, Petitioner shall conduct daily optical gas imaging (OGI) inspections following requirements of Rule 463(f)(3)(D) and (d)(3)(D). Petitioner shall provide Air Quality Inspector Morgan Kossak with repair records if any within seven (7) working days of the end of the variance period.
- 5. During the variance period, Petitioner shall mitigate odor by utilizing a portable carbon adsorber(s) connected to Tank no. 8019 vent(s). Petitioner shall only use the portable vapor control system (carbon adsorber) with Permit to Operate R-G5754, or an equivalent emissions control system approved in writing by the Executive Officer.
- 6. During barge loading from Tank No. 8019, Petitioner shall control displaced VOC emissions by utilizing a portable thermal oxidizer equipped with a flame arrestor. Petitioner shall only use a portable thermal oxidizer system with a Permit to Operate G27420, or an equivalent emission control systems approved in writing by the Executive Officer. The thermal oxidizer shall achieve a minimum of 95% destruction efficiency.
- 7. Petitioner shall not operate the carbon adsorber(s) and thermal oxidizer in a manner inconsistent with the various location Permits to Operate specified in Condition 5 and 6 for such equipment. All conditions set forth in these various location Permits to Operate shall be followed during the variance period.
- 8. Petitioner shall conduct marine tank vessel loading activities in accordance with the applicable requirements of South Coast AQMD Rule 1142.

- 9. After the removal of product is complete from Tank No. 8019, petitioner shall degas the tank in accordance with the applicable requirements of South Coast AQMD Rule 1149 and 203.
- 10. The petitioner shall notify the Clerk of the Hearing Board (clerkofboard@aqmd.gov) in writing, Air Quality Inspector Morgan Kossak by email (mkossak@aqmd.gov), and by calling 1-800-CUT-SMOG to report a Variance Notification within two (2) hours of achieving final compliance after the work is complete, Tank No. 8019 and all affected devices are back in compliance with their permits.
- 11. Petitioner shall pay all applicable fees to the Clerk of the Hearing Board or the variance shall be invalidated pursuant to Rule 303(k), except for excess emissions fees if applicable, which shall be paid within fifteen (15) days of notification in writing that the fees are due, unless otherwise ordered by the Hearing Board.
