NOTICE IS HEREBY GIVEN that on the **23rd** day of **JUNE, 2026** at 9:30 a.m. the Hearing Board of the South Coast Air Quality Management District (South Coast AQMD) will hold a public hearing in the above entitled matter to determine whether a variance shall be granted from **Rules 203, 2004 and 3002** of the South Coast AQMD Rules and Regulations for three internal combustion engines and associated selective catalytic reduction units. The nature and extent of estimated excess emissions, if any, are to be determined at the hearing. The address of the facility or location involved in the hearing is **8141 Gulana Avenue, Playa Del Rey, CA 90293**.

The hearing will be conducted through a hybrid format, both in person at the South Coast AQMD, 21865 Copley Drive, Diamond Bar, CA 91765, Hearing Board Room and virtually via videoconference and by telephone. Members of the public will have the opportunity to provide public comments or testimony either in person or virtually. 
