NOTICE IS HEREBY GIVEN that on the **23rd** day of **JULY, 2026** at 9:30 a.m. the Hearing Board of the South Coast Air Quality Management District (South Coast AQMD) will hold a public hearing in the above entitled matter to determine whether a variance shall be granted from **Rules 203, 218.1, 2004, 2012, and 3002** of the South Coast AQMD Rules and Regulations for a simple cycle gas turbine. The nature and extent of estimated excess emissions, if any, are to be determined at the hearing. The hearing will be conducted through a hybrid format, both in person at the South Coast AQMD, 21865 Copley Drive, Diamond Bar, CA 91765, Hearing Board Room and virtually via videoconference and by telephone.
