A facility or site inspection may be required as part of the Laboratory Approval. The cost for this is \$146.90/hr up to \$430.60 additional.

Inspections/visits may be conducted concurrently for more than one method.

Audit sample analysis may also be required, and the costs are \$195.83/hr up to \$574.10 additional (per analysis).

*Method 100.1 system audits are mandatory for approval (may also be required subsequently for renewal). The cost is \$195.83/hr up to \$574.10 additional (per analyzer).
