<u>Mitigated Negative Declaration (MND) for the Proposed</u> <u>Riverside Highland Water Company Well Development Project</u>

South Coast Air Quality Management District (SCAQMD) staff appreciates the opportunity to comment on the above-mentioned document. The following comments are meant as guidance for the Lead Agency and should be incorporated into the Final MND.

SCAQMD Staff's Summary of Project Description

The Lead Agency proposes to construct 2,700 linear feet of pipeline of 12 inches in diameter on 1.5 acres (Proposed Project). The Proposed Project is located at 800 East Washington Street on the southeast corner of RV Center Drive and East Washington Street in the City of Colton. Construction of the Proposed Project is expected to last approximately 140 days, with a 40-day casing and well drilling period¹.

SCAQMD Permits

Upon a review of the MND and the CalEEMod output files, SCAQMD staff found that, during the casing and well drilling phase of construction, a 221-horsepower (hp) bore/drill rig would be used². It is important to note that generally, operation of portable engines and portable equipment units of 50 hp or greater that emit particulate matter require a permit from SCAQMD or registration with the Portable Equipment Registration Program (PERP) through the California Air Resources Board (CARB)³. The Lead Agency should consult with SCAQMD's Engineering and Permitting staff to determine if operation of the 221-hp bore/drill rig will require a SCAQMD permit or if it will need to be registered under the PERP through CARB⁴. If a permit from SCAOMD is required, SCAOMD should be identified as a Responsible Agency for the Proposed Project in the Final MND. Any assumptions used in the Air Quality Analysis in the Final MND will be used as the basis for permit conditions and limits for the Proposed Project.
