Air Shed Grant Programs



- Scope of Air Shed Grant Began with:
 - Vehicle Maintenance Aqueous Brake Cleaners
 - Auto Refinishing Laser Spray Guides
 - Commercial Green Cleaners
 - Boiler Efficiency Upgrades & Replacements
 - Architectural Coatings
 - Electric Lawn Mowers
 - Commercial Leaf Blowers

Programs Added or Expanded to Air Shed Grant



- New Programs
 - Commercial Electric Lawn Mowers
 - Weatherization of Homes near
 Freeways and Intermodal Facilities
 - Air Filtration for Schools
- Expanded Program
 - Wood Burning Fireplace/Stove
 Voucher Program

Commercial Electric Lawn Mowers



- Available to non-profit or government agencies
- Implementation pilot study
 - Users to provide information on usage and fuel savings
 - Cost & emission benefits
 will be determined
- No cost to users
 - Value of mowers rangesfrom \$3000 to \$20,000





Weatherization of Homes Near Freeways and Intermodal Facilities



- Goals of weatherization program:
 - Reduce residential exposure to DPM
 - Reduce energy usage
- Weatherization measures
 - Insulation
 - Weather-stripping
 - Duct repair
 - High efficiency furnace filter
- Currently working on RFP for contractor(s)
- RFP to AQMD Board in September 2014

Air Filtration in Schools



- Install air filtration in schools near:
 - Freeways, major transportation corridors, and/or intermodal facilities
- Reduce school children exposure to toxics and criteria pollutants
- Program includes
 - Installation of high performance filters
 - Data collection & testing
 - Training of school staff on maintenance & operation
 - 5-year filter supply

Low Emission Wood Burning Fireplace/Stove Voucher Program



- Program was formerly applicable to conversion to gas logs
- New incentives for:
 - Fireplace inserts
 - Wood stoves
 - Alcohol-fueled devices
- Incentive amounts depend on:
 - Availability of gas service
 - Wood is used as primary heat source

Auto Expo in Boyle Heights



- Hosted Auto Expo at L.A. Trade Tech in August 2013
- Expo included:
 - Demonstration of alternative-fueled vehicles
 - Training on high-efficiency spray painting
 - Education on lower-polluting VOC products
- Provided local auto body and repair shops with 20 lasers for spray guns and 6 aqueous brake cleaners: \$14,100



Rule 1420.1 – Large Lead-Acid Battery Recyclers



Community Well Being

- Amended Rule 1420.1 on January 10 and March 7, 2014
 - Established emission limits for lead, arsenic and toxics organics
 - Requirements to fund a continuous multimetals monitoring demonstration program
 - Curtailment provisions
 - Investigation provisions for unplanned shutdowns




Legacy LA – Ramona Gardens 2020



Partnership

- SCAQMD first met with Legacy LA in 2013
- Non-profit focused on youth development
- Youth working on "Ramona Gardens 2020: Road Map for Healthier Community"
 - Healthy Food
 - Environmental Justice
 - Access to Resourcesand Safe Walkable Streets



Legacy LA – Vision for 2020 Environmental Justice

- Youth representatives presented proposals and solutions to Environmental Justice in their neighborhood
 - Air filtration for Murchinson
 Elementary and Santa Teresita
 Parochial Schools
 - Weatherization for homes and units near freeways



Legacy LA – Vision for 2020 Environmental Justice

- SCAQMD staff initiated process for evaluate
 Murchison Elementary School for air filtration
- Air filtration has been installed at Santa Teresita Parochial school through MELA
- SCAQMD staff developing an RFP for weatherization of homes near freeways

- Site visit on October 9, 2012
- Met with Jim Parros
 - Senior VP/Logistics
- Purpose of visit
 - Explain CCP
 - Convey community concerns
 - Discuss possible measures


 99¢ Only Stores Warehouse may be willing to consider

99 Cents Only Truck Route

Facility has designated truck routes

- Indiana to Olympic to Freeways
- Designated truck route only for 99 Cents Only trucks not for vendor trucks



99 Cents Only Warehouse (Cont.)

 Replaced 24 older diesel trucks with cleaner diesel trucks meeting 2007* emission standards

(Source: Prop. 1B Funding)

Replaced 40 older diesel trucks with 40 CNG trucks

- Trucks leased from Ryder
- American Recovery and Reinvestment Act (ARRA) funding
- No information on vendor trucks (i.e. Non-99 Cent Only Trucks)



*Equipped with diesel particulate filters (DPF) for particulate control

99 Cents Only Warehouse (Cont.)

- CNG Refueling Station
 - AQMD provided consulting services on fueling station design
 - AQMD did not provide funding for CNG fueling station
 - No public access
 - Fueling station only benefits one facility



Heritage Crematory

Identified as a potential source of smoke and odors during Boyle Heights pre-tour by Father John Moretta and Rafael Yanez



Heritage Crematory (cont.)

- Facility operates four crematory furnaces
 - No restriction on operating hours or schedule (24/7)
 - All furnaces required to comply with 60 ppm Rule 1147 NOx limit
 - Two furnaces require burner replacement
 - Applications filed June 2012 to replace burners
 - Permits to Construct issued August 2012
 - Source tests conducted October 2012 demonstrate compliance
 - Recent inspections confirm facility compliance with applicable air quality regulatory requirements

AQMD Staff Approach to Identify Unpermitted Facilities

AQMD staff drove Union Pacific and Pico in May 2012

and October 2012

Many businesses were unmarked

 Visually identified facilities that may be conducting operations requiring an AQMD permit

Removed facilities

Already in AQMD permit database

Facilities with recent inspection that showed no permitted equipment



Identifying Unpermitted Facilities (cont.)

- Identified 29 potentially unpermitted facilities
- AQMD staff made first contact
 - "No-fault" inspections using Small Business Assistance Unit
 - Provided facility information regarding regulatory compliance, if needed

 29 facilities


Most facilities did not require SCAQMD permits

Facilities Investigated along Pico and Union Pacific


Permitted facilities in blue




Rendering Plant Odors

- Four rendering facilities near Boyle Heights
 - Baker Commodities
 - Darling International
 - Clougherty Packing/Farmer John
 - West Coast Rendering/D & D Services
- ~350 odor complaints in 10 years (2002 2011)
 - Most from addresses in Boyle Heights
 - Not all complaints verified by inspector

Rendering Facilities

- Baker Commodities
 - Used cooking oil from restaurants
 - Waste from meat and poultry processing plants, supermarkets
- Darling International
 - Rendering
 - Collection and storage of used cooking oil





Rendering Facilities (cont.)

- Clougherty Packing/ Farmer John
 - Rendering of hogs
- West Coast Rendering/D & D Services
 - Rendering of restaurant grease, zoo animals, marine life, shelter animal carcasses





Proposed Rule 415 – Odors from Rendering Facilities

- Scope of Proposed Rule
 - Rendering of animal parts & carcasses
 - Rendering/processing of inedible kitchen grease
- Goal: reduce odors
 - implement most effective technologies and best management practices to control odors
- Four animal rendering facilities in Vernon
- One Vernon facility not as modern as the others

Proposed Rule 415 – Key Issues

- What are the most effective technologies?
- What are best management practices?
- Cost of odor control equipment?
- Conditions under which an Odor Management Plan would be required?
 - Example: continuing odor issues resulting in Notices of Violation
- Contact signage directing public to contact AQMD for odors?
