<b>1. Facility Name</b> <p>For identification purposes, please enter the name of the entity responsible for the submittal of the registration, typically the land owner/operator. The information in this section of the application form will be used for all future correspondence, including information about subsequent registrations. In the event that the registration form is prepared and submitted by a party other than the land owner/operator, it is important that the South Coast AQMD be notified of any changes to this information.</p>
