Program Overview

- The South Coast AQMD GO ZERO pilot incentive program offers rebates for zero-Nox emission space and water heating appliances installed on or after June 13, 2025.

General Requirements

- ✓ Must be located within South Coast AQMD's jurisdiction.
- ✓ Must be an owner or property manager of a residential building with 5+ dwelling units.
- ✓ All eligible equipment must be Energy Star certified.
- ✓ Multiple space heating/cooling units servicing one dwelling unit are counted as one heat pump for rebate purposes.
- ✓ The total rebate for a project with multiple heat pumps will be capped at \$300,000 and is calculated at the complex/campus level. See next page for appliance rebate amounts.

Rebate Process Overview

- 1 Reservations (optional):** You may be eligible to place a reservation if funds are available AND your project has not yet been installed. Submitting a rebate reservation does not guarantee you will receive a rebate. You are required to provide proof of incremental progress at least every 30 days to maintain your reservation.
- 2 Rebate Application:** Once your project(s) have been completed, complete and submit the required documentation with your application.
- 3 Review:** Willdan will review your documents and application; a post inspection may be required. You will be notified if additional information is needed, and will receive email notifications as your application progresses through the review and approval process.
- 4 Payment:** If your application is approved, Willdan will issue your rebate payment via check or electronic funds transfer to the payee designated on your rebate application.
