

South Coast AQMD Issues Smoke Advisory Due to Canyon Fire

Valid until Sunday 11:00 AM



Current conditions

- The Canyon Fire has burned 5,370 acres along the Ventura LA County border near Castaic Lake and is 25% contained as of 2:30 PM on August 8, 2025.

- Smoke has been impacting the area along the I-5 corridor near Castaic Lake, with Air Quality Index (AQI) levels briefly reaching the **Unhealthy** category for fine particle pollution overnight from Thursday night into Friday morning.

- The smoke impacts in Santa Clarita were less, with the AQI level only reaching the **Moderate** category for fine particle pollution overnight.

Forecasted Smoke and Air Quality Impacts

- Smoke is expected to impact the area around the I-5 corridor near Castaic Lake during the overnight hours Friday into Saturday with much less smoke during the day.
- If the fire continues through Saturday, smoke is expected to return overnight Saturday into Sunday.
- Lesser smoke impacts are expected in Santa Clarita.

South Coast AQMD will issue an update if additional information becomes available.

If you are in an area impacted by smoke:

- Limit your exposure by remaining indoors with windows and doors closed or seeking alternate shelter.
- Avoid vigorous physical activity.
- Run your air conditioning and/or an air purifier. If possible, do not use swamp coolers or whole house fans that bring in outside air.

- Avoid burning wood in your fireplace or firepit and minimize sources of indoor air pollution such as candles, incense, pan-frying, and grilling.
- If you must be outside, a properly fit N95 or P100 respirator may provide some protection.
