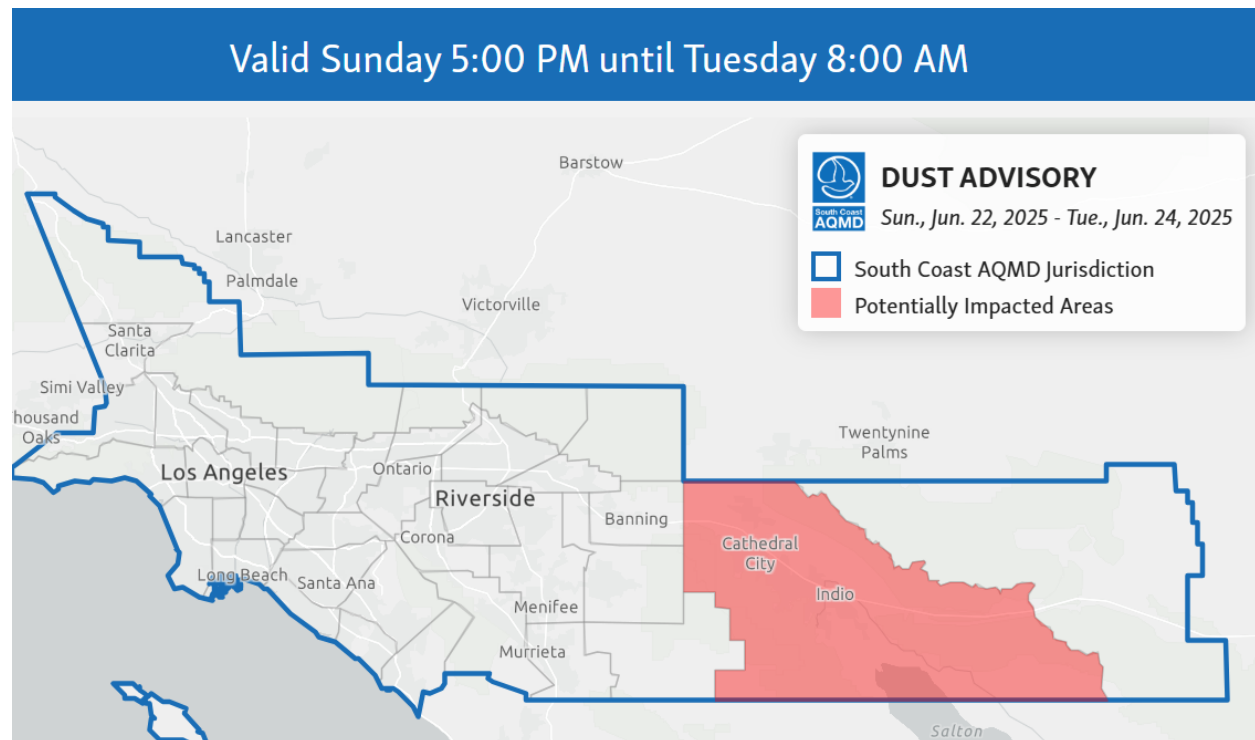

## South Coast AQMD Issues Windblown Dust Advisory for Coachella Valley

*Valid until Tuesday 8:00 AM*



### Current Conditions

- South Coast AQMD is issuing a windblown dust advisory for the Coachella Valley through Tuesday morning.
- Gusty winds have led to elevated levels of windblown dust and particle pollution (PM10) from Friday evening through Sunday morning.

- Air Quality Index (AQI) in the Coachella Valley ranged from **Moderate** to **Hazardous** during this period, with the highest AQI in Northern Cathedral City.

#### Forecasted Air Quality Impacts

- Winds from the west with gusts up to 51 mph are predicted in the northwestern Coachella Valley below Banning Pass at times through Tuesday morning.
- Blowing dust may result in **Hazardous** AQI categories in the Coachella Valley at times from Sunday afternoon through Tuesday morning, with the highest AQI expected in the northwestern part of the valley.
- Air quality can vary by hour and location depending on wind conditions.

#### Detailed Forecast

5 PM Sunday through 8 AM Monday	AQI is predicted to range from <b>Moderate</b> to <b>Unhealthy</b> or higher at times, with the highest AQI in northwestern Coachella Valley. Wind gusts and PM10 levels are predicted to peak around 9 PM Sunday.
Monday daytime	As winds decrease during the day on Monday, AQI due to PM10 will be in the <b>Good</b> to <b>Moderate</b> categories between 8 AM to 4 PM.
Monday afternoon through Tuesday 8AM	Winds are predicted to increase starting 4 PM Monday. AQI due to PM10 will be in the <b>Moderate</b> to <b>Hazardous</b> categories, with the highest AQI in northwestern Coachella Valley.

*South Coast AQMD will issue an update if additional information becomes available.*

#### If you are in an area impacted by windblown dust or ash:

- Limit your exposure by remaining indoors with windows and doors closed or seeking alternate shelter.
- Avoid vigorous physical activity.
- Run your air conditioning and/or an air purifier. If possible, do **not** use swamp coolers or whole house fans that bring in outside air.
- Help minimize dust pollution by stabilizing loose soils and slowing down if driving on dirt roads.
