Re: Data Year 2025 Annual Emissions Reporting and California Air Resources Board Criteria and Toxic Reporting Regulation

Dear Facility Owner/Operator:

South Coast Air Quality Management District (South Coast AQMD) requires specific facilities to report their emissions annually and pay any applicable fees based on the amount of air contaminants emitted under the Annual Emissions Reporting (AER) Program pursuant to South Coast AQMD Rule 301 (e).

Annual emissions reporting is required for any facility that:

- exceeds annual emission thresholds as specified in Rule 301;
- is subject to the CARB Criteria and Toxics Regulation (CTR) reporting as specified in California Code of Regulations Section 93400 et seq.;
- is subject to the Air Toxics "Hot Spots" Act (AB 2588 Program);
- is subject to Rule 317.1 (please contact Rule317.1@aqmd.gov for questions, including status of applicability determination or exclusion plan); or
- is notified otherwise by South Coast AQMD.

In 2020, CARB amended CTR expanding reporting requirements to additional facilities. These Additional Applicability facilities are determined by permitted processes and activity levels specified in Table A-3 of the CTR. Note that the Additional Applicability facilities subject to Phase 1 and Phase 2 CTR reporting that have already reported their 2022 or 2024 emissions, respectively, are not required to report 2025 emissions. Phase 3 facilities – which include, but are not limited to, facilities with natural gas combustion equipment – must report 2025 emissions. A list of all facilities identified as being subject to reporting 2025 emissions will be posted to the AER Webpage. This list will exclude Additional Applicability facilities that reported in 2022 and 2024 and that have no other reporting obligations.

Your facility has been identified as being subject to the AER Program due to one or more of the above criteria and is required to report emissions from operations within your facility for Data Year 2025 (January 1, 2025, through December 31, 2025). On or after January 1, 2026, please use the Facility ID and unique PIN Code provided above to access your facility's preloaded permit profiles in the AER Webtool (https://aerreportingtoolpro.aqmd.gov/) and prepare and submit the annual emissions report.

The Data Year 2025 emissions report and applicable fees are due no later than 5:00 p.m. on **May 1, 2026**. If your completed report and applicable fees are not postmarked or received by the South Coast AQMD by this deadline, you may be subject to both enforcement action and late filing/payment surcharges.
